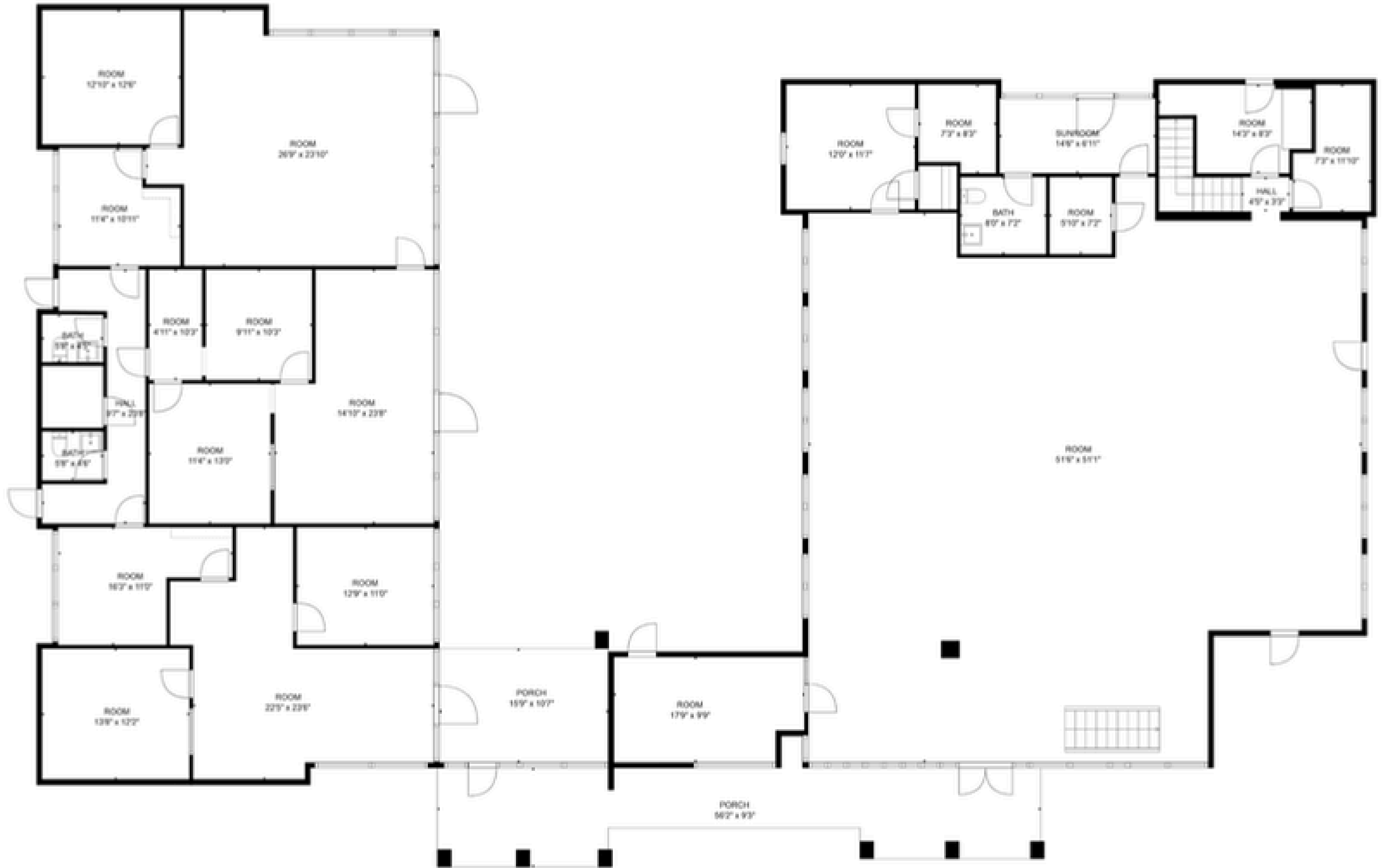

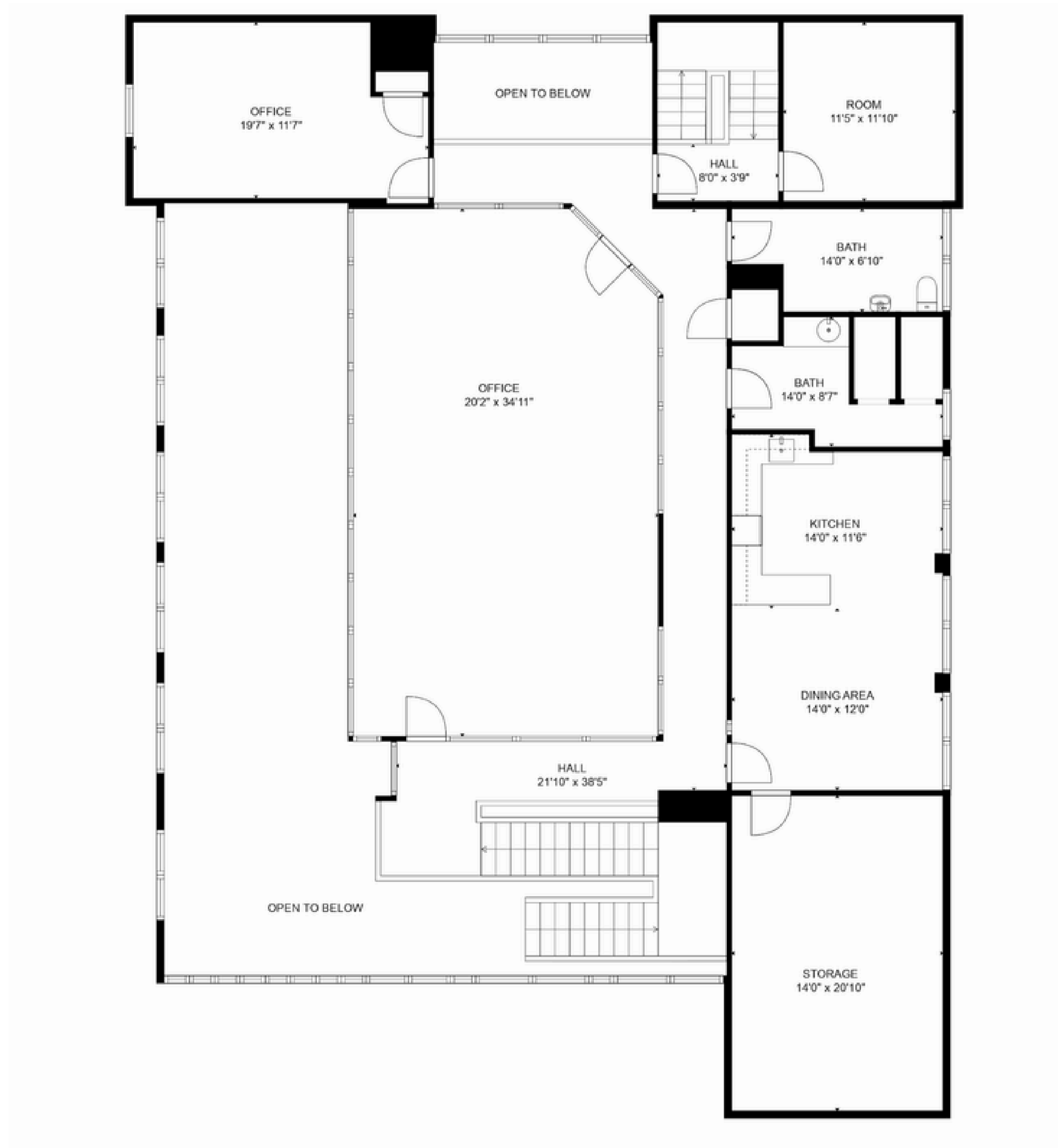
FLOOR PLAN - FIRST FLOOR
