



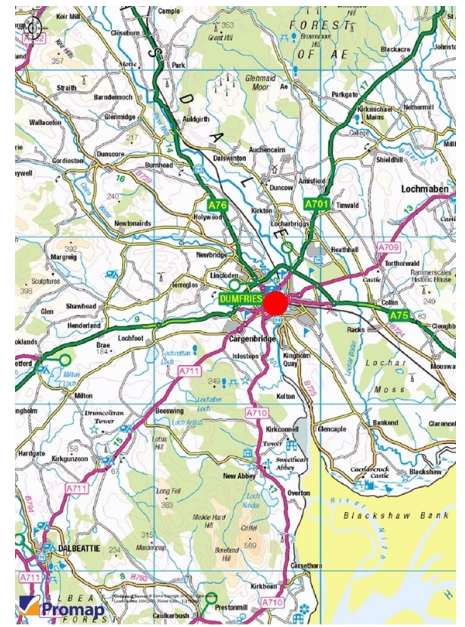
## 89 High Street, Dumfries, DG1 2BN

## LOCATION

The subjects are located on the pedestrianised High Street of Dumfries town centre. The surrounding properties comprise a mix of commercial uses including retailers such as Boots, Coral, Ramsdens, Virgin Money, and Vision Express.
