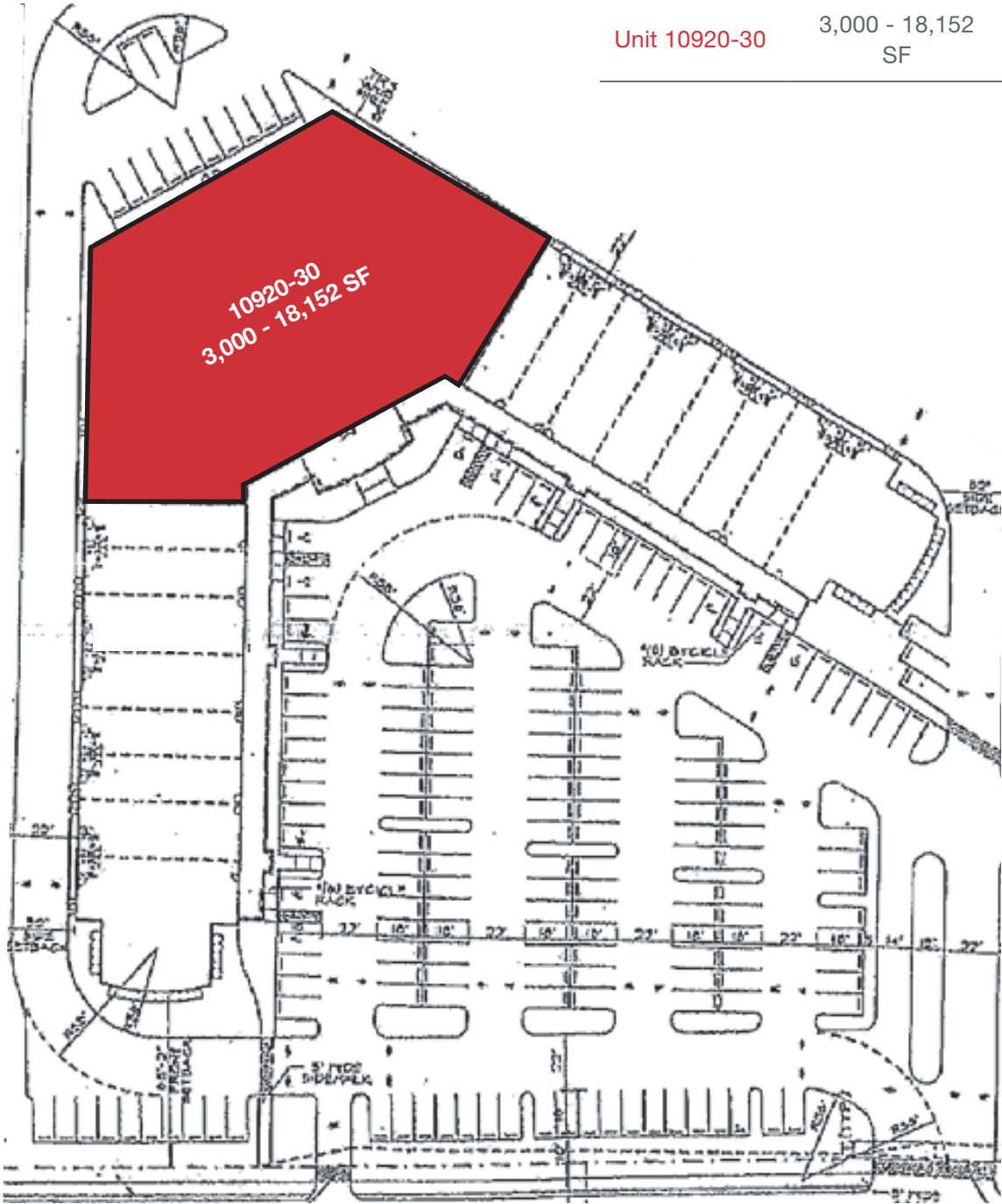

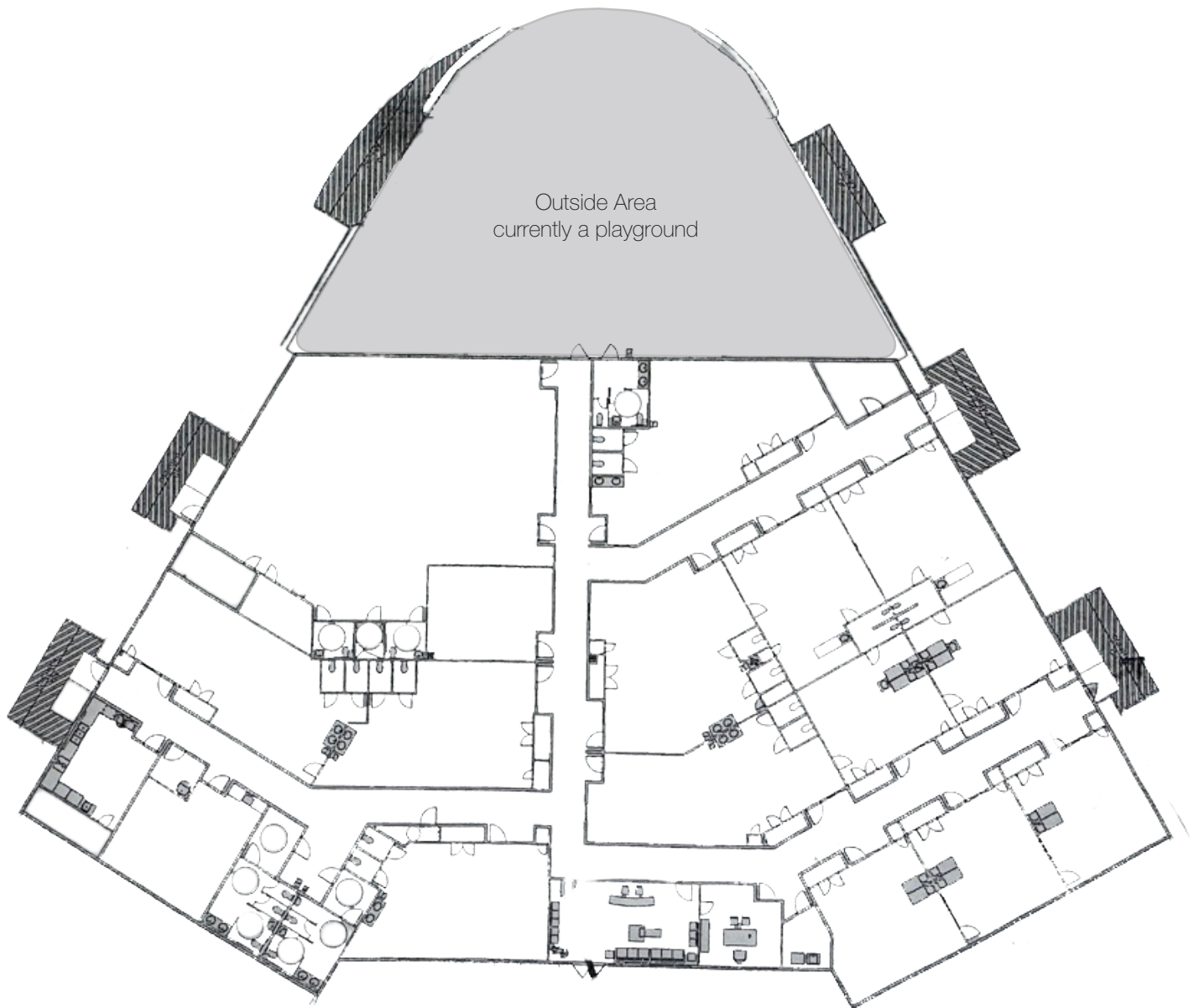


SW 184TH ST

Floor Plan

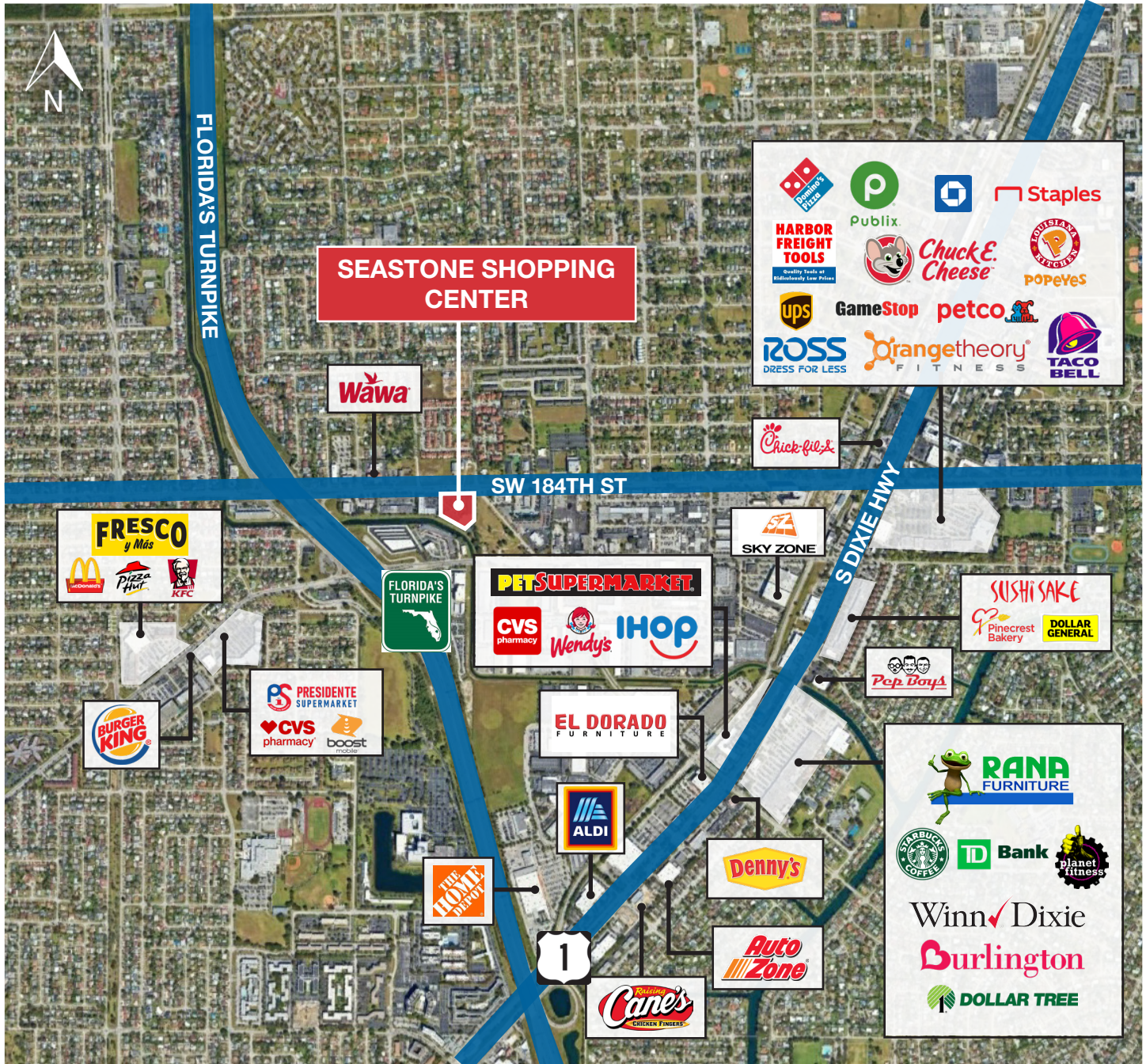
