## Description

Unit 1 Wokingham Commercial Centre is located at the southern end of the terrace and is of steel portal frame construction with double glazed windows to both floors. There are double doors to the front of the Ground Floor which lends itself to Workshop, Storage or Office use. The Open Plan First Floor Office has recently been refurbished to include Kitchen/Break Out area, Meeting Room and Executive Office. There are WC facilities on each floor.

It is possible to take just the one floor.

The unit has 8 allocated parking spaces.

## Location

Wokingham is located between Reading and Bracknell, 5.5 miles south of junction 10 of the M4. The well established estate is in the heart of the commercial district within easy walking of the recently redeveloped town centre which boasts numerous retail, restaurant and leisure options. Approximately one mile from the Bus and Train station, trains run to Reading four times an hour, taking just 10 minutes and the journey to London Paddington is under an hour

## Business Rates

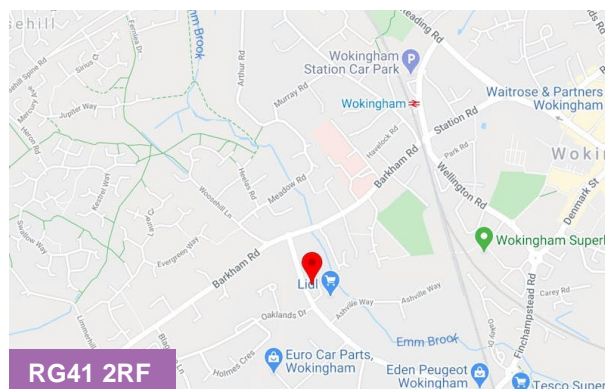
