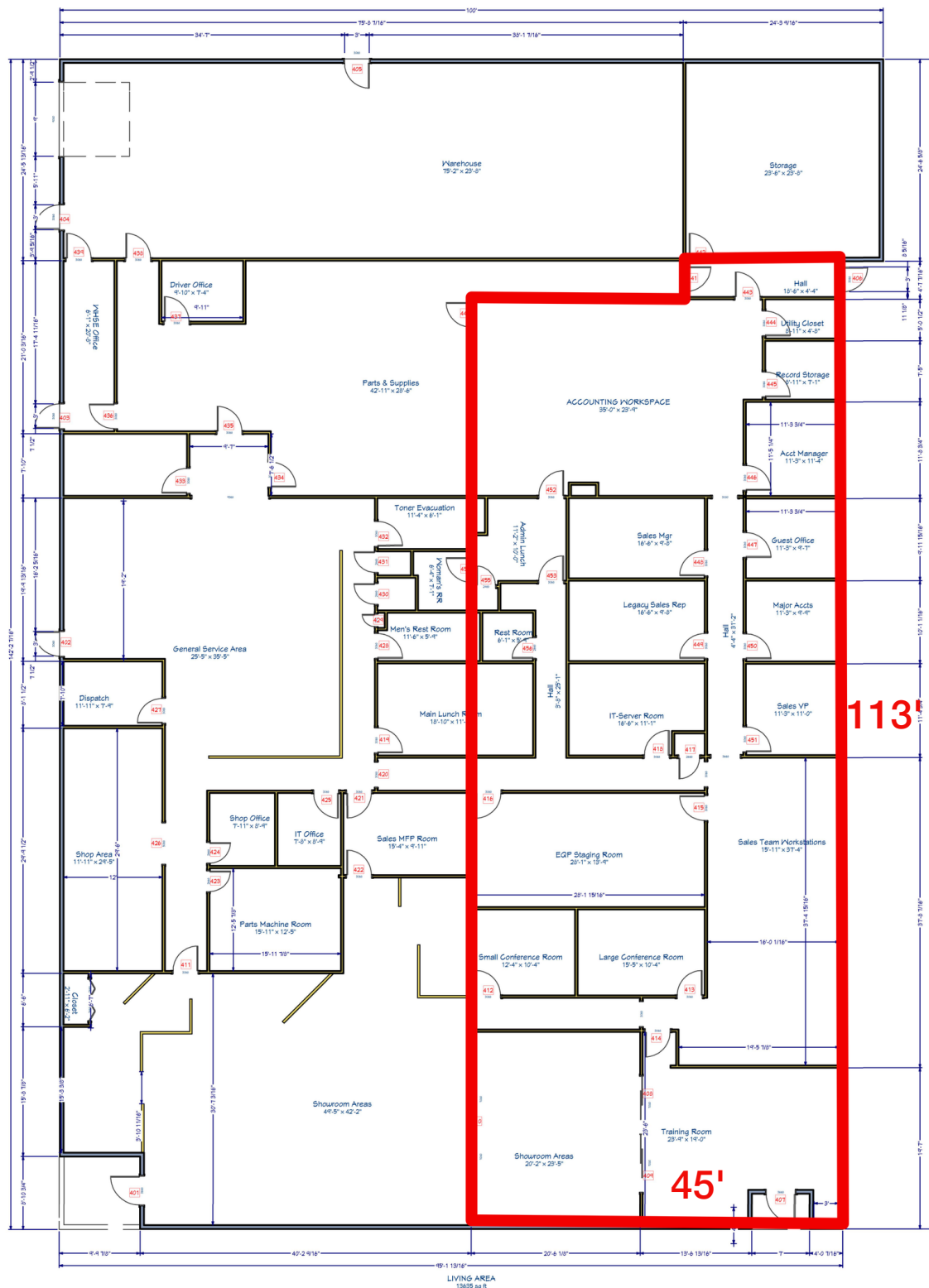

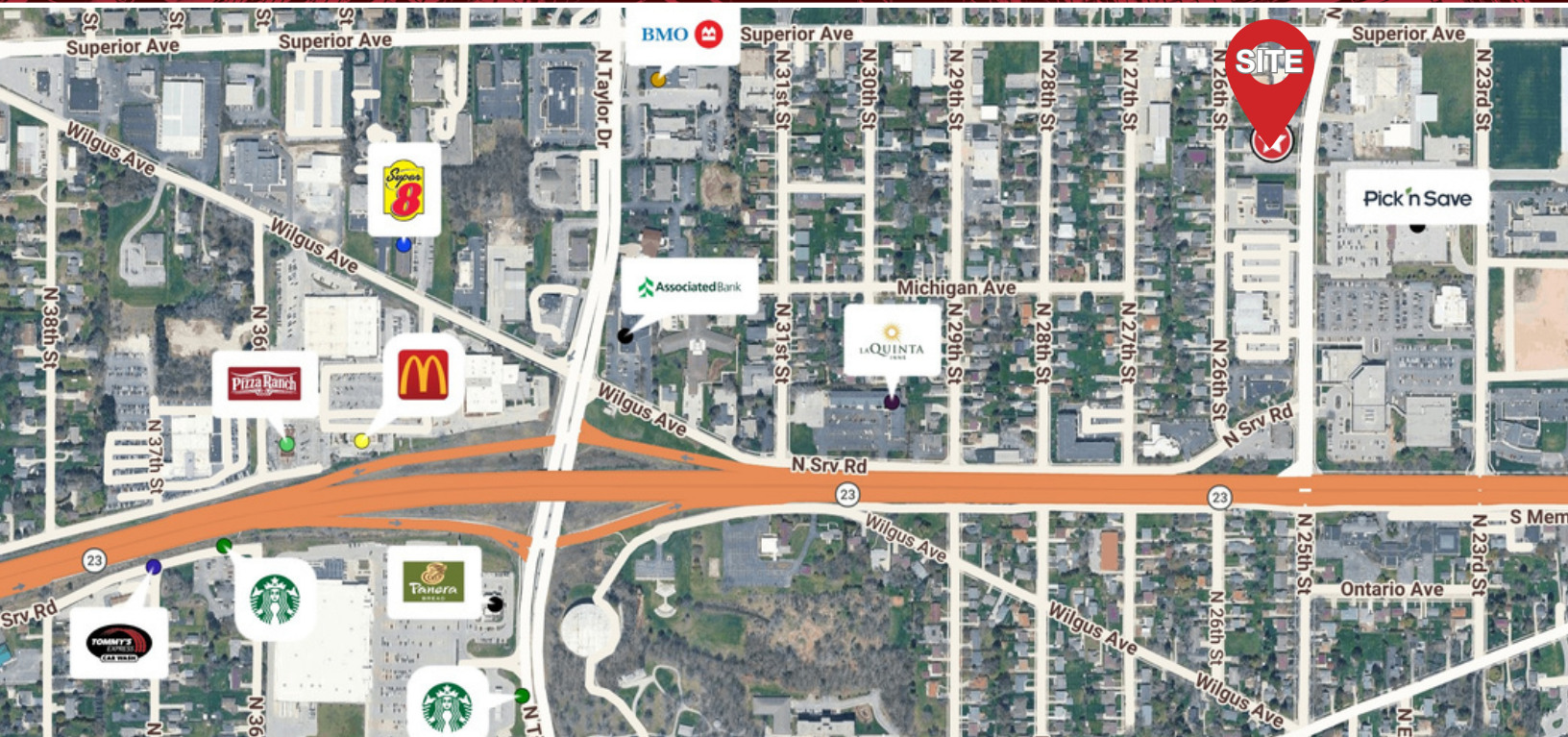

STATE OF WISCONSIN BROKER DISCLOSURE

Confidentiality Notice to Customers
