Offered for sale at \$3,150,000, this 60,000 SF industrial facility features an open production floor, approximately 4,000 SF of two-story premium office infill, six dock-high doors, and a 20’ wide drive-in door. The property is equipped with 480V three-phase power, heavy electrical service, solar panels, radiant heat, ridge ventilation, and a large gravel front yard and parking area.

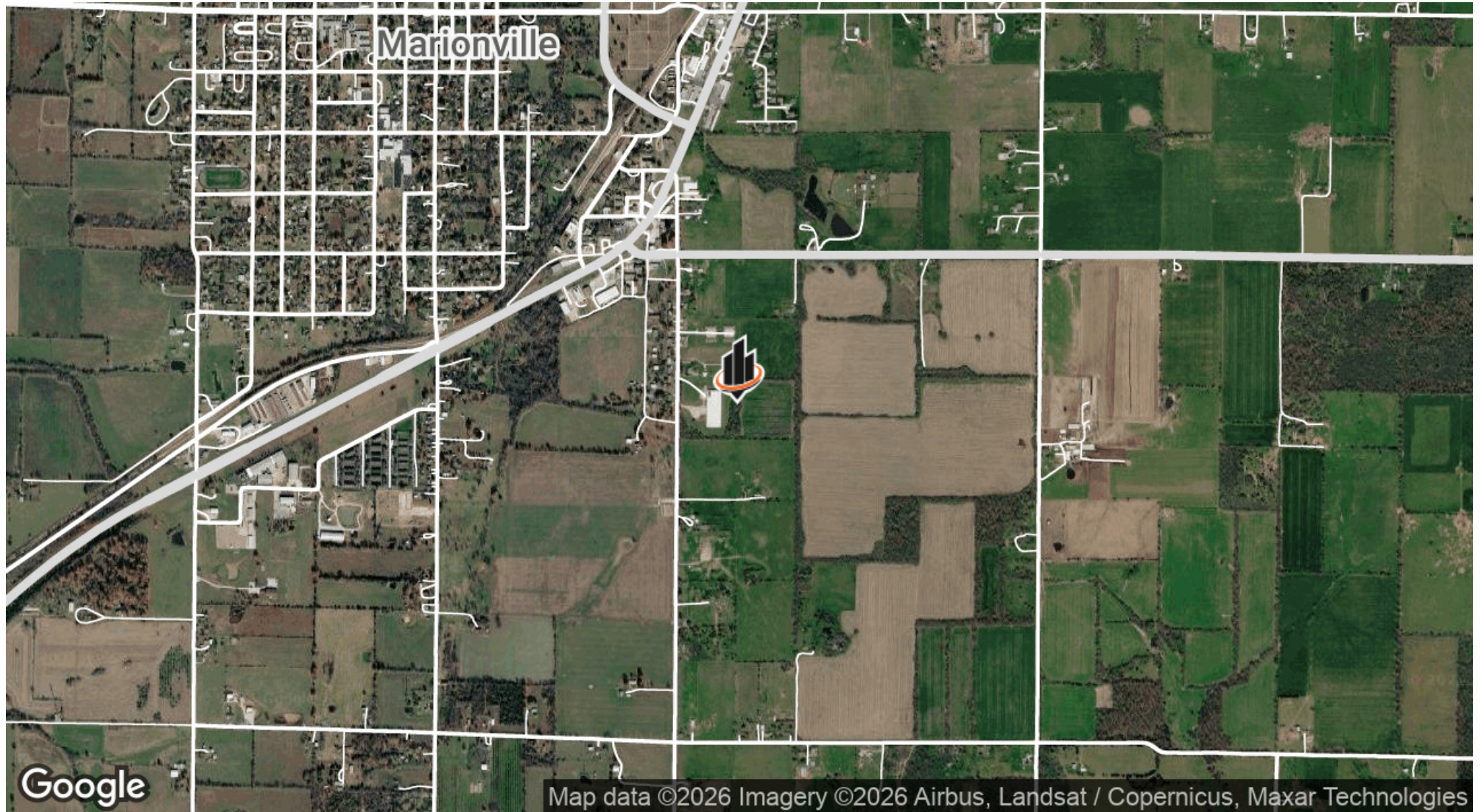
