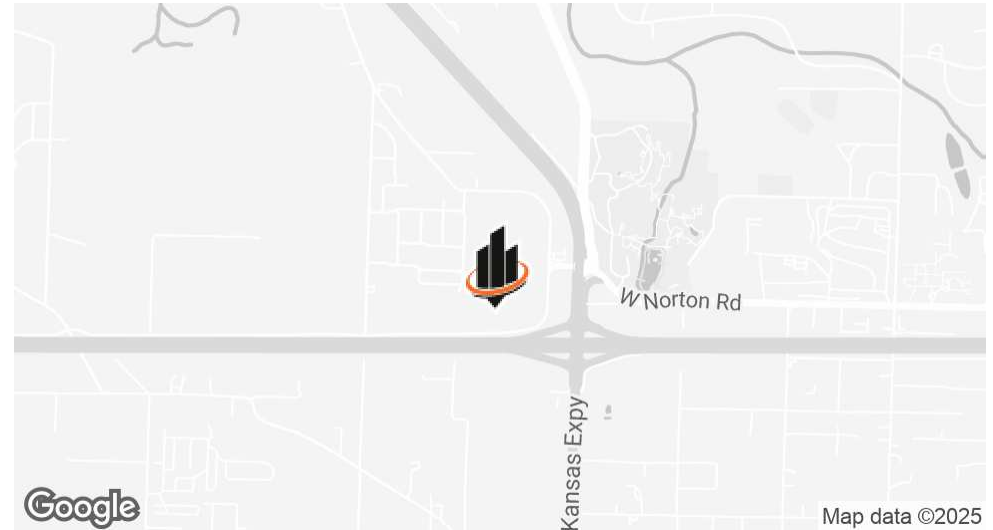

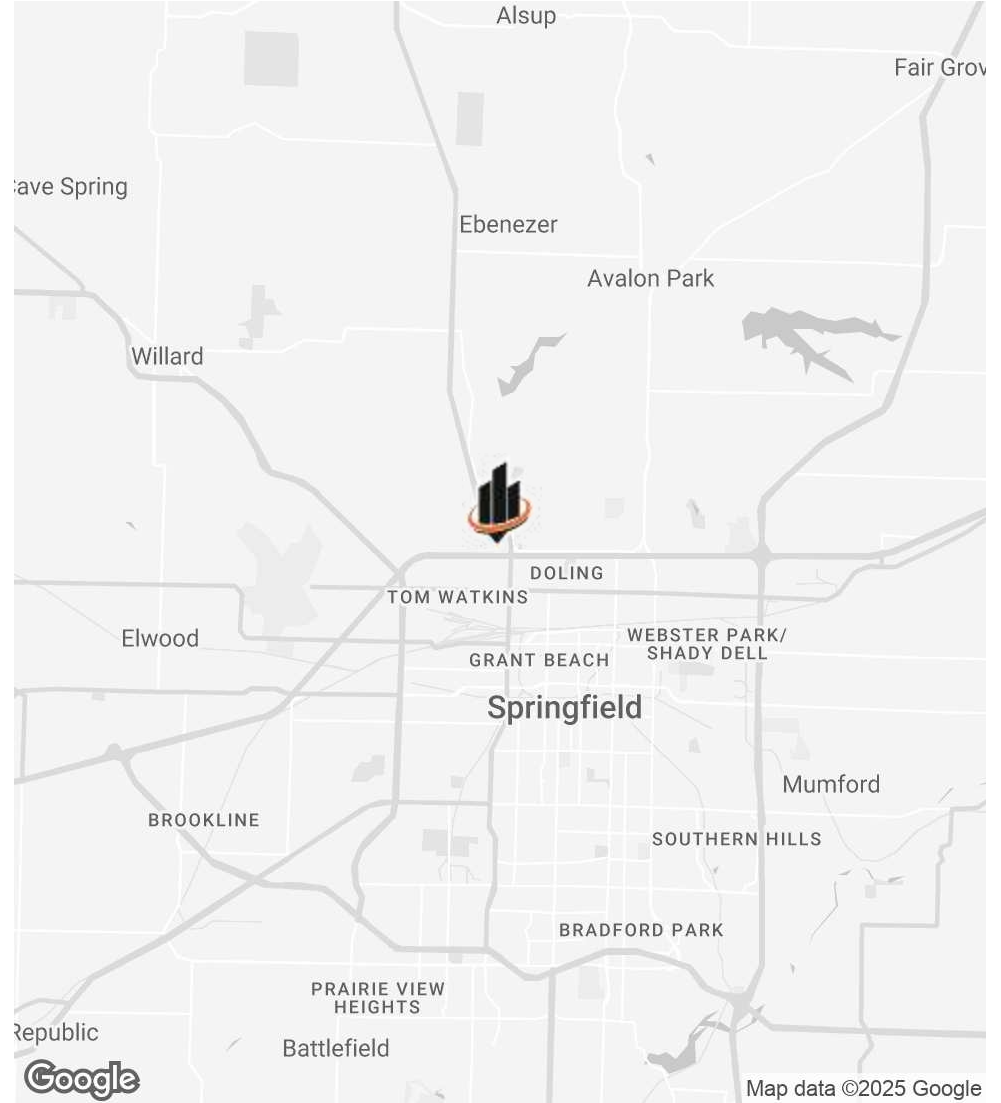
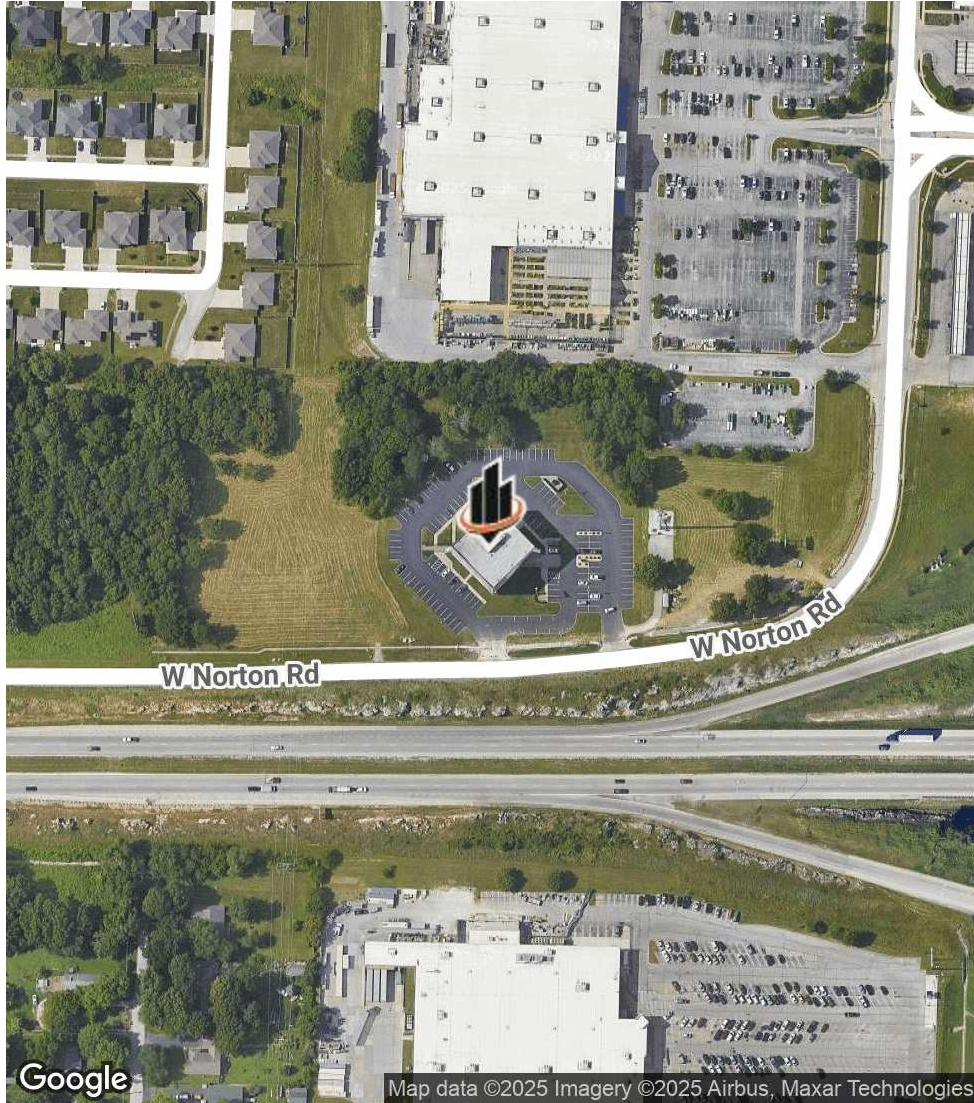

# LOCATION MAP

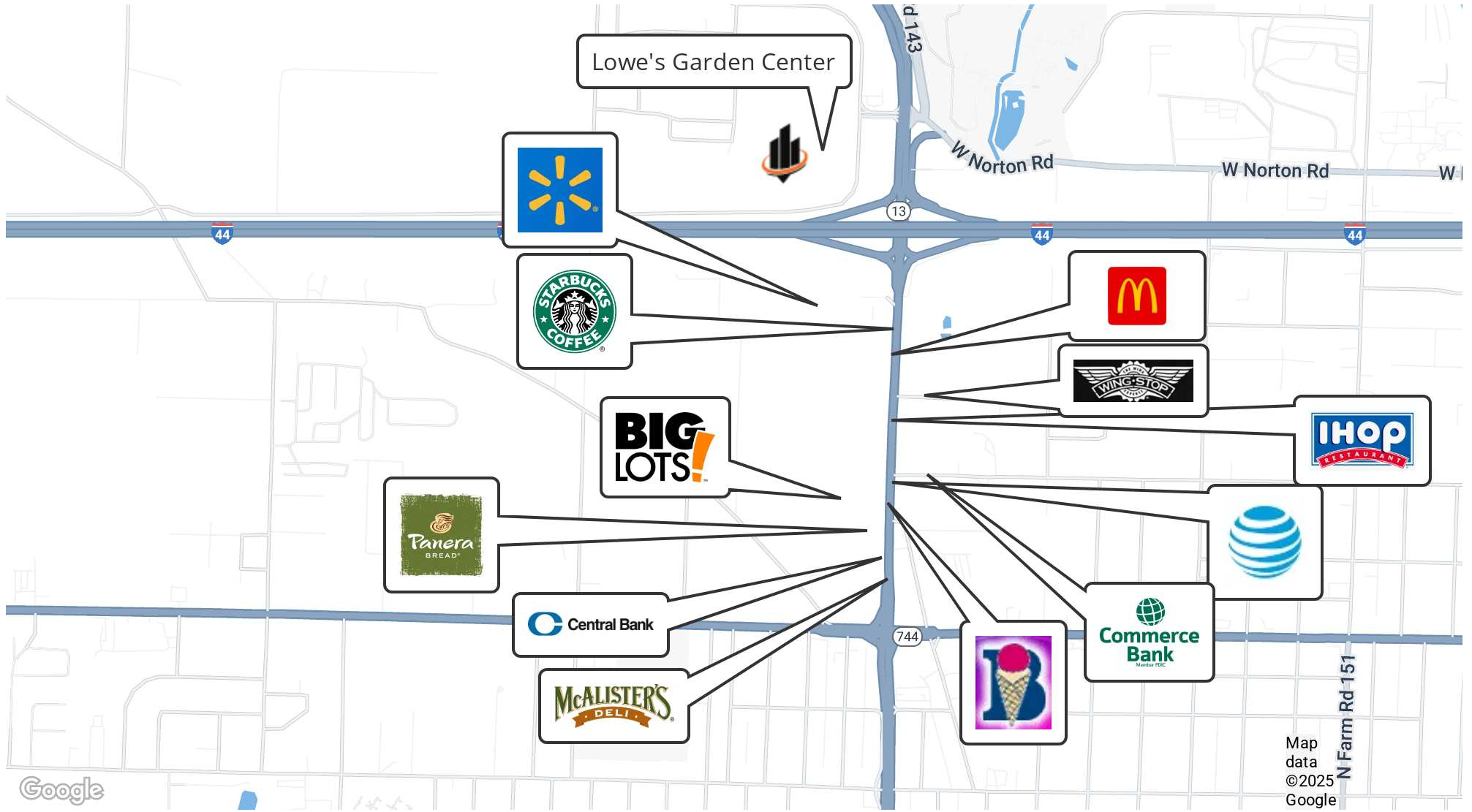

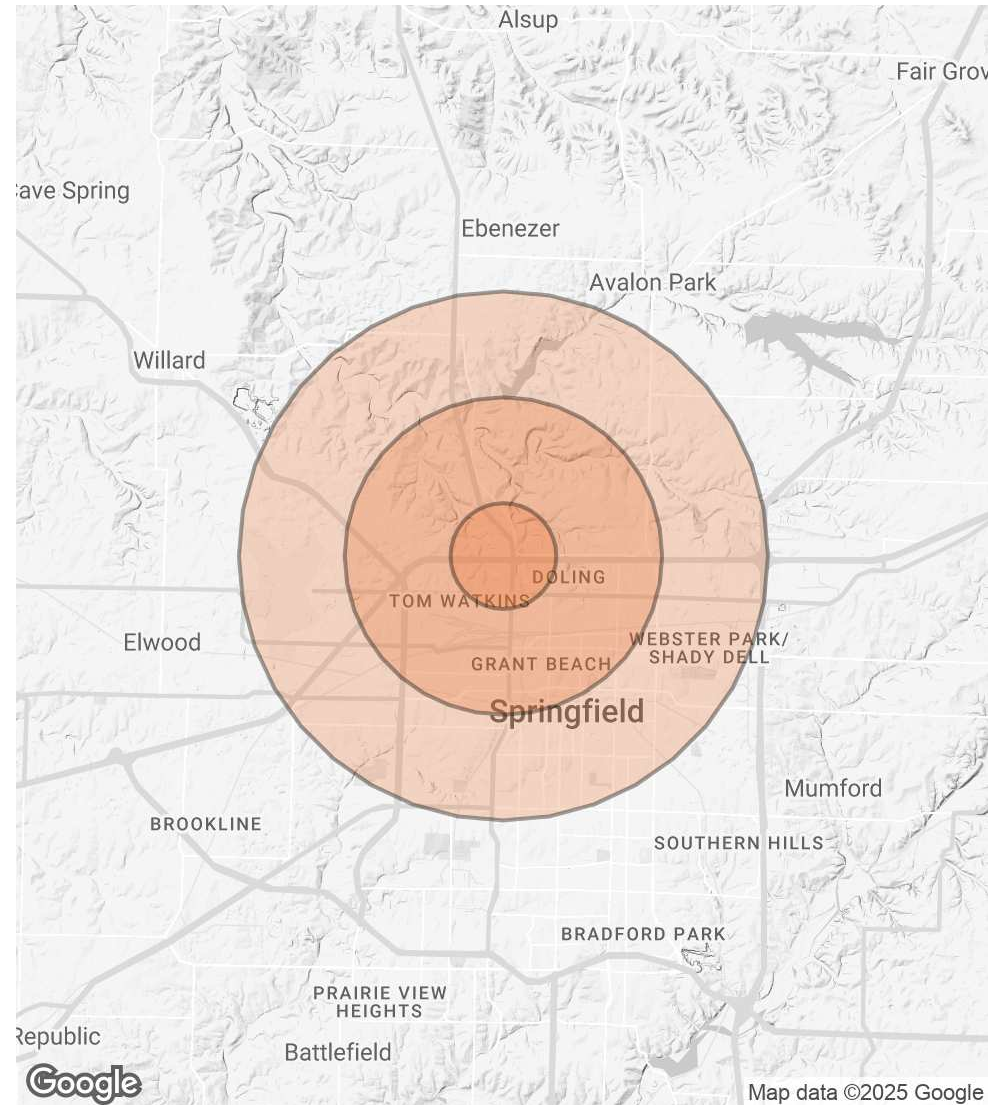
