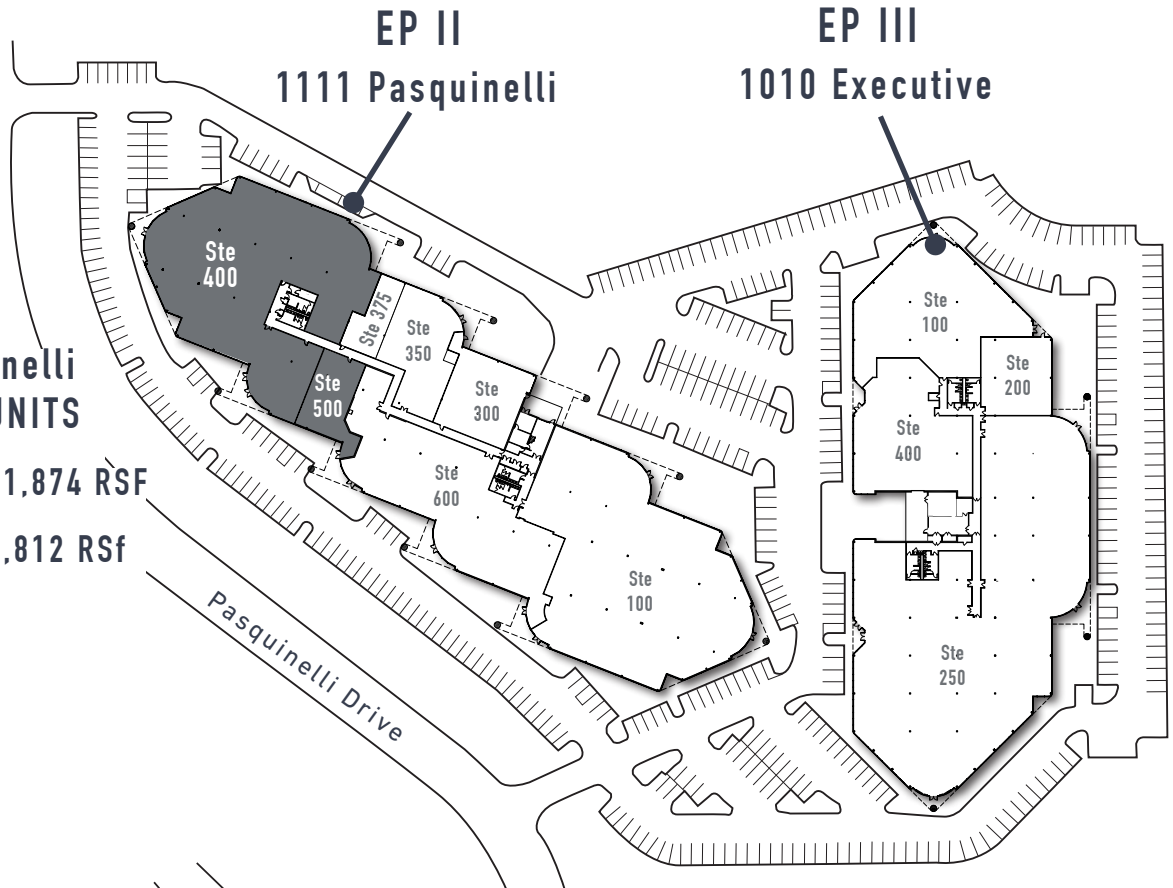

PARK PLAN



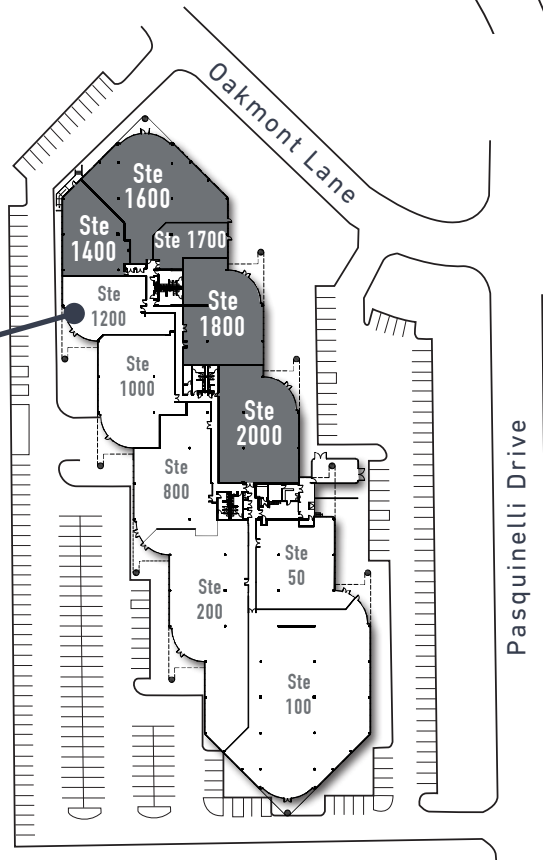

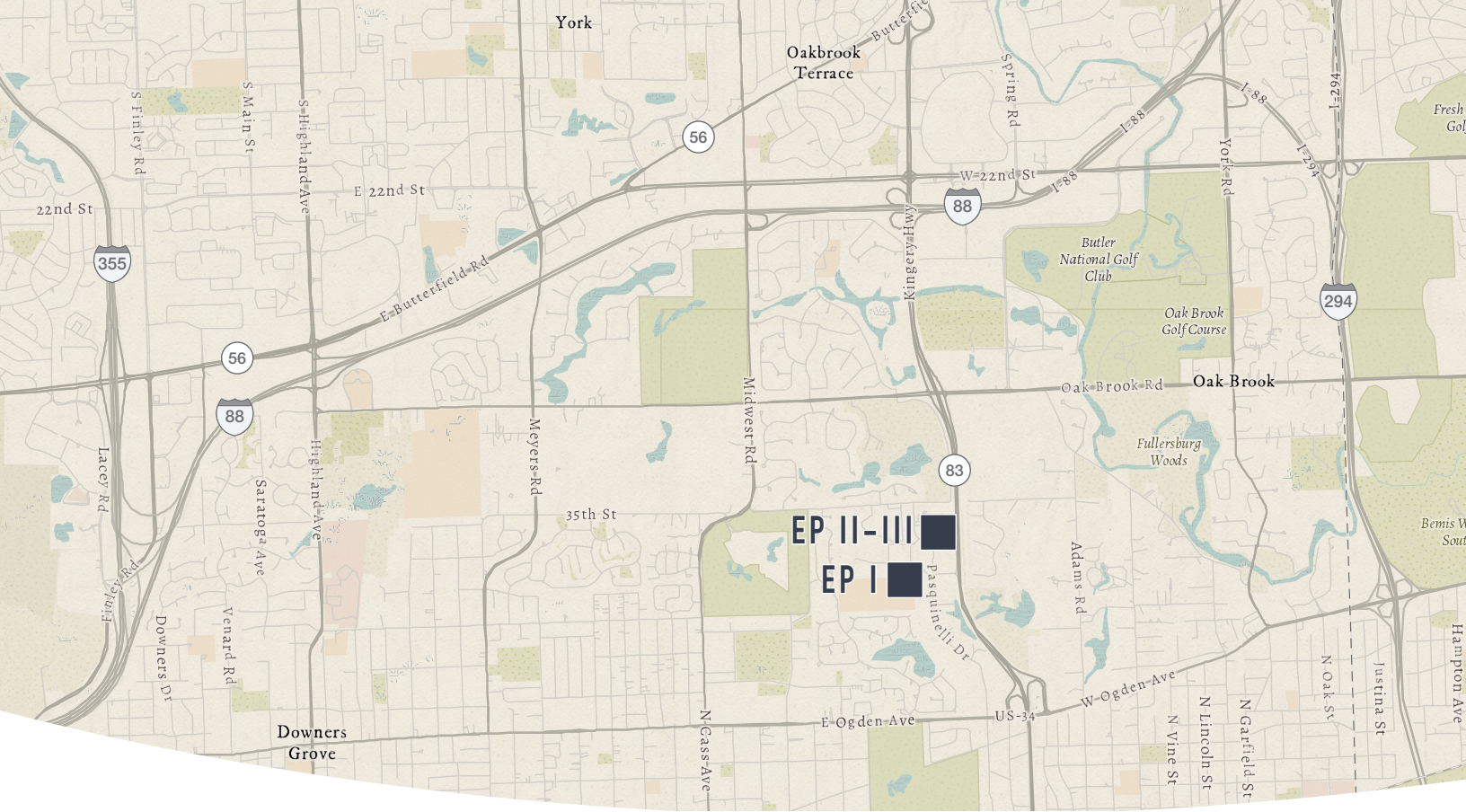
