Called out for septic service and inspection. Parked truck on west side of building by door, pulled 2 hoses over to septic tank right next to telephone pole on west side of building that's right with ground level. Pump out and rinsed down 1000 gallon single compartment septic tank. Good to go on septic maintenance for 2 years since it's a commercial building.

Tank, baffle T's, riser, lid, flow in and out of septic tank were in good condition at time of service. Note: lid is just big enough to cover hole, but would recommend getting a lid that's bigger for safety purposes.
