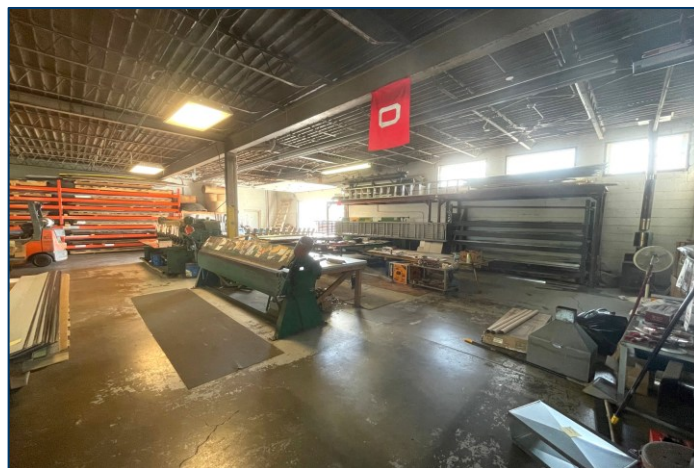
Drive-in Shop Area

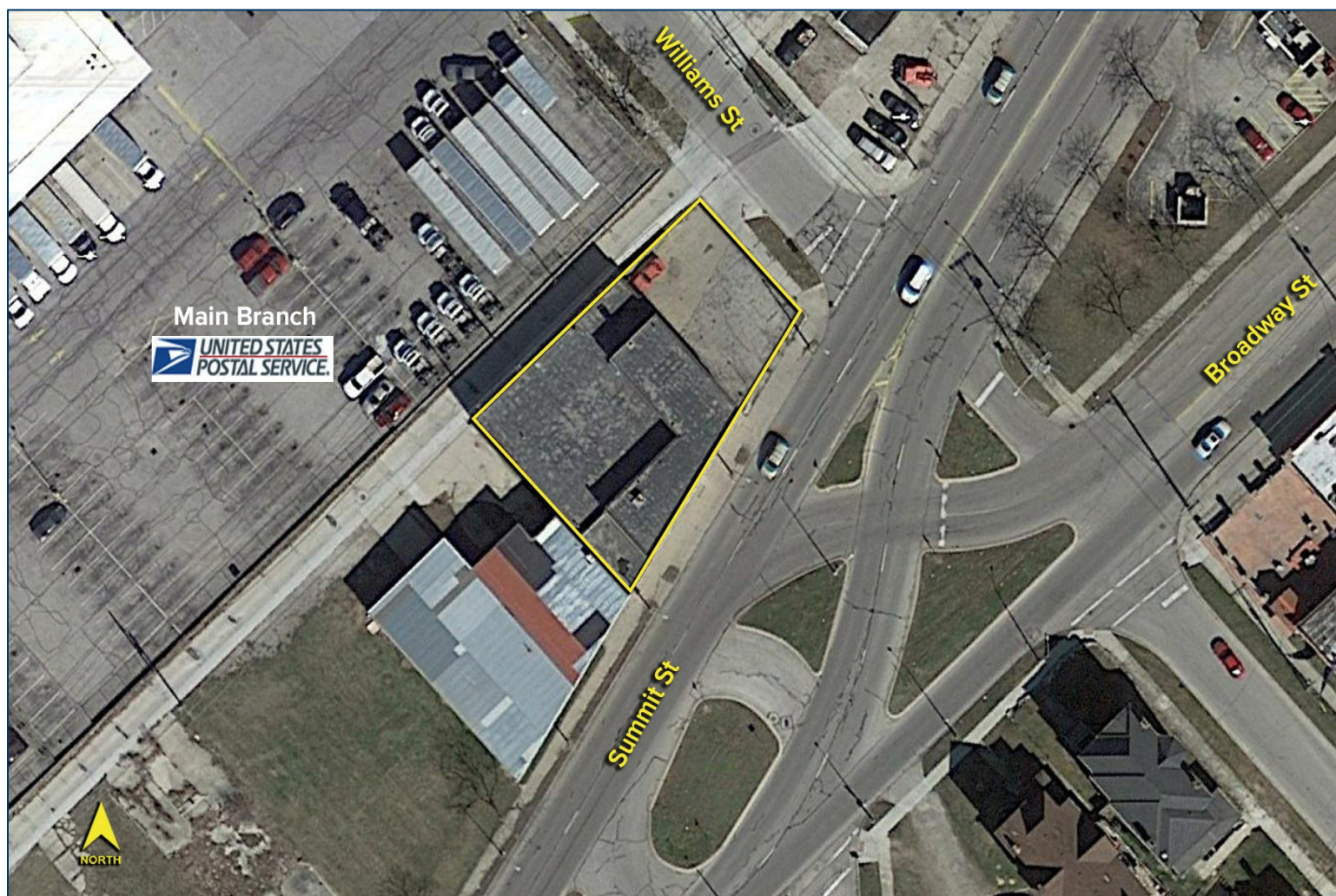
