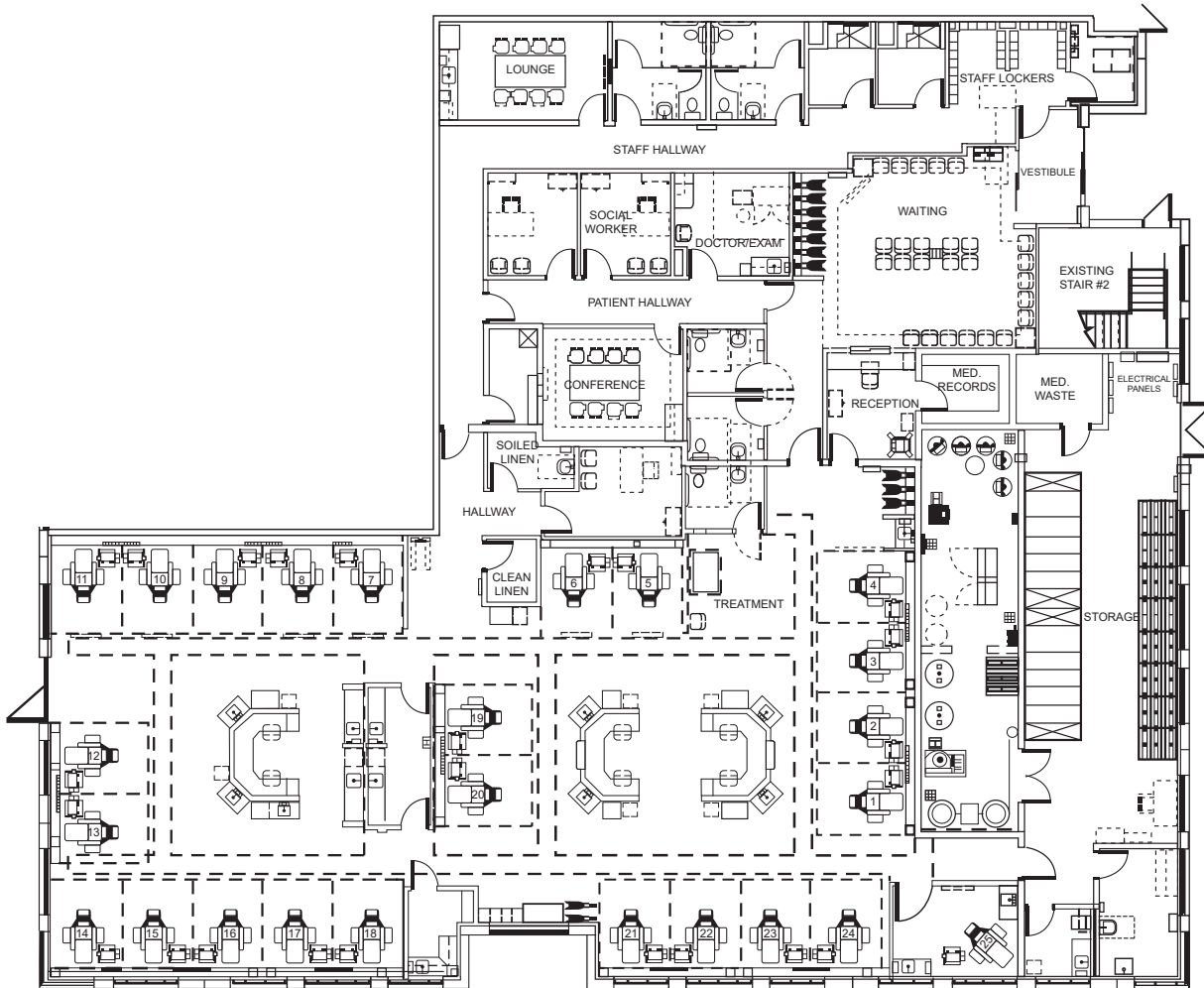
IDEAL MARKET & SITE LOCATION

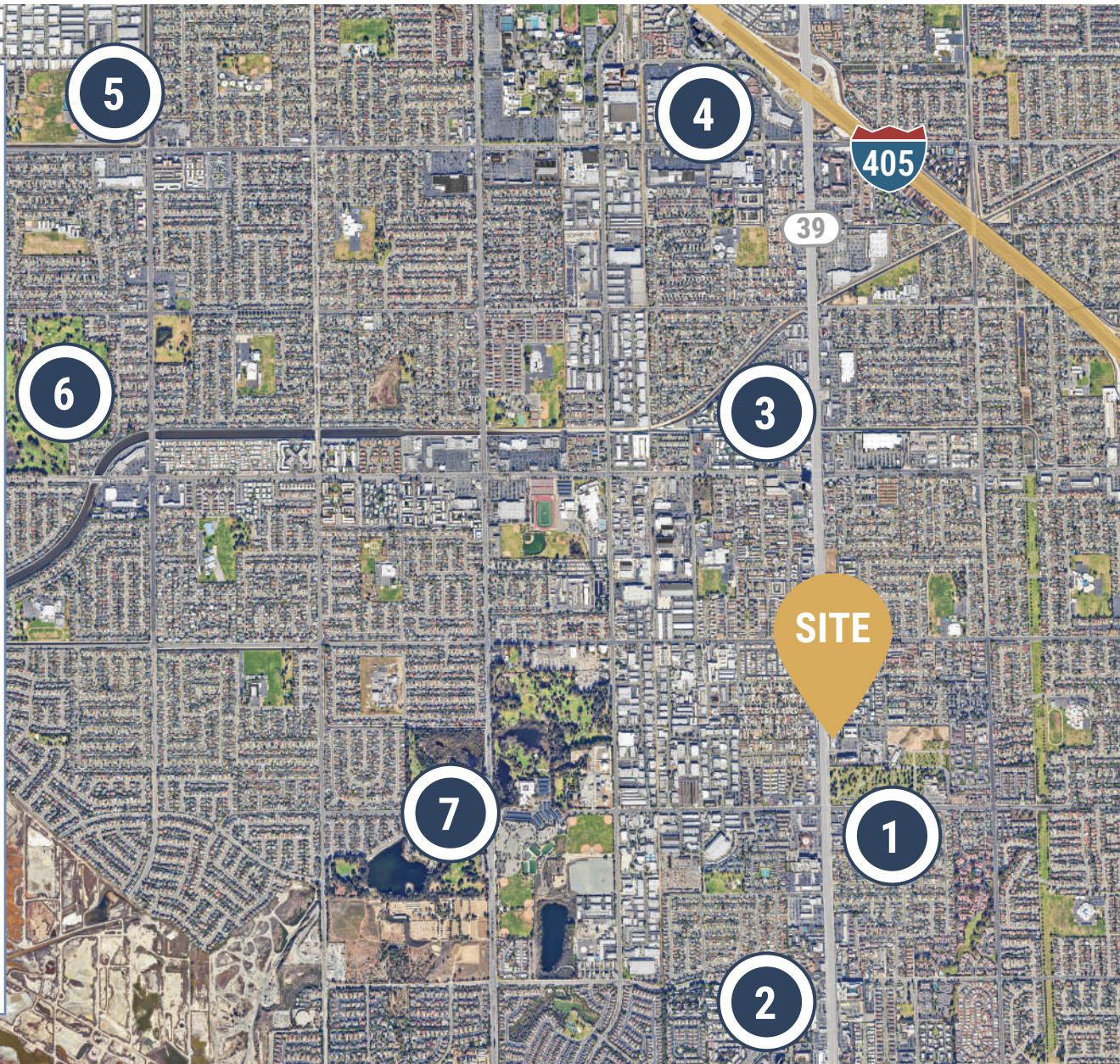
