The unit is available by way of a new lease for a term to be agreed. The rent is exclusive of all outgoing.

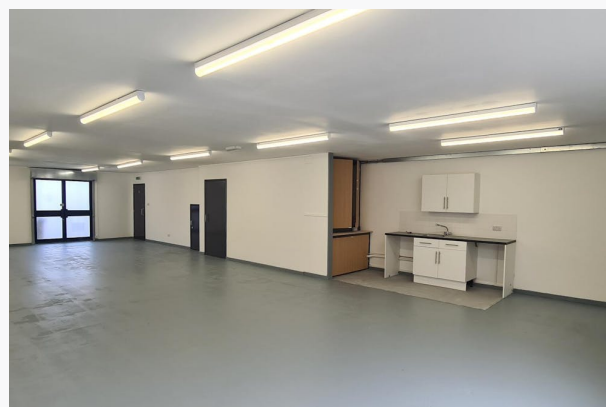
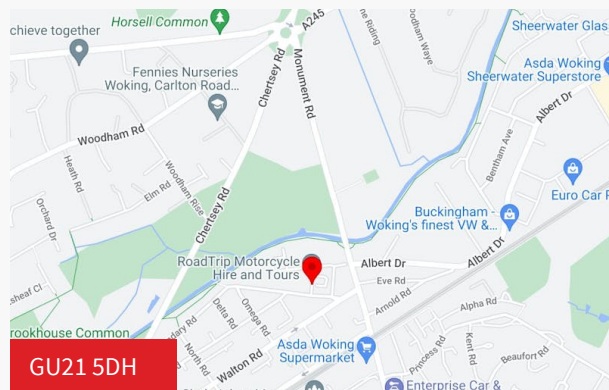
