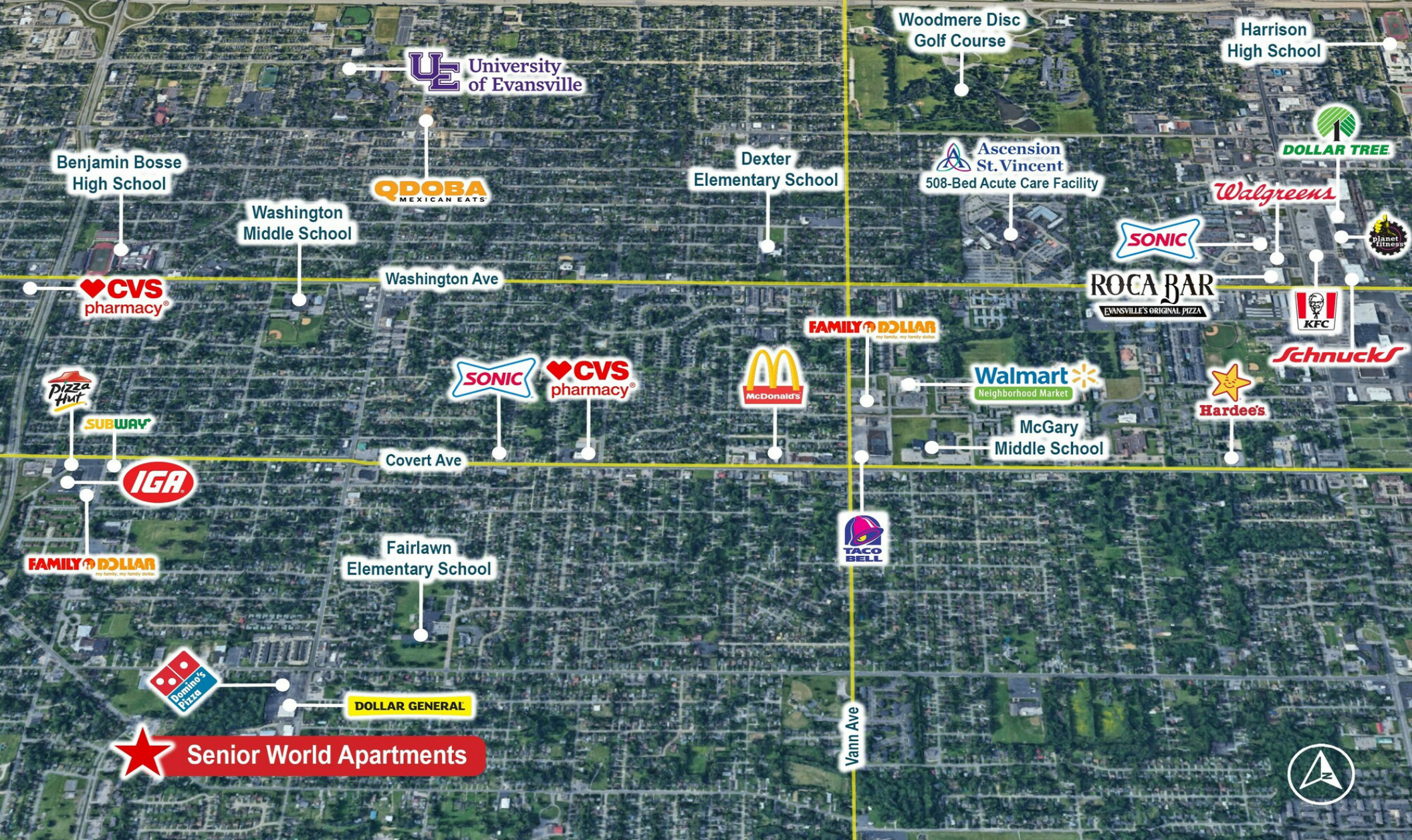
INVESTMENT HIGHLIGHTS
