LANDSCAPE REQUIREMENTS

COMMERCIAL PLANTINGS (MINIMUM 50% EVERGREEN SHRUBS)

- 1 tree / 2,000 SF of vehicular surface area
- = 8.5 required trees
- 1 shrub / 500 SF of vehicular surface area
- = 33.6 required shrubs

TRANSITIONAL PROTECTIVE YARD (MINIMUM 50% EVERGREEN SHRUBS)

- TYPE D-4 - 20' WIDE: 292.5 LF (6.6 canopy, 3.3 understory, 28 shrubs / 100 LF)
- = 19.3 required trees
- = 9.7 required understory trees
- = 81.9 required shrubs
- TYPE B-1 - 25' WIDE: 1,922.5 LF (3.5 canopy, 1.4 understory, 14 shrubs / 100 LF)
- = 67.3 required trees
- = 26.9 required understory trees
- = 269.2 required shrubs
- TYPE B-3 - 20' WIDE: 42 LF (4.5 canopy, 1.8 understory, 18 shrubs / 100 LF)
- = 2.1 required trees
- = 0.8 required understory trees
- = 8. required shrubs
