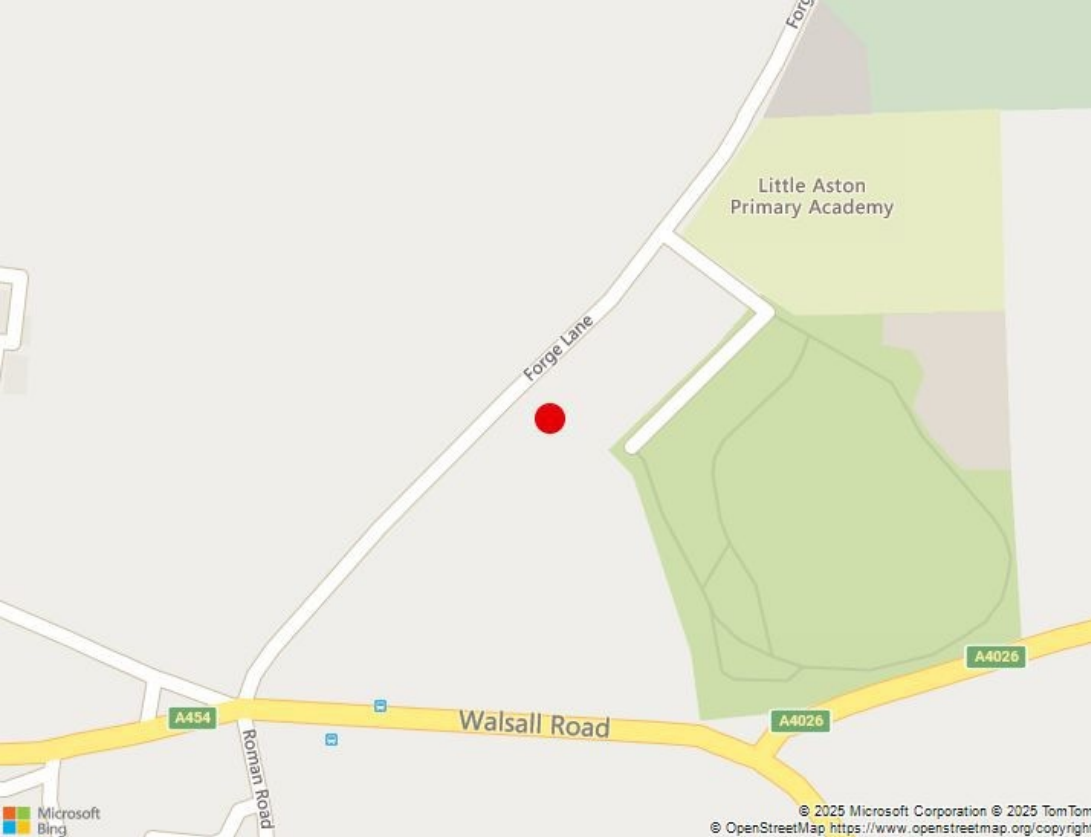

LOCATION

The site is located on Forge lane in the village of Little Aston, approximately 2 miles north of Sutton Coldfield and 10 miles from Birmingham City Centre. The site benefits from excellent transport links to the A452, A38 and M6 Toll, with Blake Street Railway Station nearby providing direct links to Birmingham New Street and Lichfield City Railway Station.

DESCRIPTION

The site comprises of approximately 0.10 acre of storage land to the front, with single storey office accommodation to the rear in a popular affluent location which could be suitable for a variety of uses subject to planning. The office accommodation comprises of a front porch on entry and opens out into three separate offices on either side with kitchenette and two WCs. The offices benefit from gas central heating, LED / fluorescent lighting and carpet coverings throughout.
