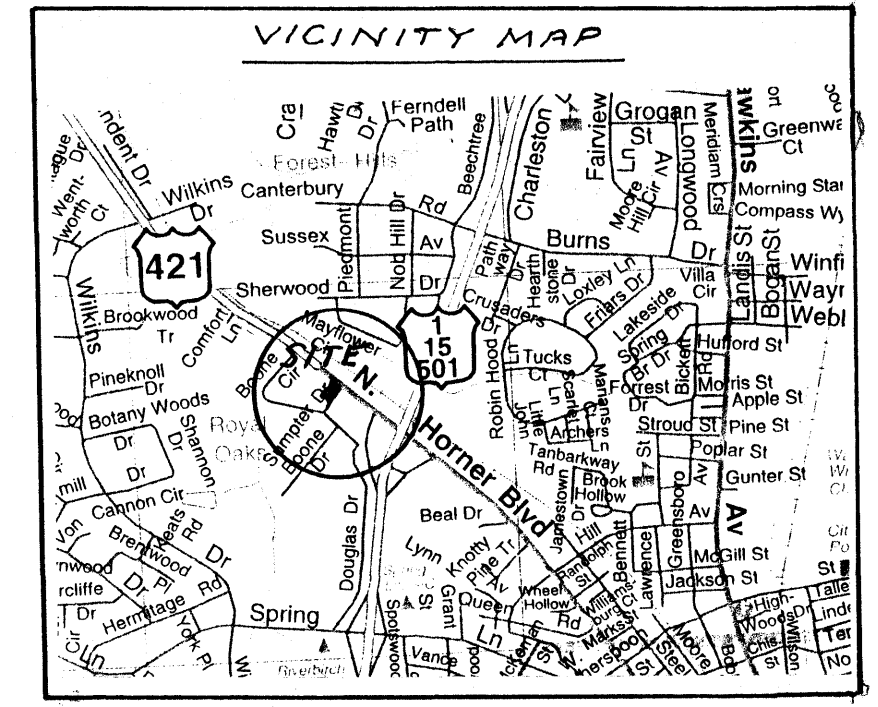
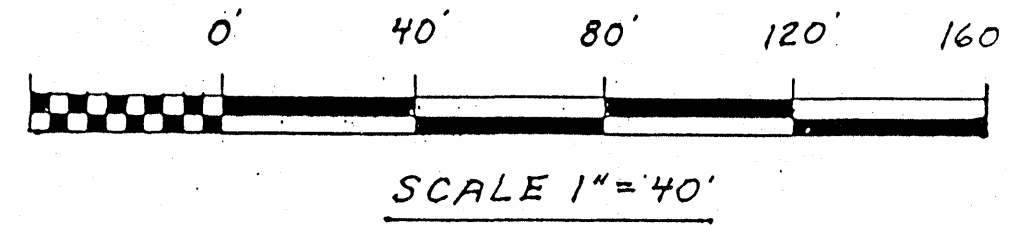


PROPERTY OF SANFORD FOOD SYSTEMS

SCALE 1"= 40' **AUGUST 11TH, 2006**



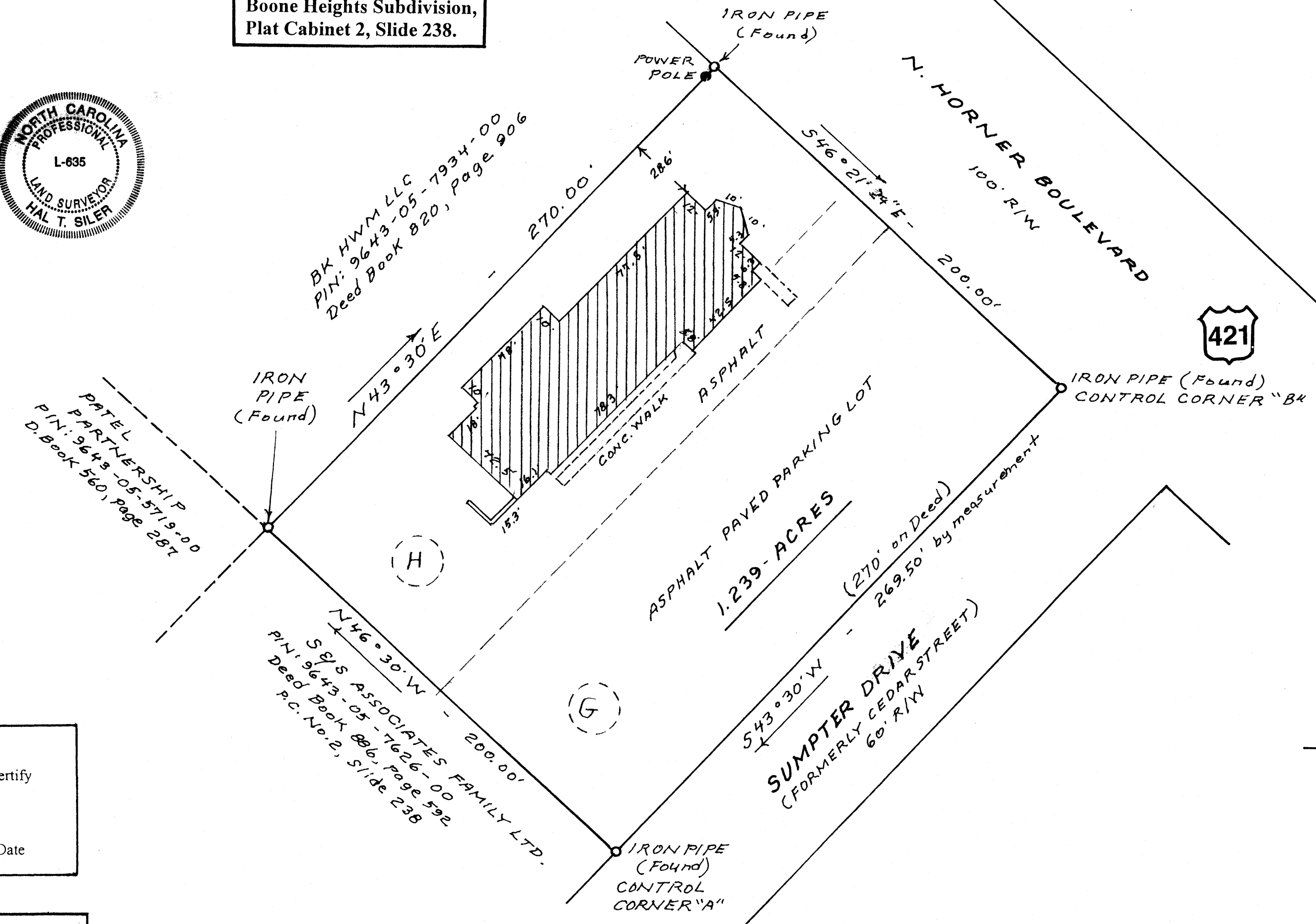
