Location

Lingfield Way is on Yarm Road Business Park, situated east of Darlington Town Centre. Nearby occupiers include Amazon, Cummins Engines, EE, Nobia UK, and Northgate Vehicle Hire.

The business park is located adjacent to the A66, which in turn links with the A1(M) and the A19, providing transport links throughout the region.

Description

The premises comprise a substantial headquarters facility, providing warehousing and offices finished to a high specification.

The steel portal framed warehouse has a maximum eave's height of 5.9m and is accessed via 3 loading doors from a secure compound.

The two storey offices are finished to a high specification providing rooms of varying sizes plus a substantial boardroom/showroom. The offices have air conditioning, suspended ceilings, perimeter trunking and aluminium framed double glazing. The premises have a fibre internet connection and there are staff amenities on each floor.

Externally there is ample parking and circulation space.
