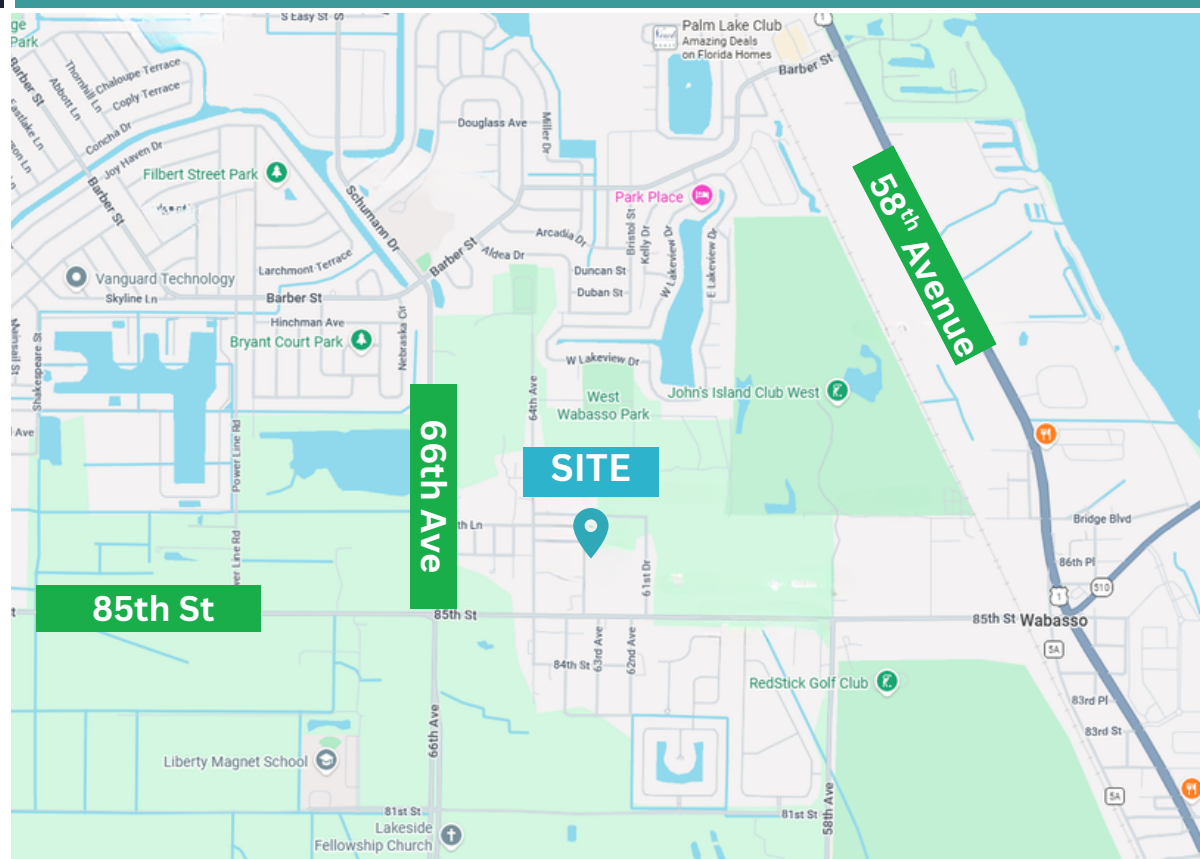

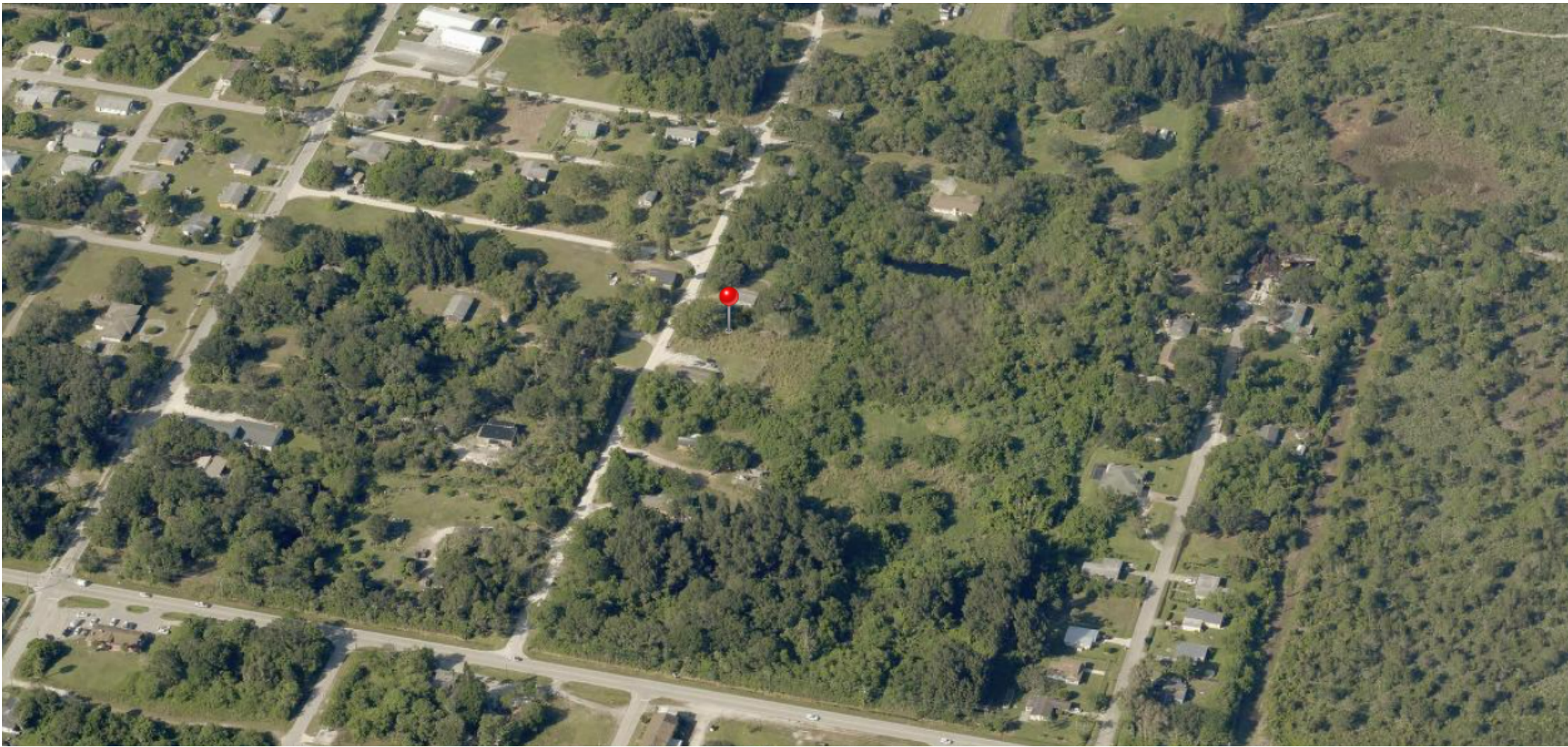

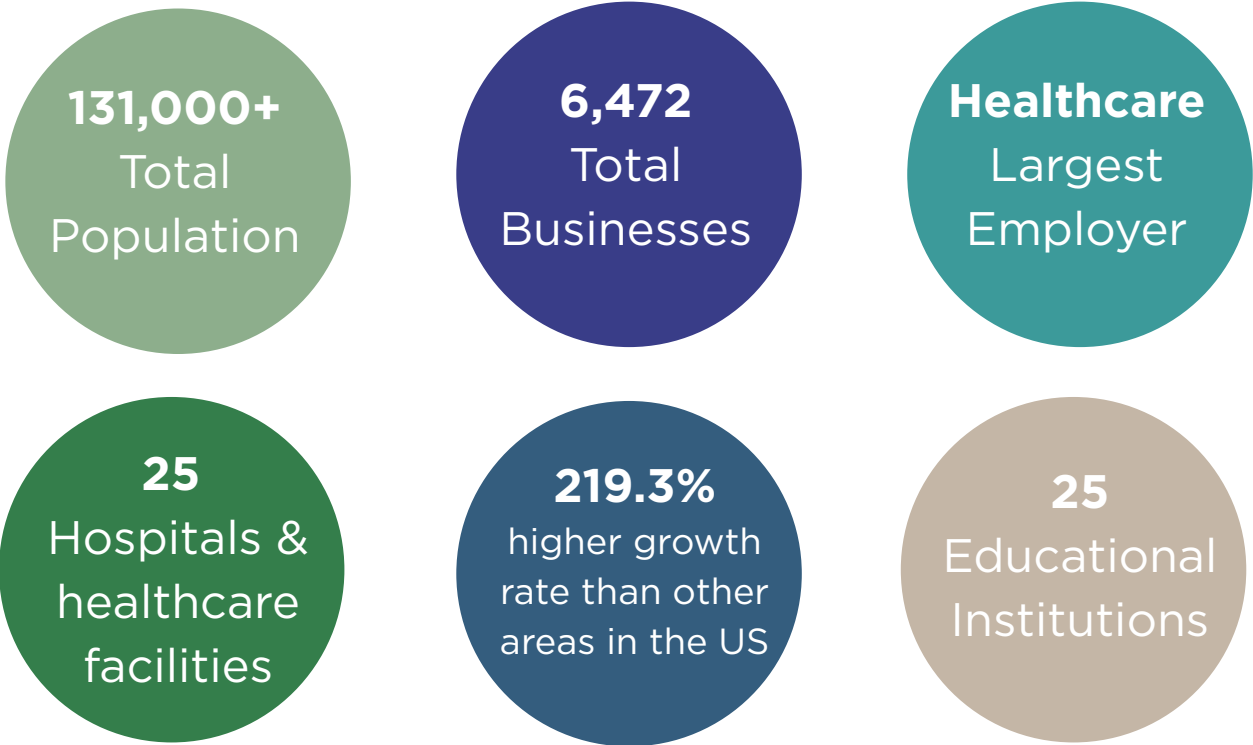
AERIAL VIEW
