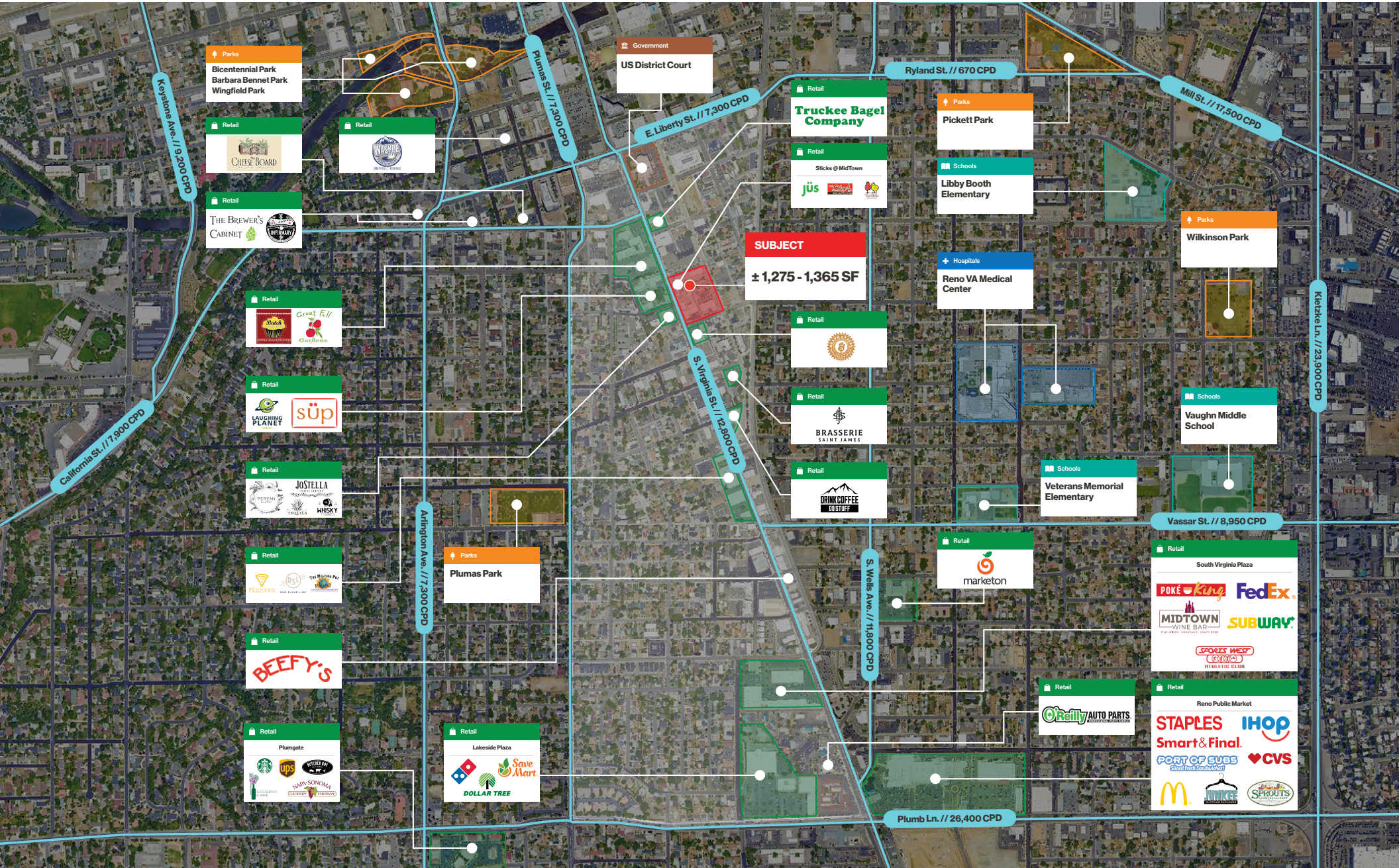

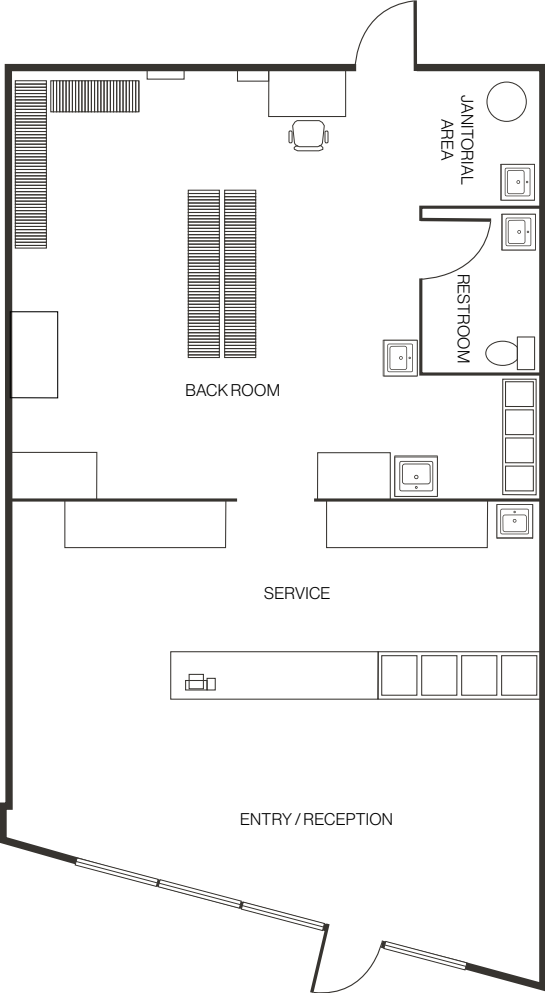

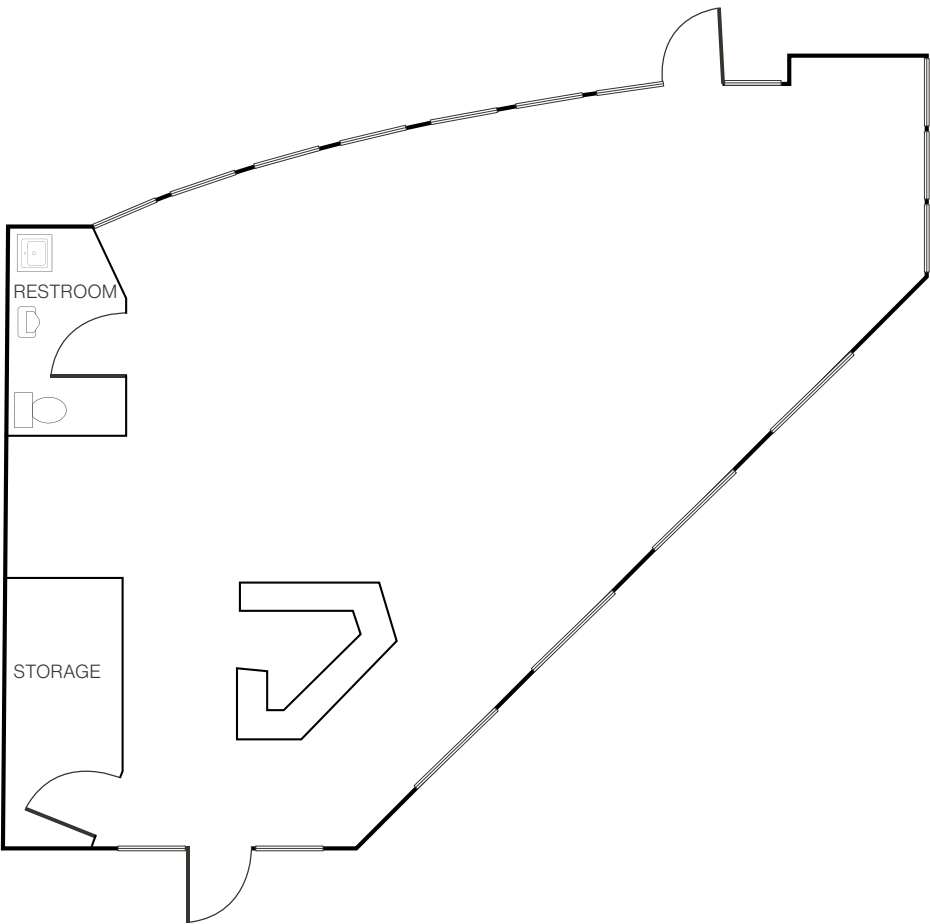


Floor Plan
