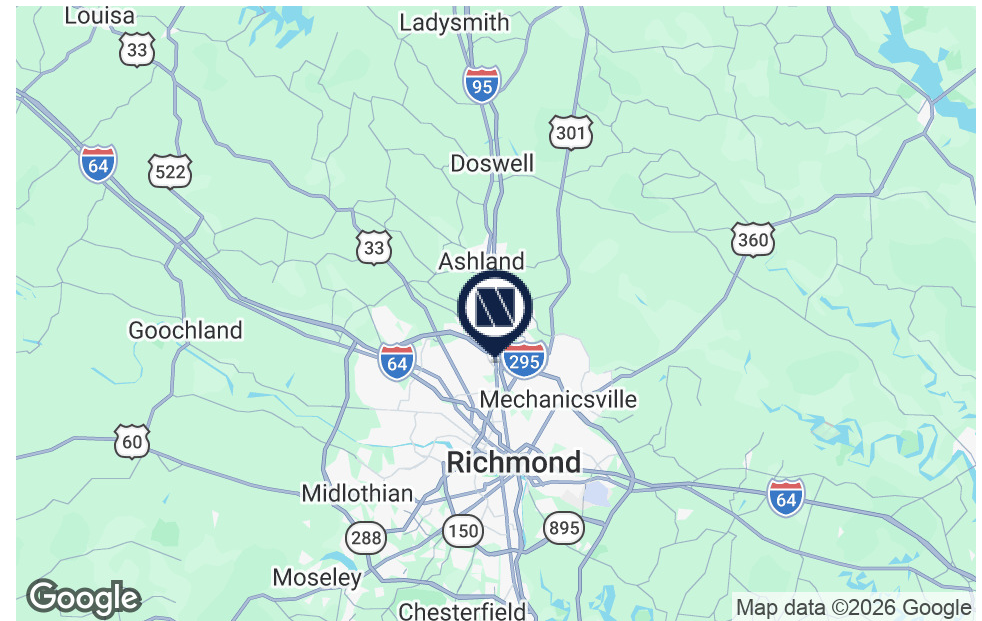
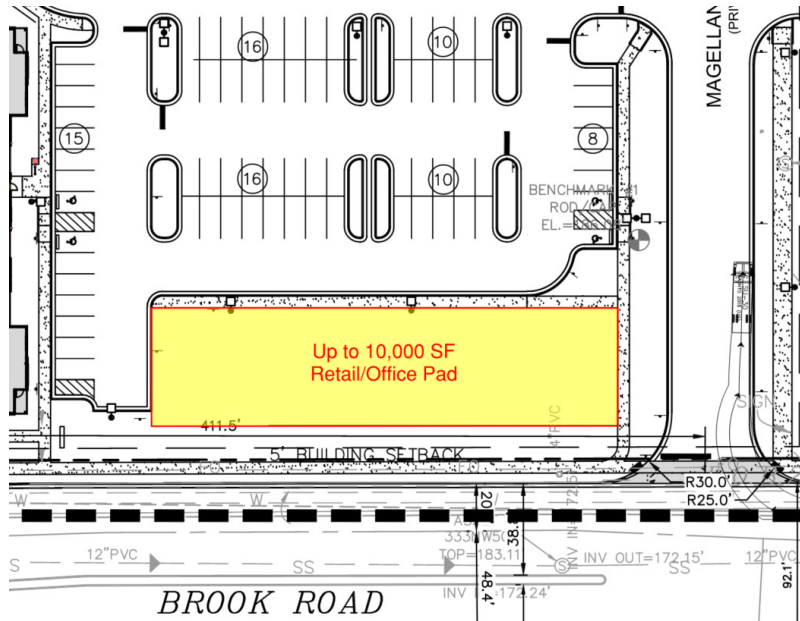

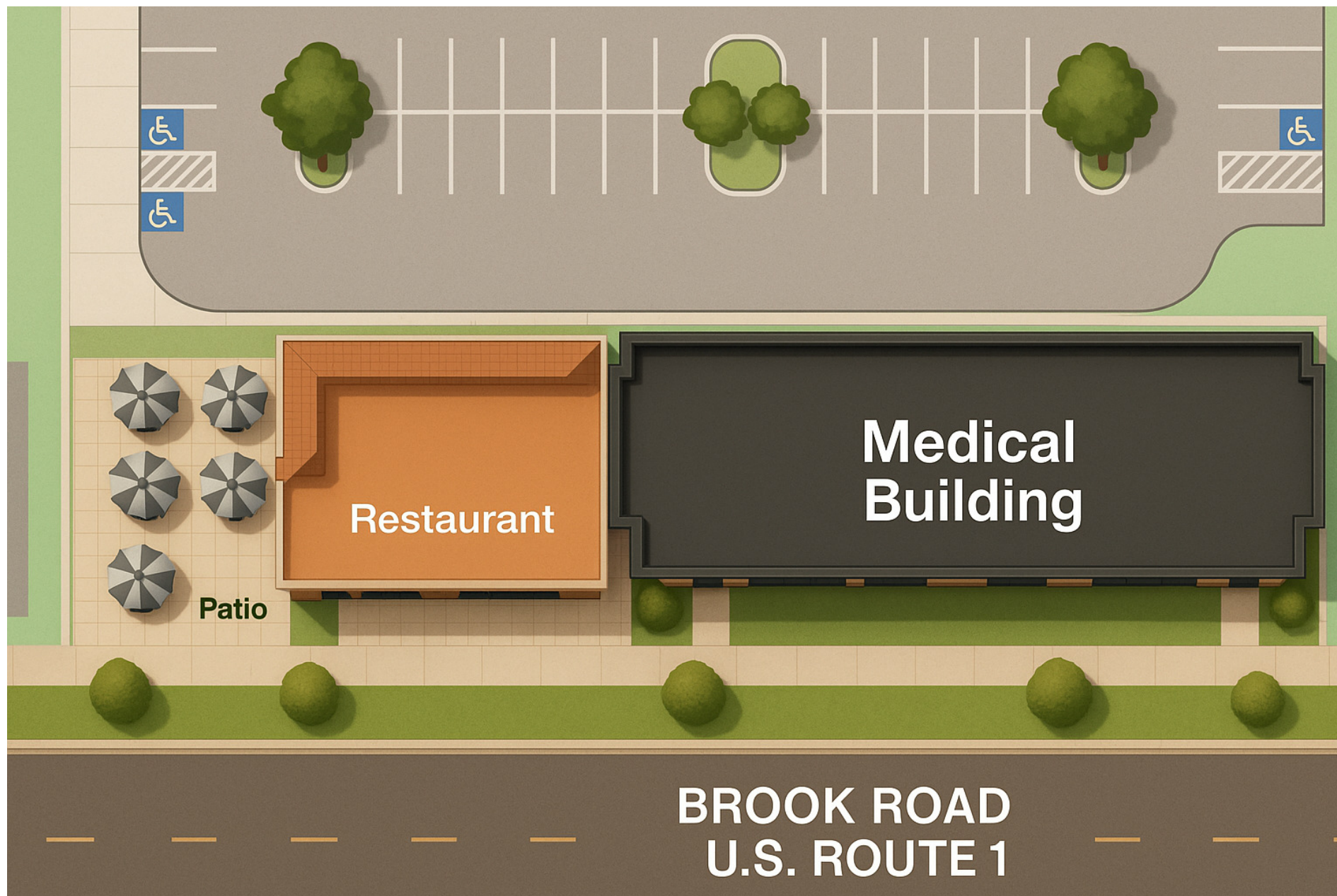

Level Green - the new residential community taking shape on the former Scott Farm property near the Best Products redevelopment, is moving forward with its first phase of homes. The 111-acre project represents a \$400 million investment by Markel Eagle Partners, bringing 880 for-sale residences to the area. With new road connections, a planned linear park, and close proximity to the future arena-anchored mixed-use district, Level Green is positioned to become one of Henrico's most dynamic new neighborhoods.

Retreat at One - Across the street from the site, Stanley Martin is under construction on a new 606-unit for-sale community. This development has a mix of two-story condos and townhomes as well as a commercial pad.

Virginia Center Commons - A 775,000 SF mall is actively being redeveloped to include a new sports complex, convention center, retail, 525 townhomes and 830 apartments.

River Mill - The original 250-acre project includes 300 townhomes, 285 apartments, 50 single-family homes and 400 zero-lot-line homes. They have recently expanded the development to add an additional 57 townhomes.
