Location

Edinburgh is Scotland's capital city and has a population of around 490,000 people with an estimated wider catchment in the region of 1.6 million people.

In the summer the city hosts one of the largest festivals in the world and is regarded as the second most popular tourist destination in the UK after London.

The subjects are located in a prominent position on the west side of Queensferry Street, in the heart of Edinburgh's West End, with access to Edinburgh's train, tram and bus network. Nearby occupiers include Zizzi, Pizza Express, McGraths Opticians, Six by Nico, HP Mathers and the new Johnnie Walker Experience directly across from Edinburgh Castle.

The flagship Johnnie Walker visitor centre is located just around the corner from Queensferry Street. The new visitor centre is the centrepiece of £150 million investment by Diageo and has created 160 - 180 full-time jobs and generated about £135 million in tourism spend in the wider Edinburgh economy through the visitors it attracts to the city.

Description

The subjects comprise a single windowed retail unit arranged over the ground and basement floors of a traditional stone built building under a pitched and slated roof. The upper floors are in separate ownership.

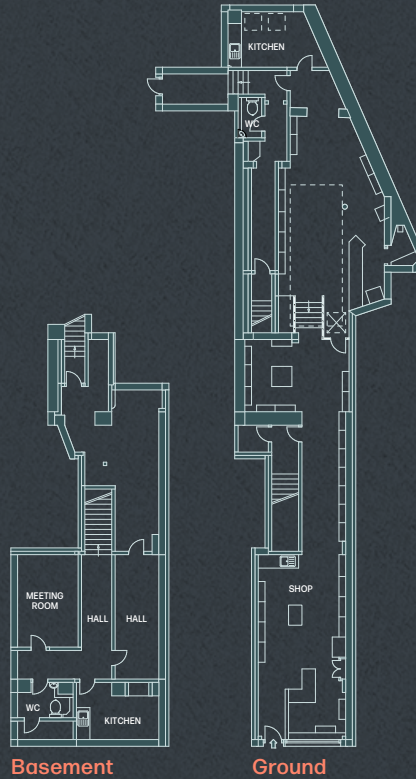
