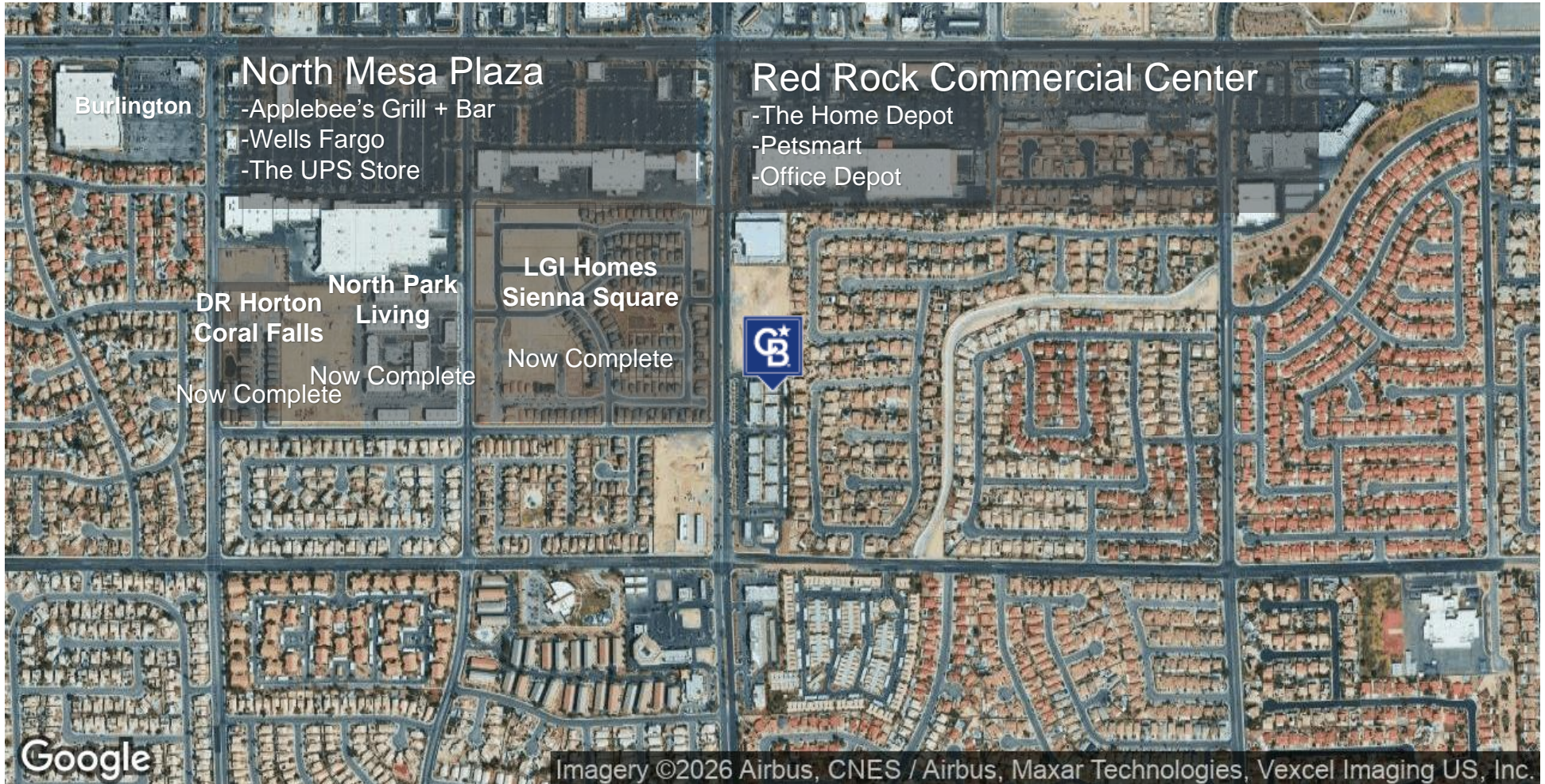








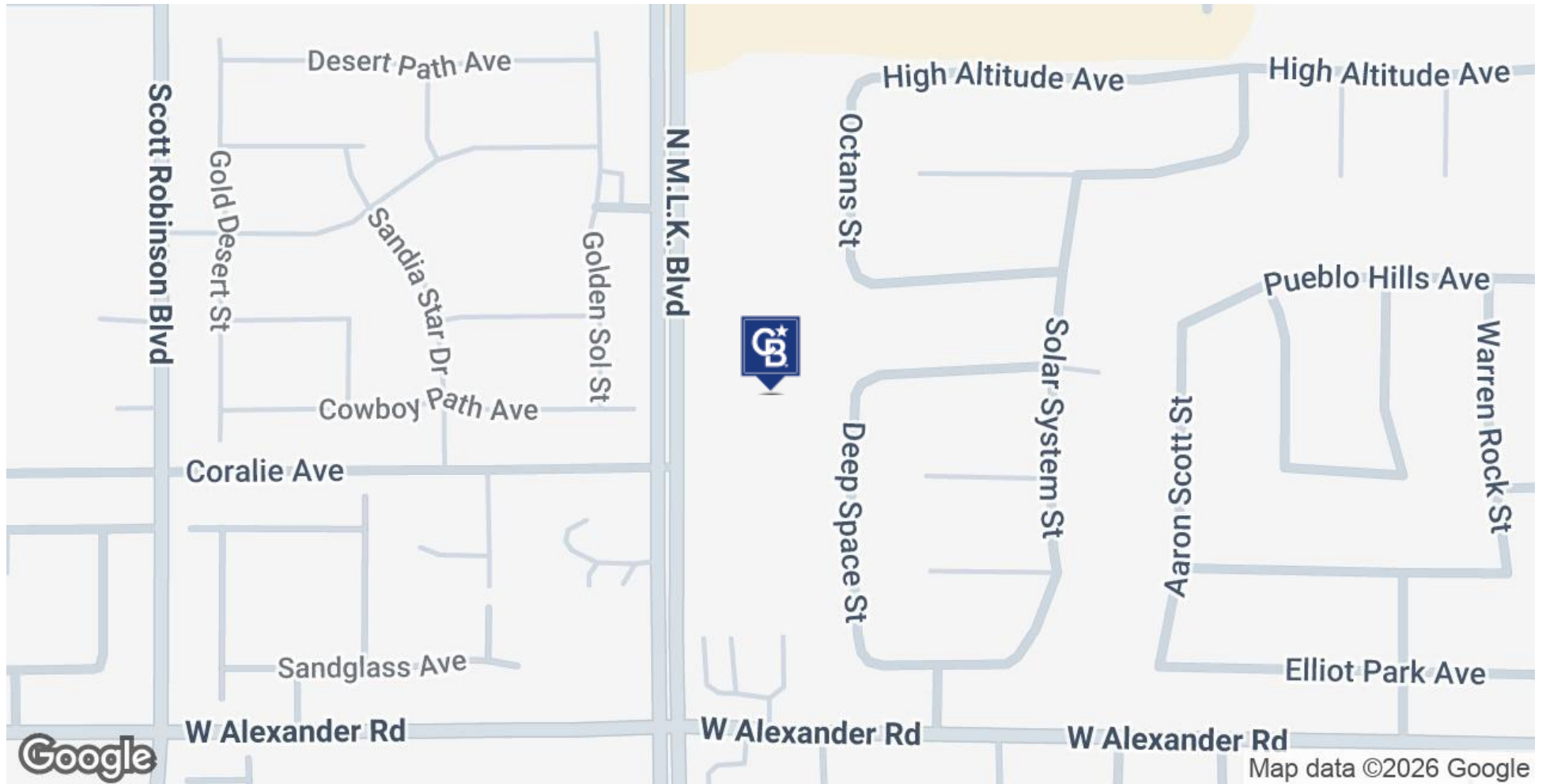

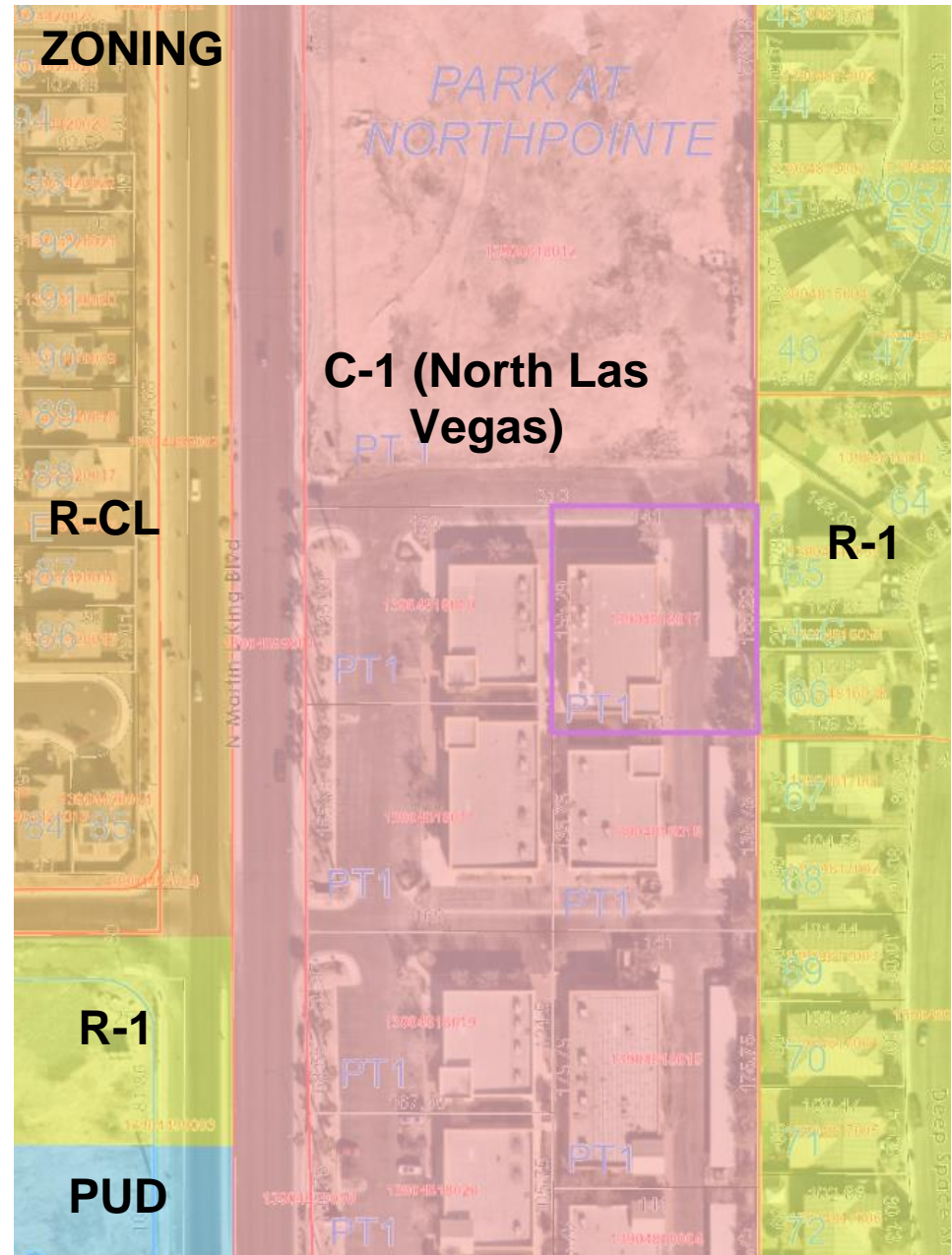
MAJOR CROSS STREETS

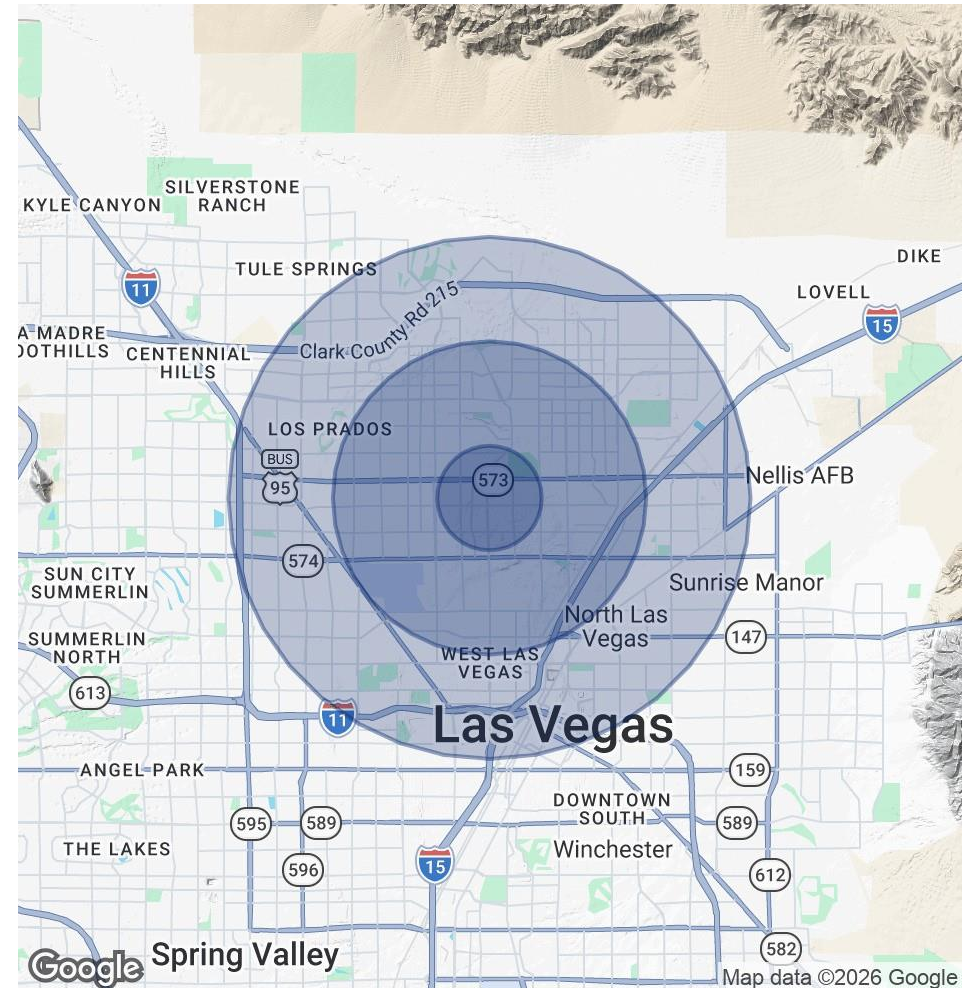
