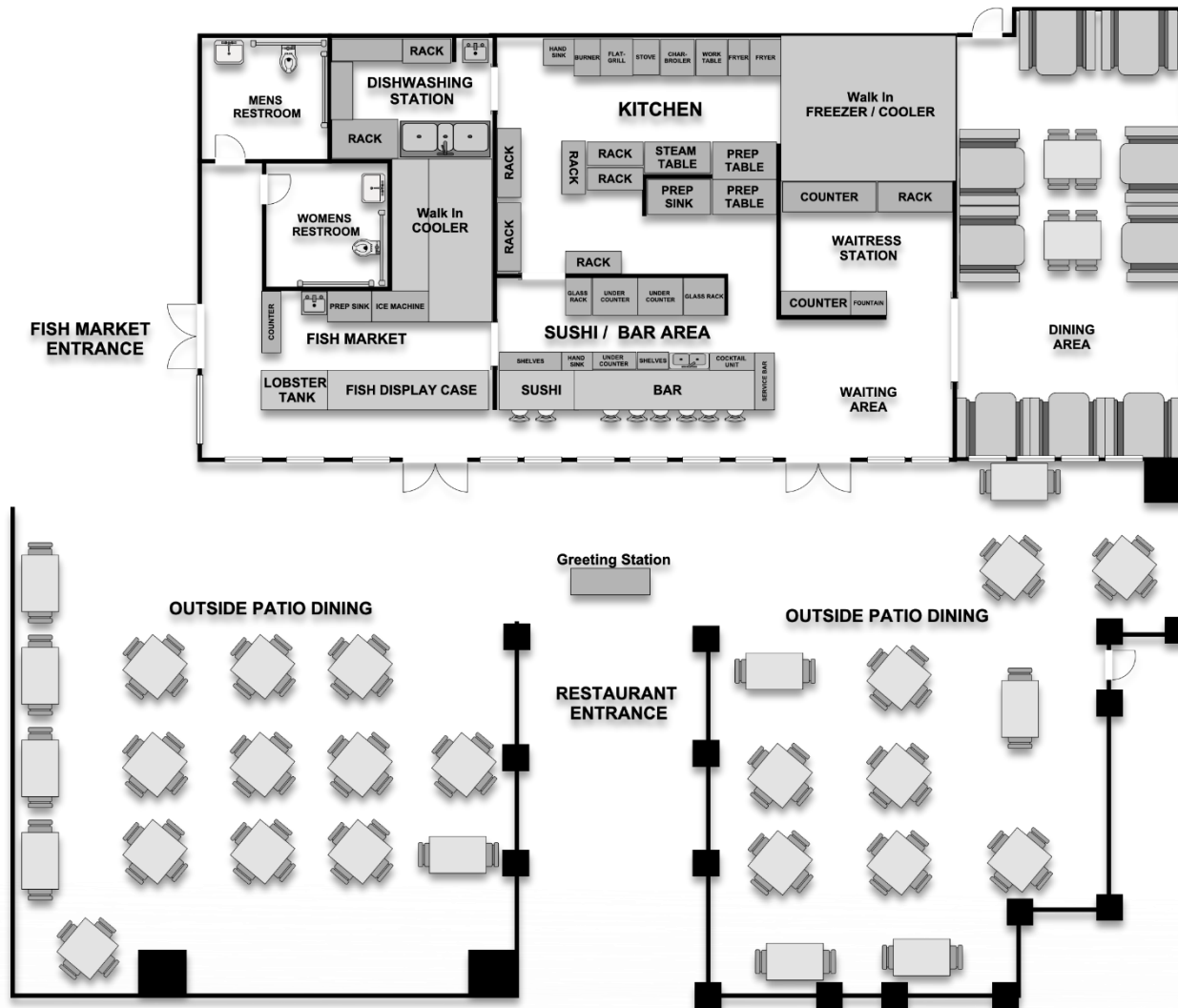

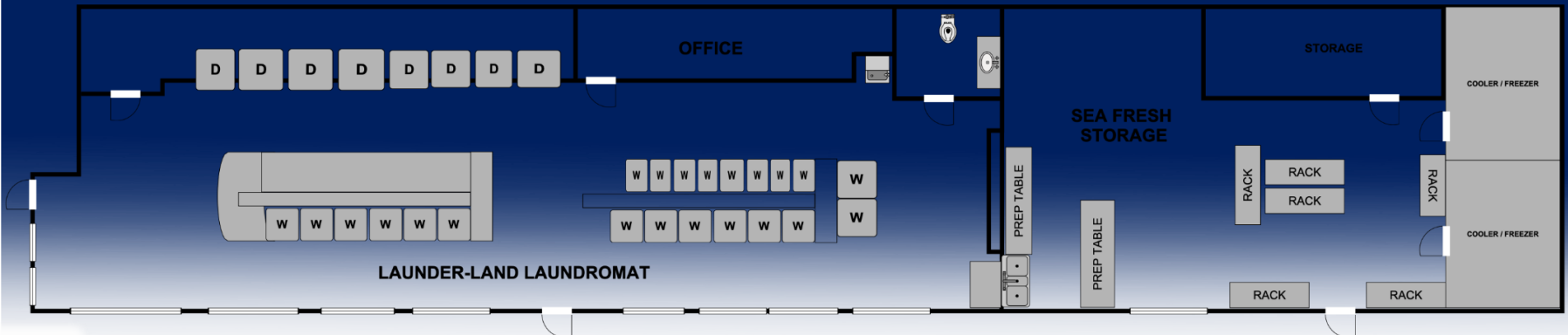

Ojai is a tranquil 4.3-square-mile town situated in Southern California, renowned for its vintage shops, spas, and art offerings. Nestled within a valley encircled by rolling mountains and nature preserves suitable for hiking and horseback riding, Ojai lies in Ventura County approximately 75 miles from Los Angeles and about 35 miles from Santa Barbara. The town attracts a diverse range of visitors, including spiritual seekers, outdoor enthusiasts, cyclists, urban and suburban residents seeking respite, as well as celebrities desiring a weekend retreat.

Visitors to Ojai will observe a distinctive atmosphere compared to much of Southern California. 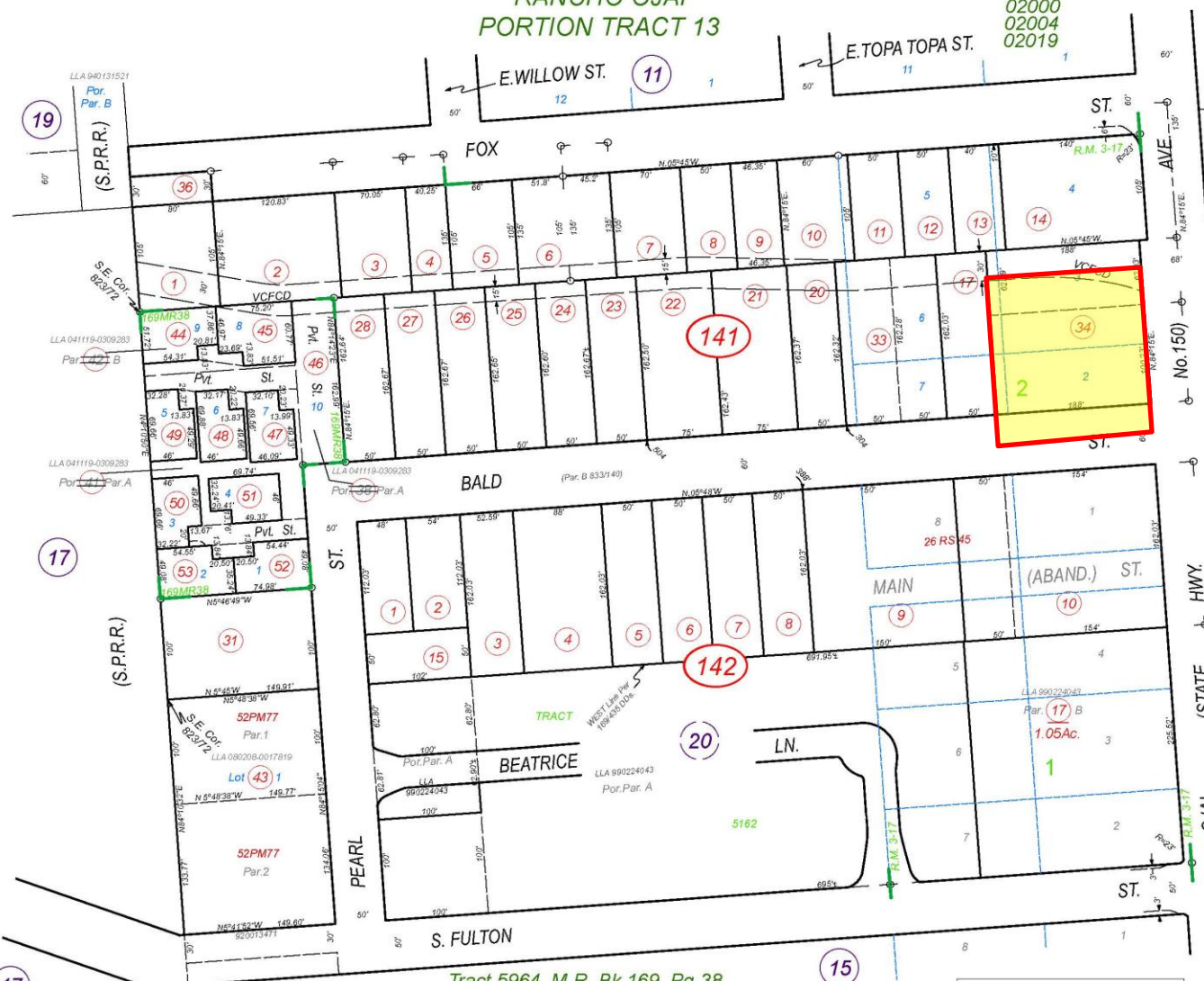
