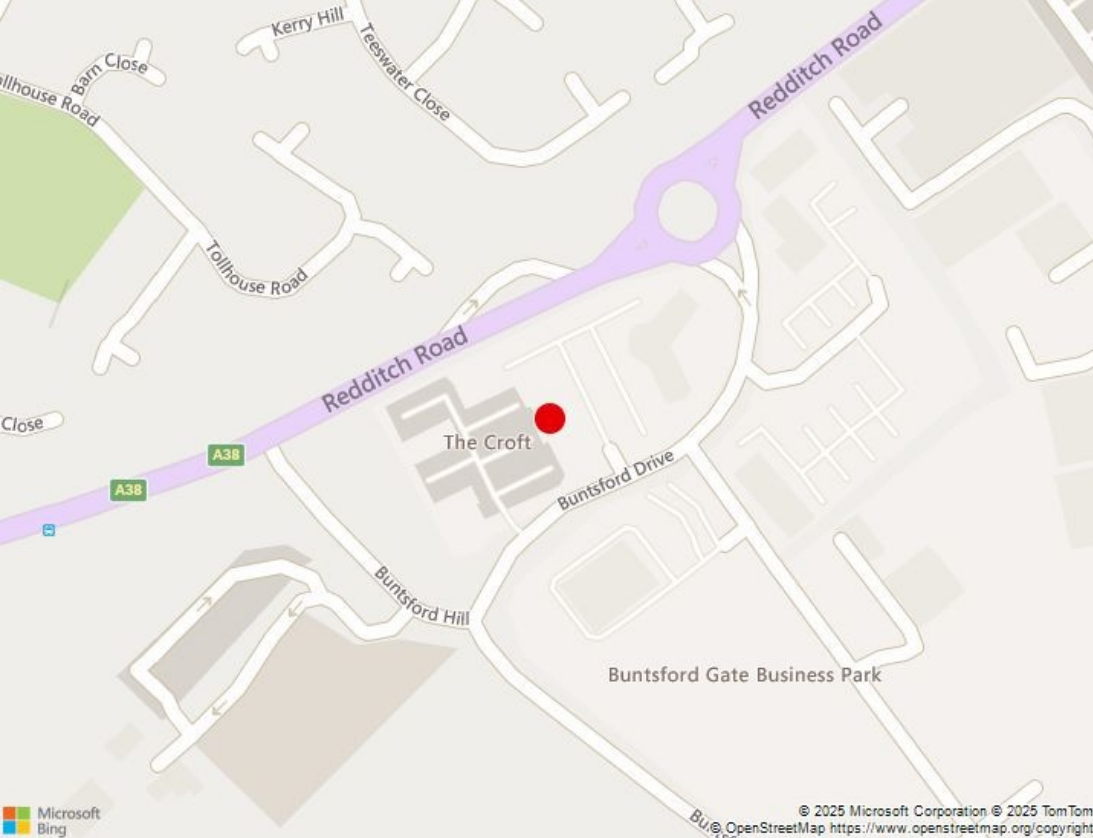

## LOCATION

The Croft is a modern office development situated to the Southeast of Bromsgrove Town Centre and conveniently located for access to the Midlands motorway network at J5 of the M5 Motorway approximately 4 miles away, and J1 of the M42 via the A38 3 miles away. Birmingham is situated approximately 13 miles to the North and Worcester lies approximately 10 miles to the South.

## DESCRIPTION

The property comprises a modern terraced office building within an established business park. The accommodation is arranged over two floors and can be accessed via two separate entrances allowing for splitting the floor if required, and opening into a predominantly open plan office with kitchenette and disabled WC on the ground floor with a small partitioned meeting room and server/comms room.
