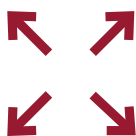

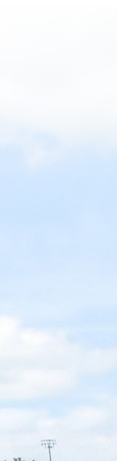
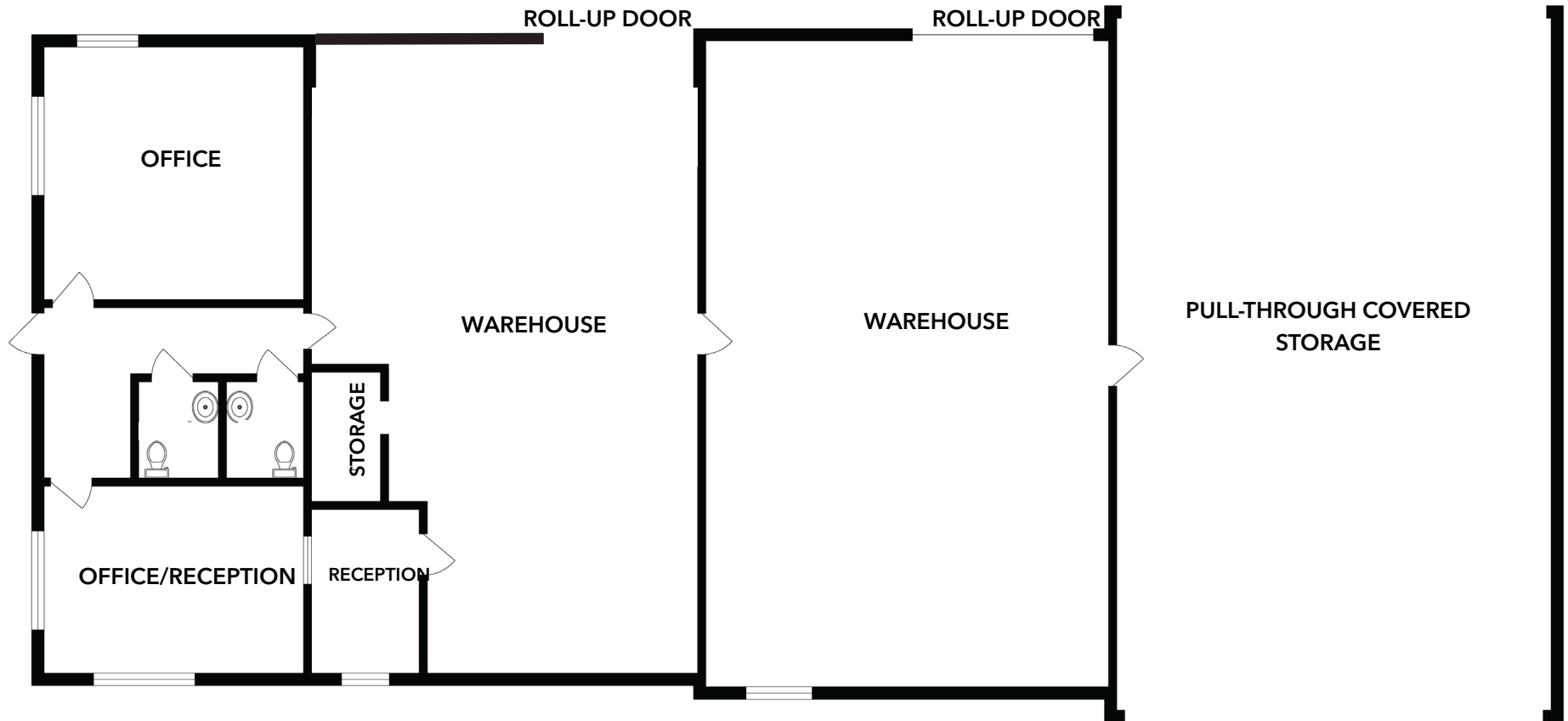

# FLOOR PLAN





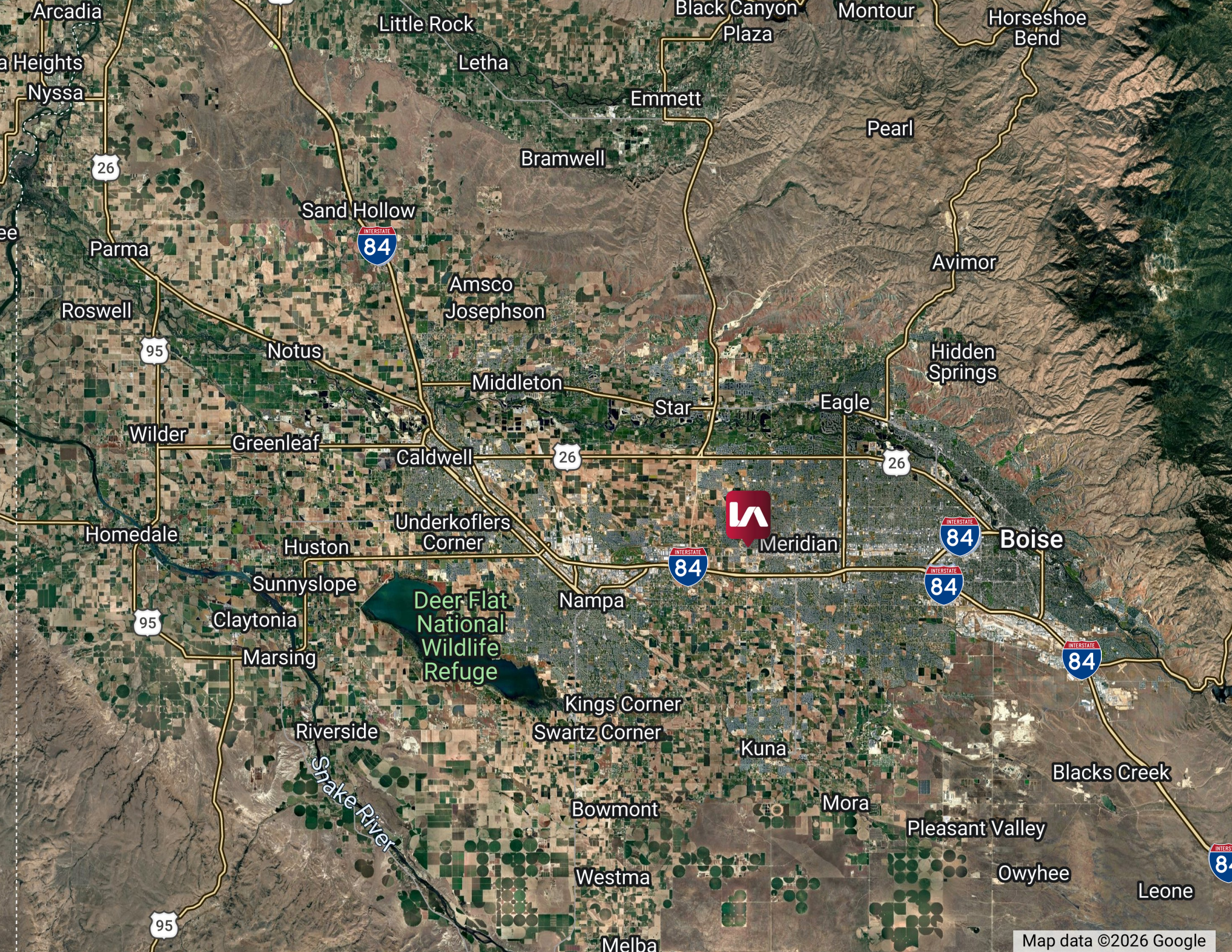

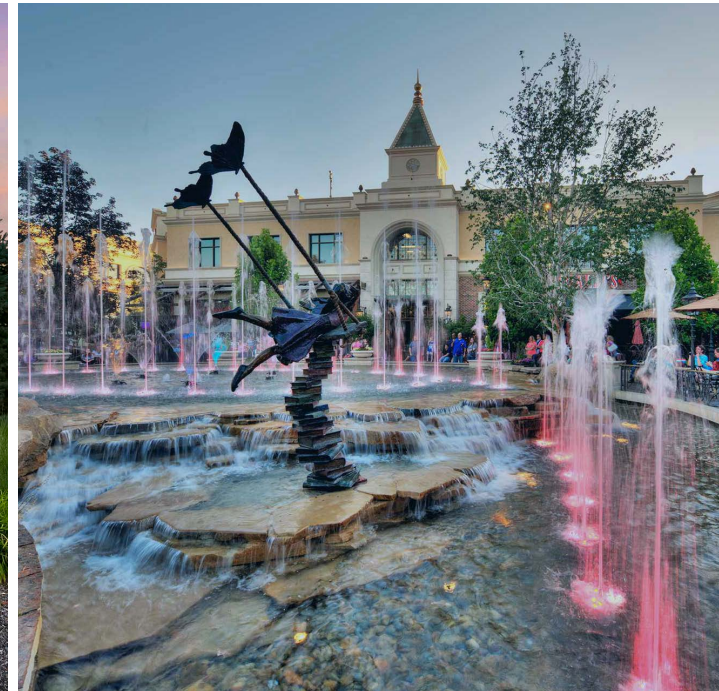
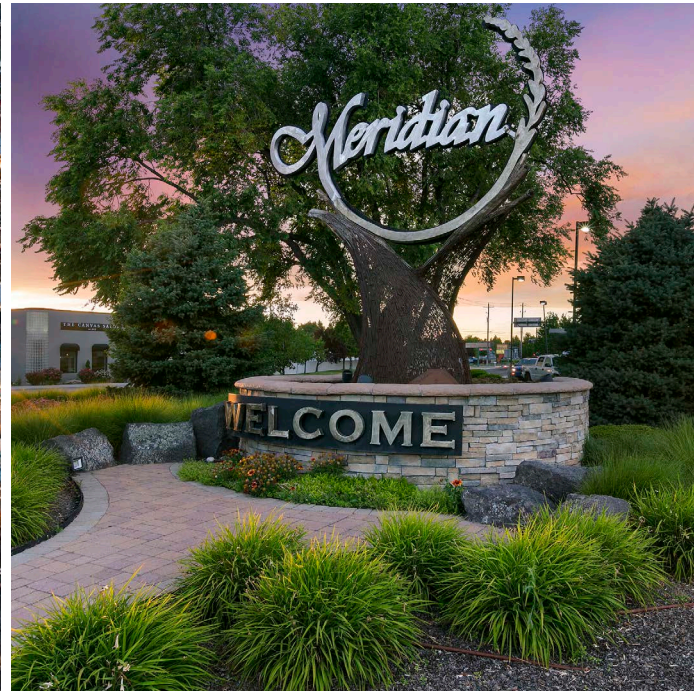


## AREA OVERVIEW

### **MERIDIAN, IDAHO**
