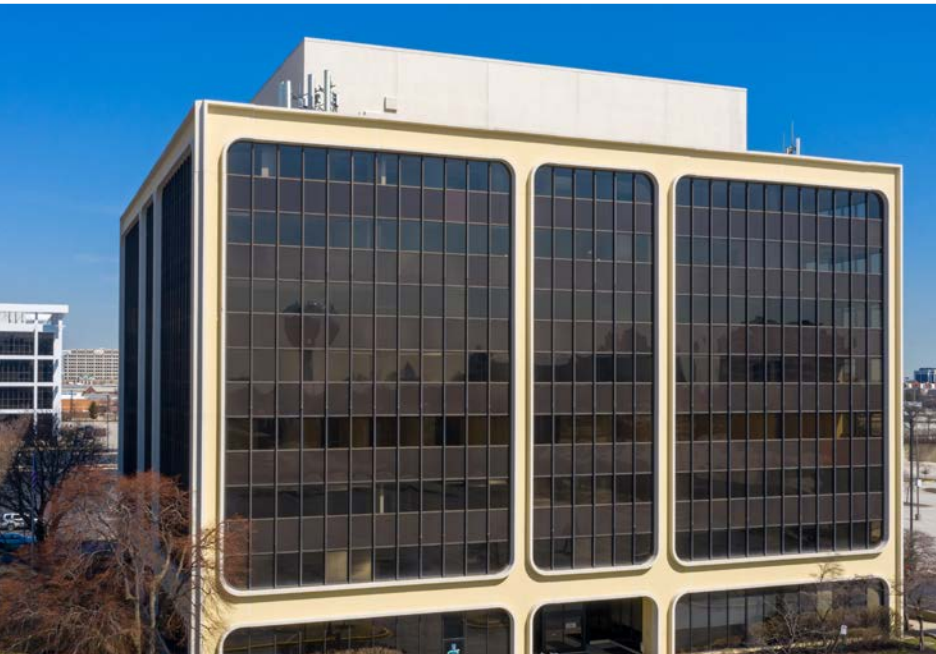

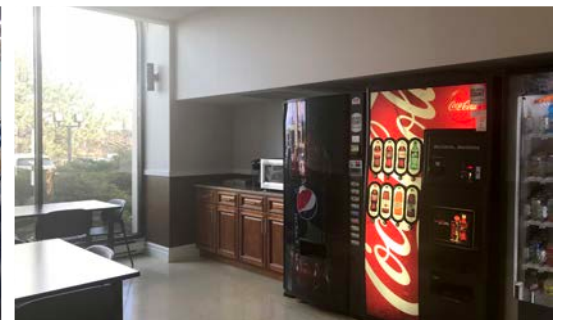

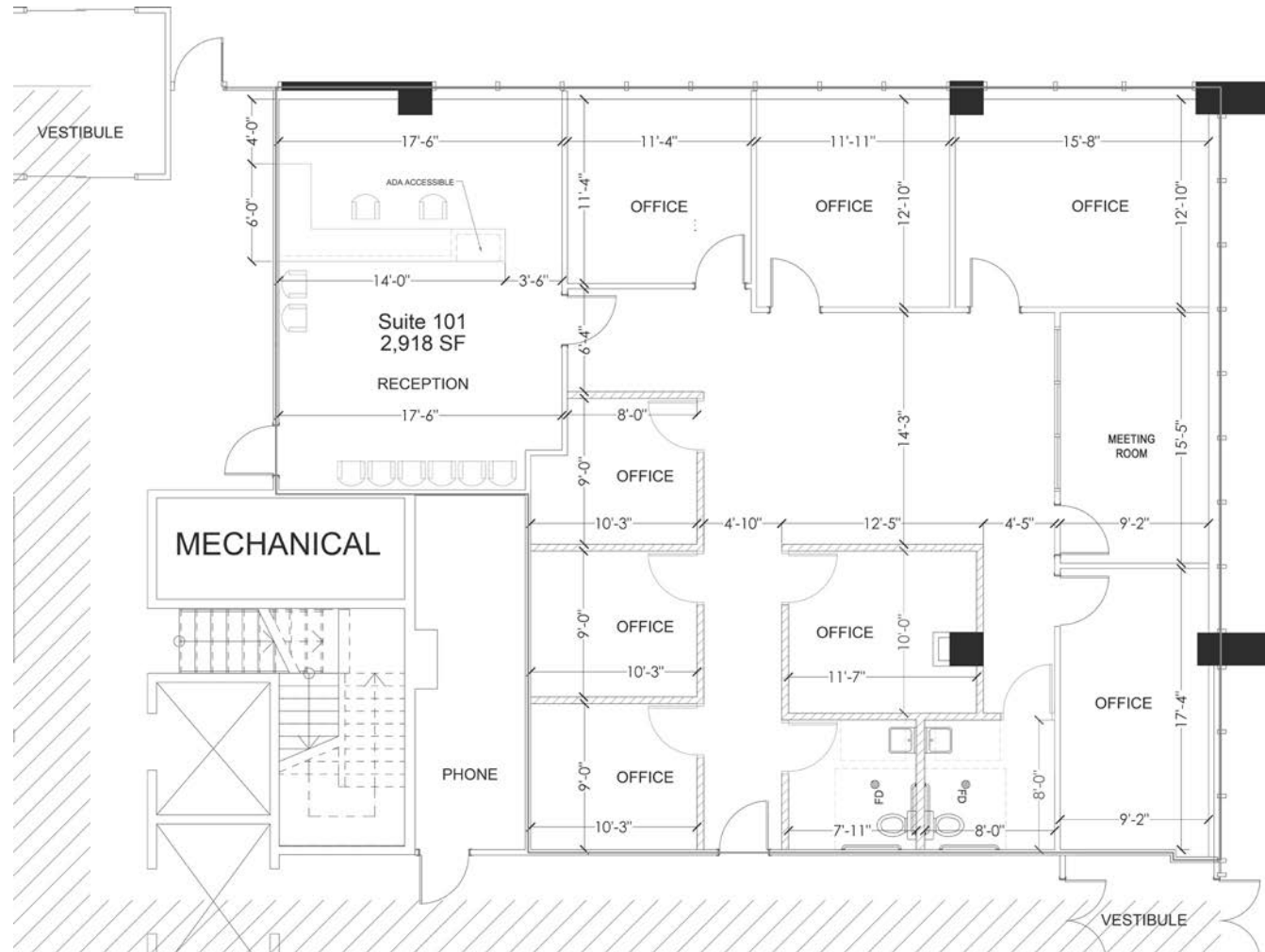
■ AT THE CENTER OF IT ALL

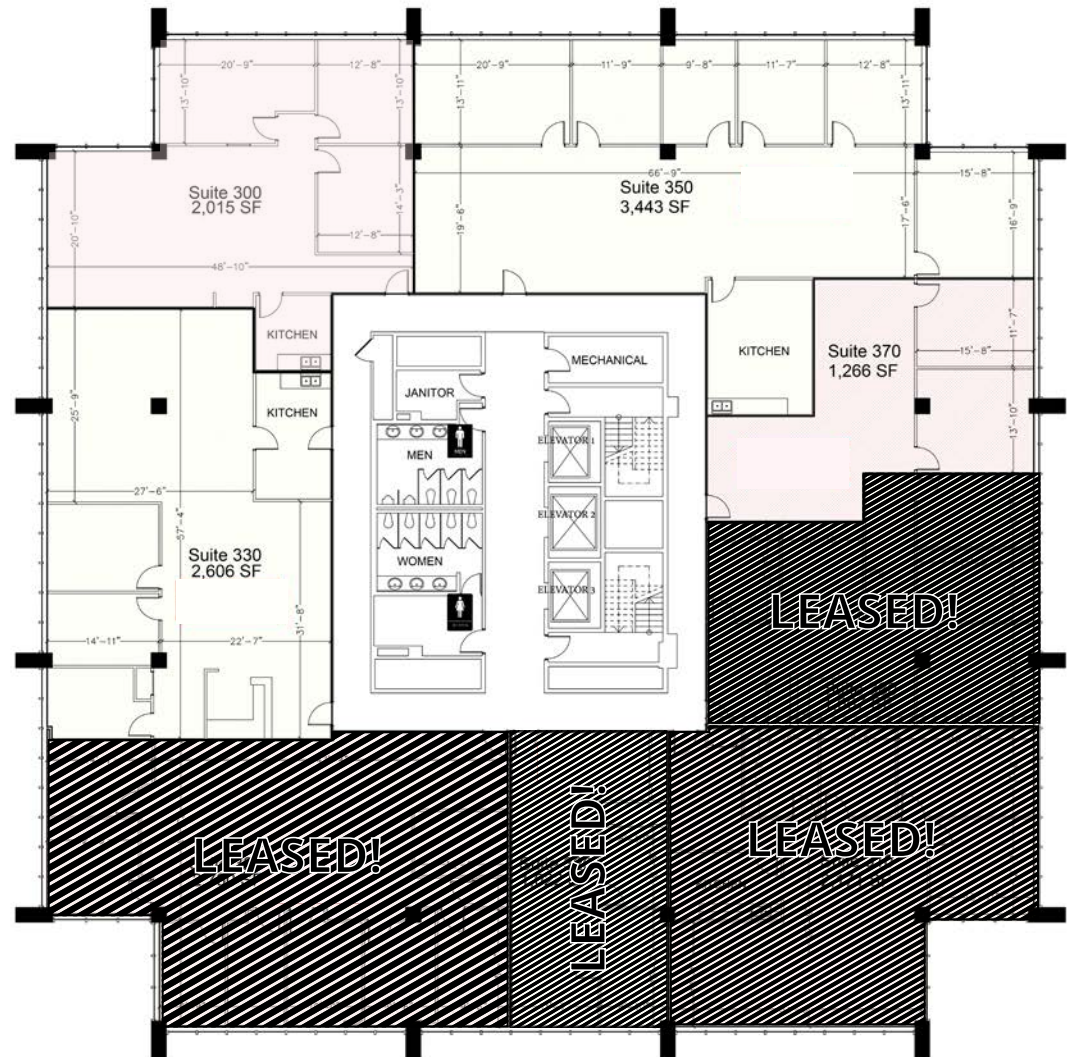

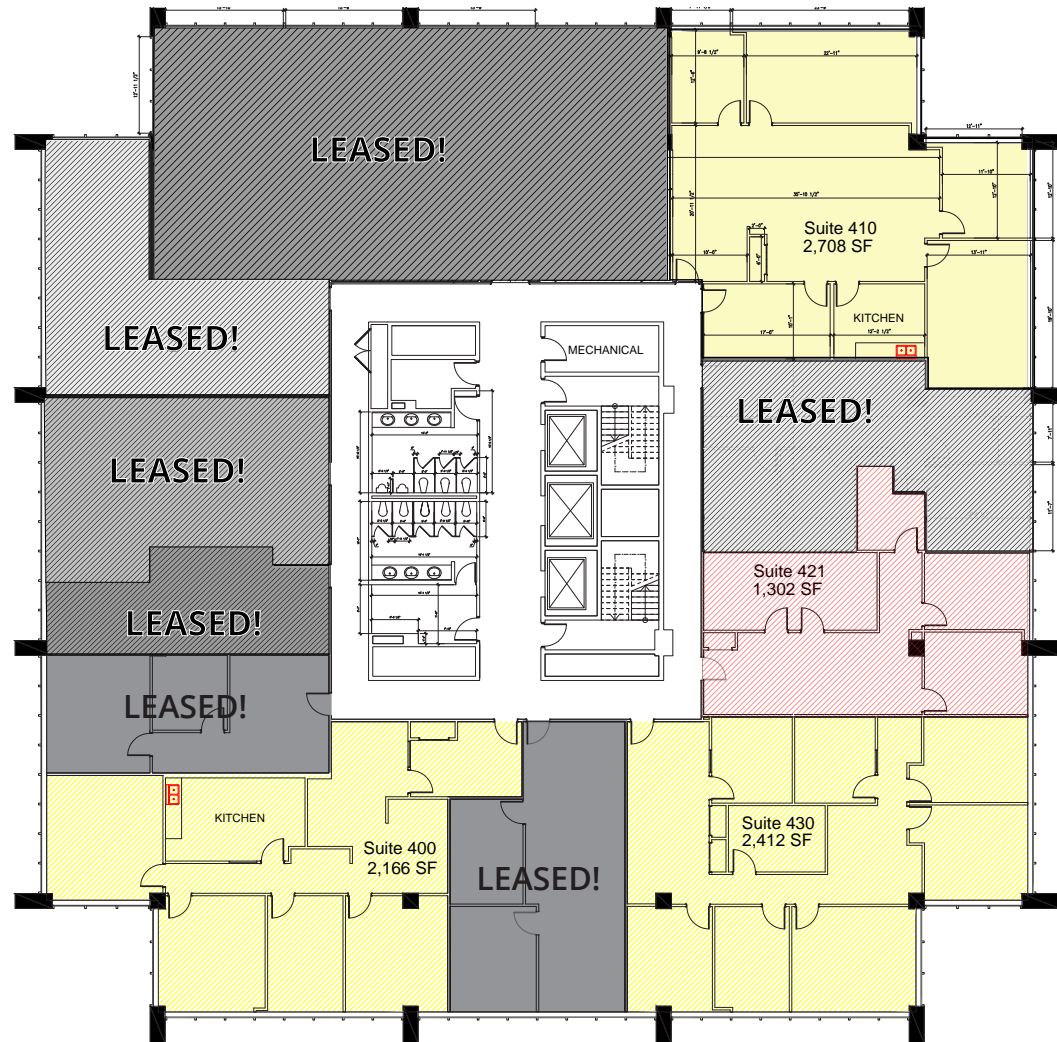

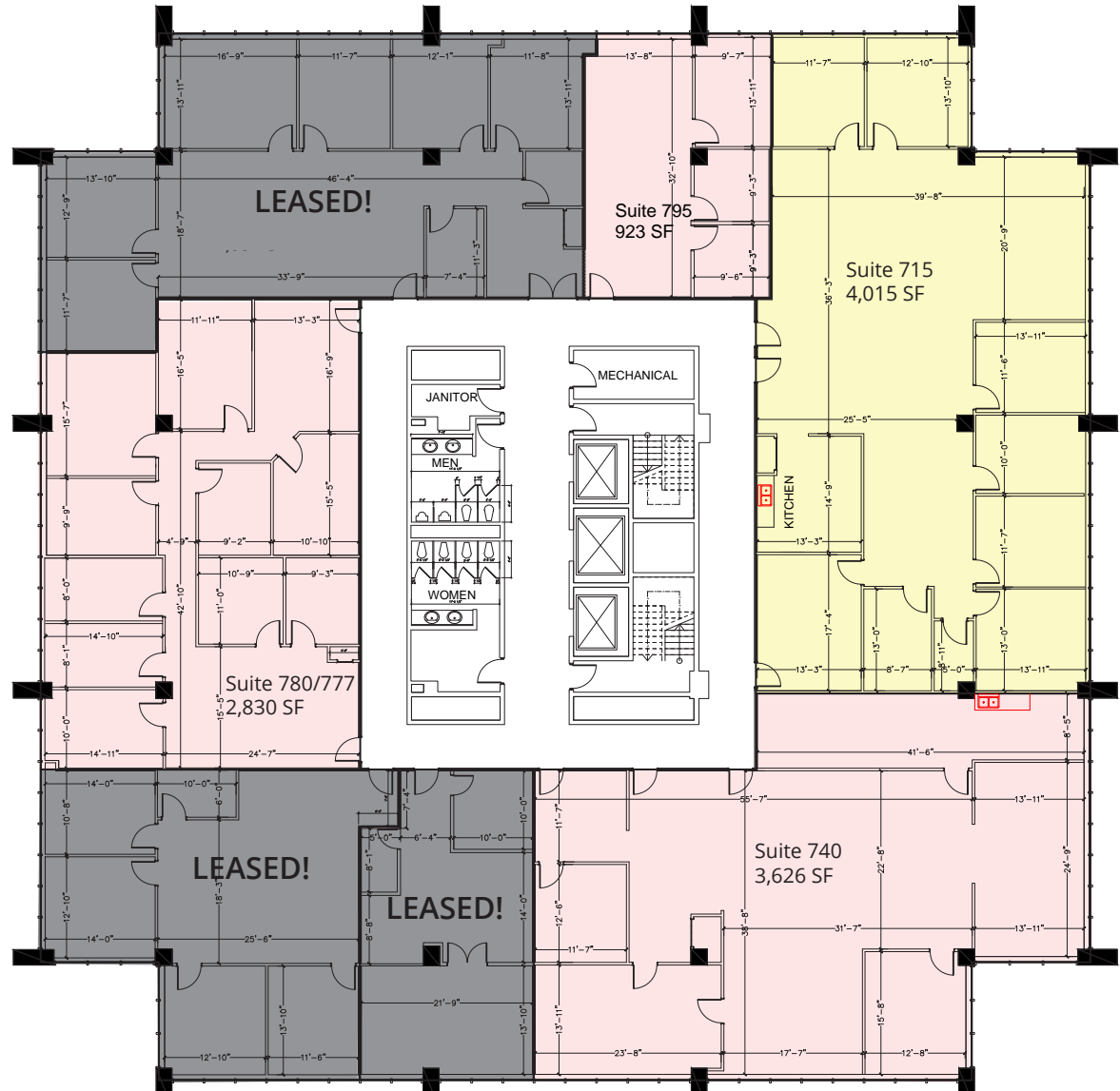

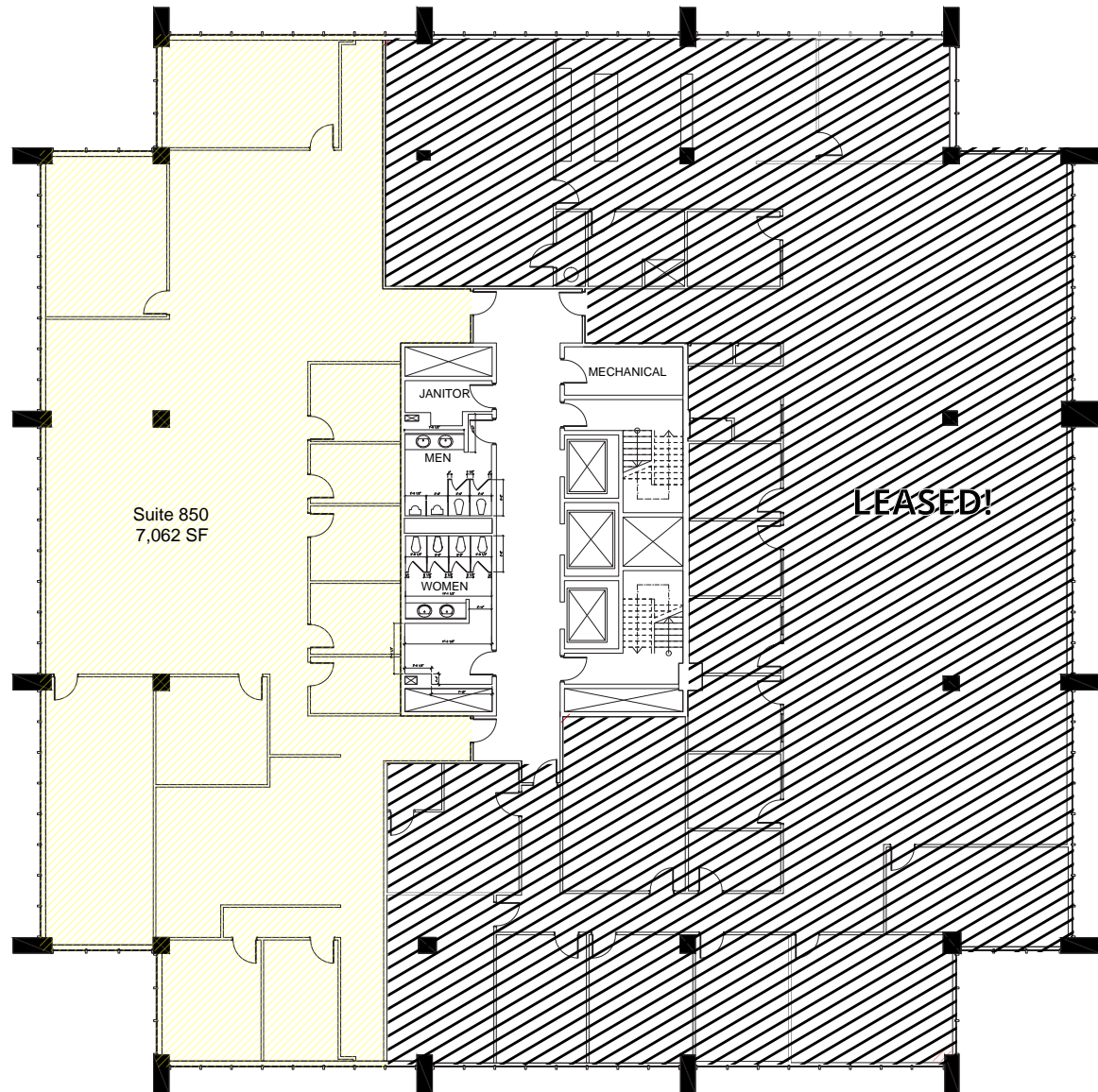

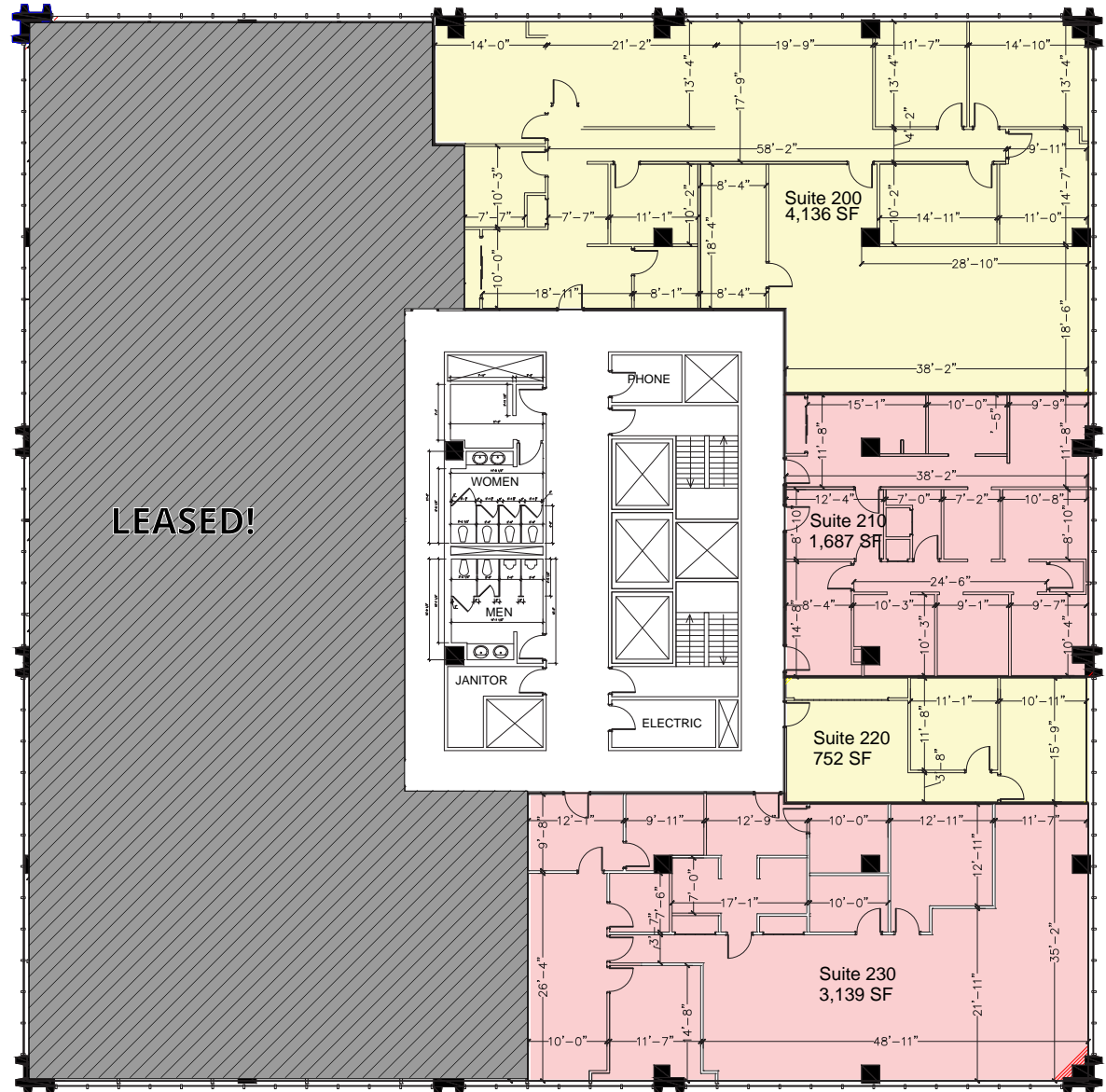

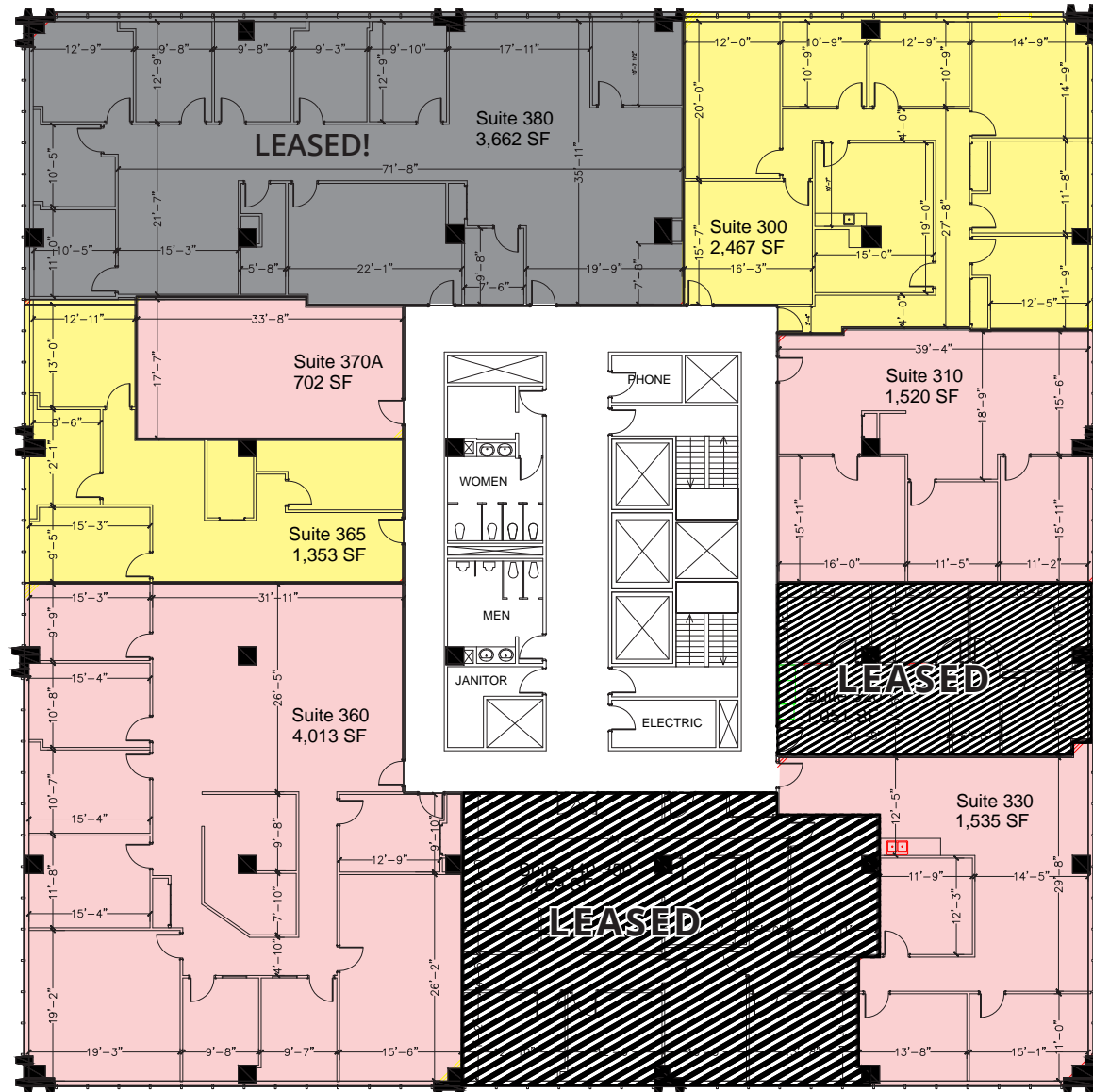

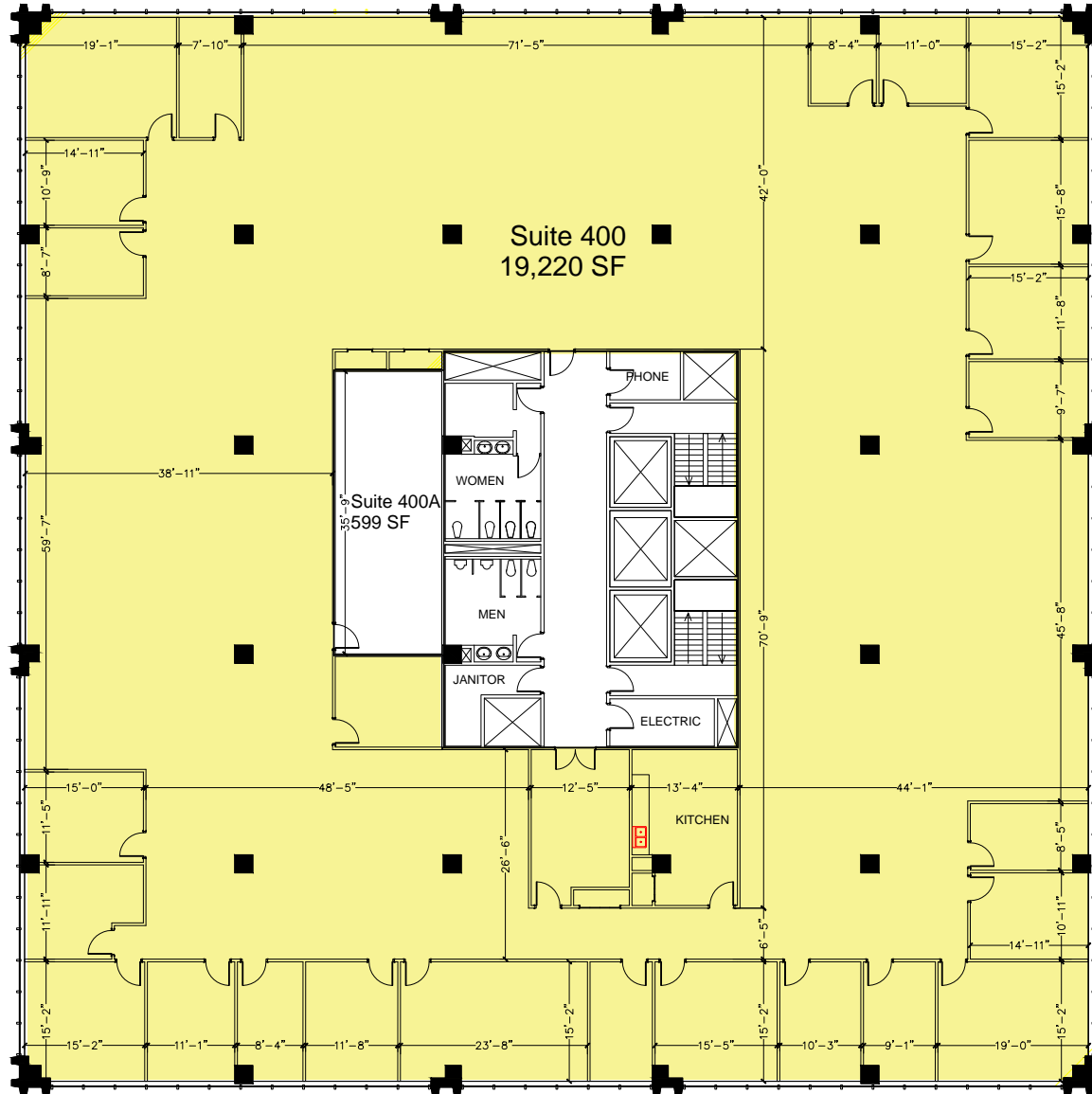

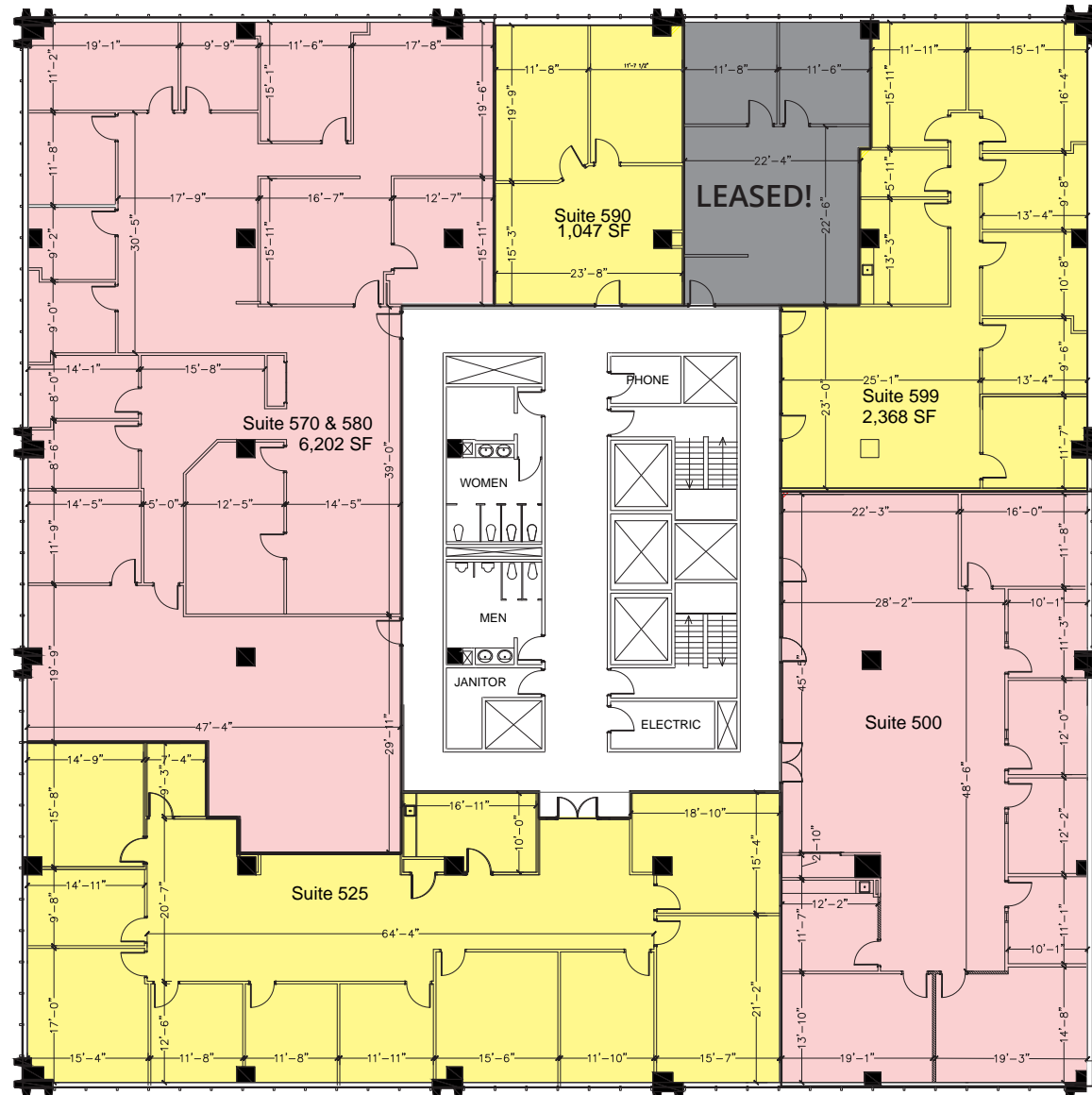

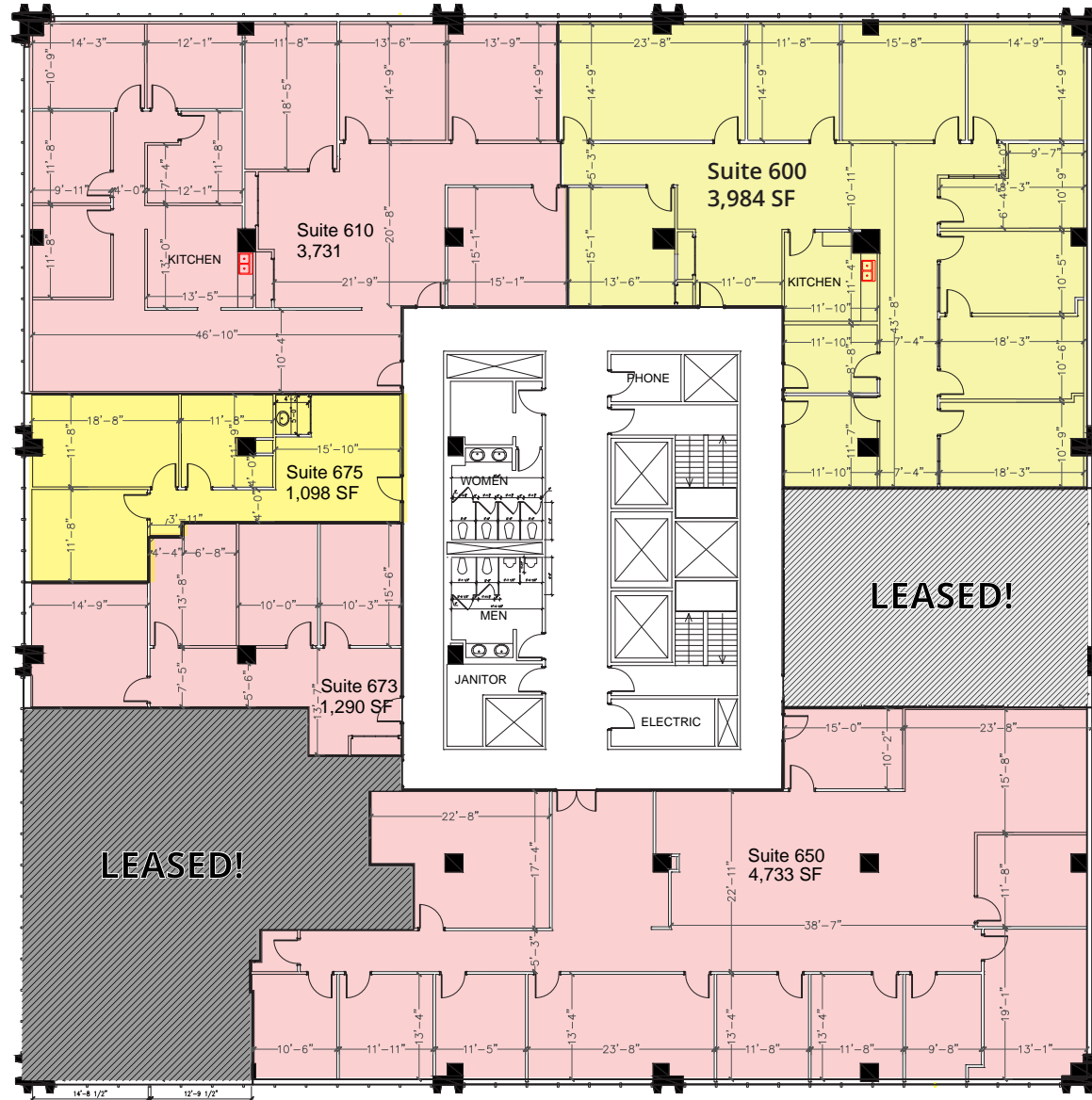

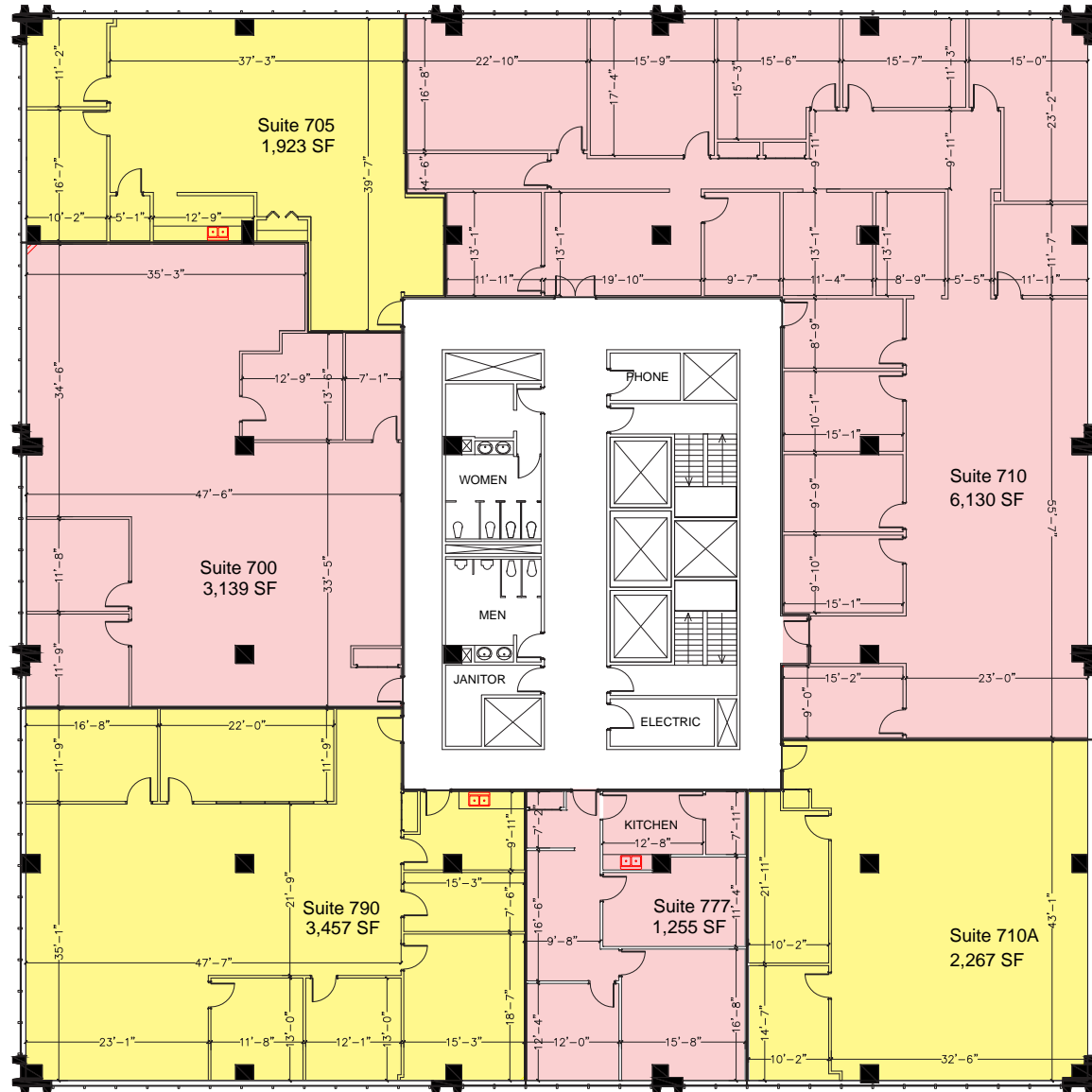

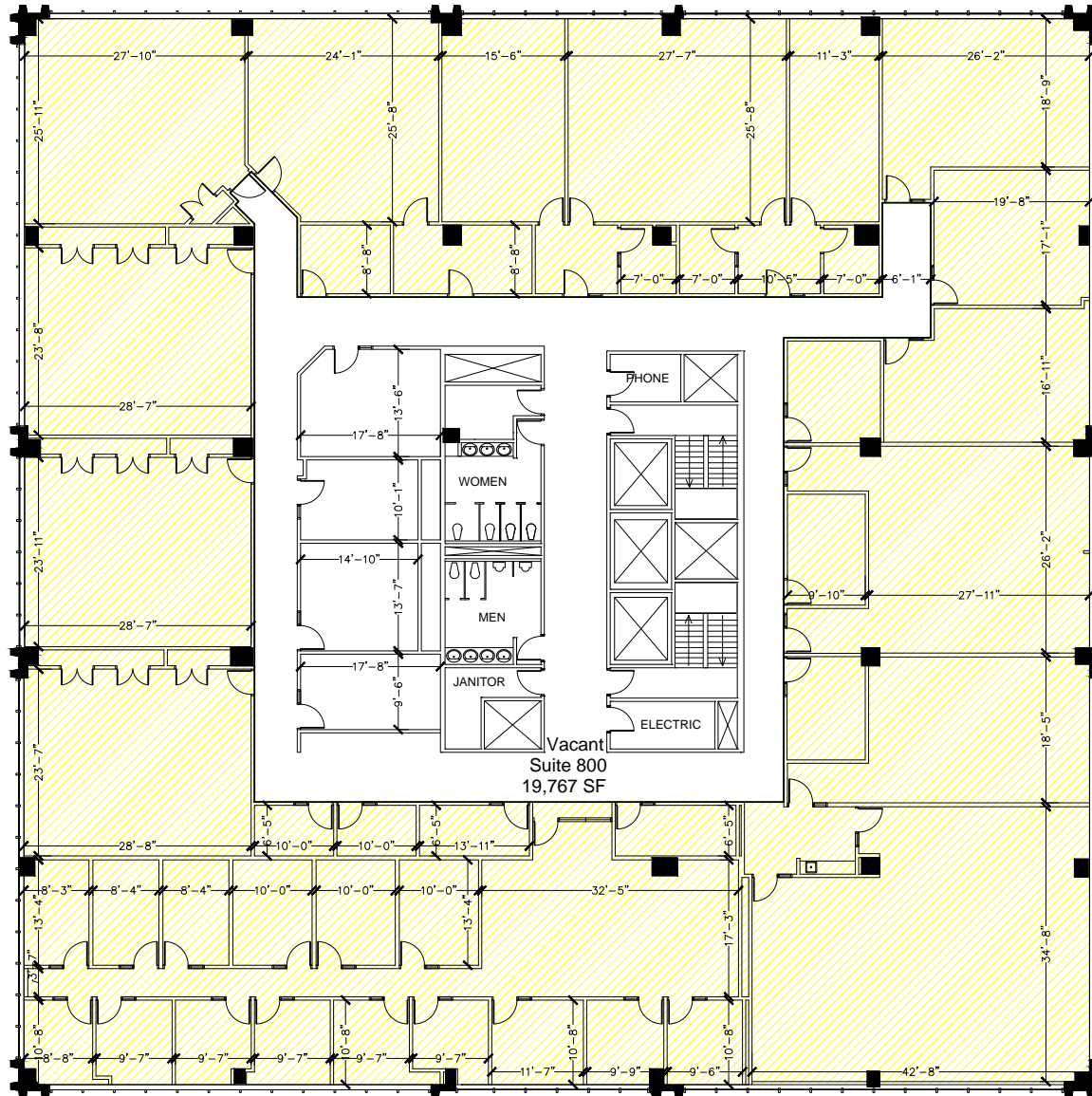
