



Location

The property is on Morgan Way, which forms part of the popular Bowthorpe Park Industrial Estate. The estate is conveniently located adjacent to the A1074 which connects with the A47 trunk road and is some 3 miles west of Norwich city centre.

Description

The property comprises an end-of-terrace light industrial/storage unit of concrete frame construction with brick and profile sheet cladding and a lined profile sheet roof. The unit has the following specification and features:

The Valuation Office Agency website indicates that as from April 2023 the Rateable Value is £15,500. This is not the annual rates payable.

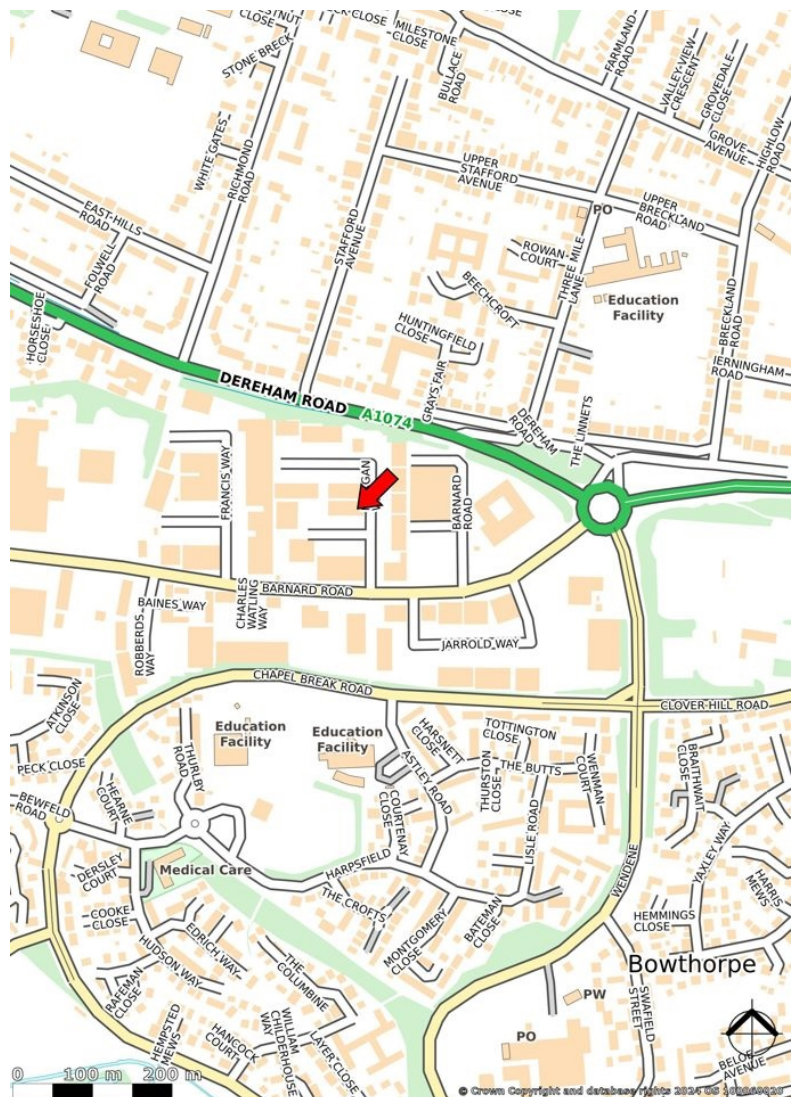
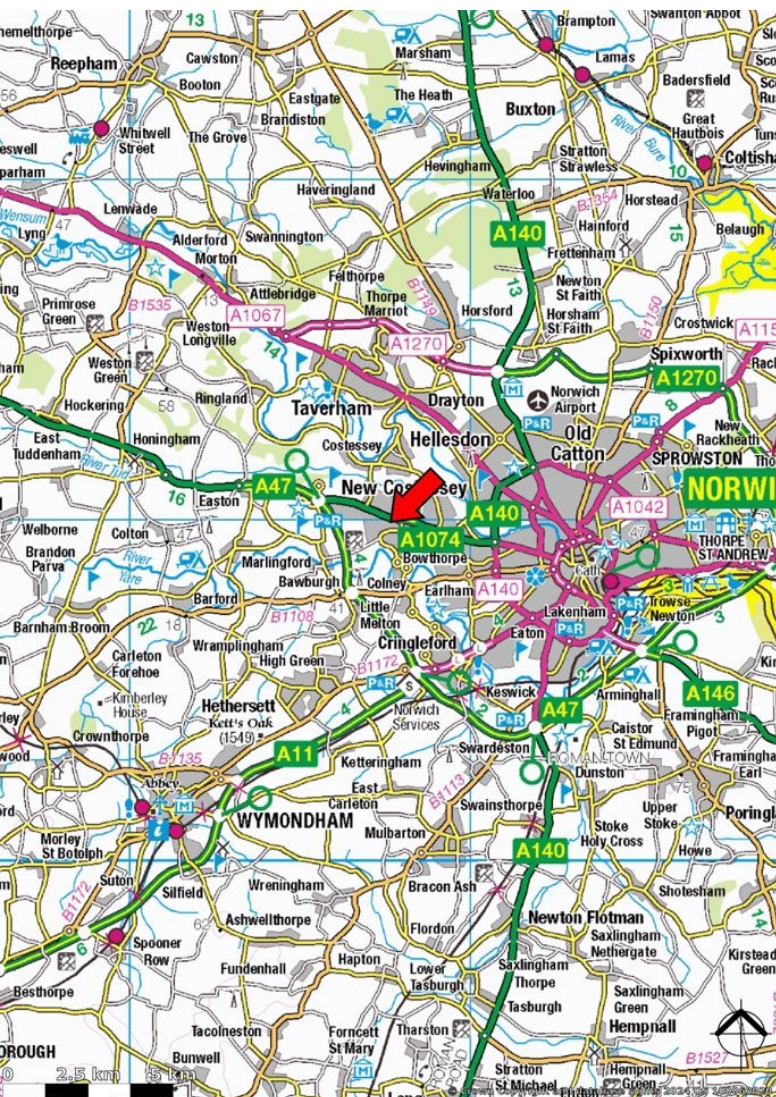
