The resort sits along the **Interstate 5 corridor near a major United States-Canada border** crossing. It features panoramic shoreline views and marina access within a **two-hour drive of both Seattle and Vancouver, British Columbia**. It uses **35,000 square feet of flexible indoor and outdoor event space** to attract high-paying corporate groups, capitalizing on a record-breaking \$775.9 million Whatcom County visitor economy.
