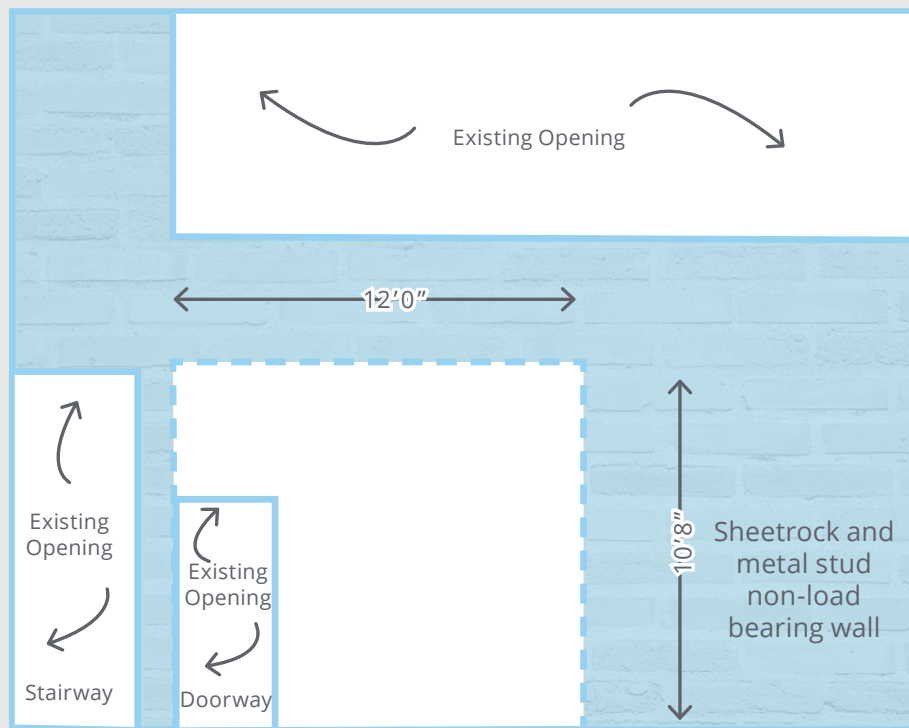

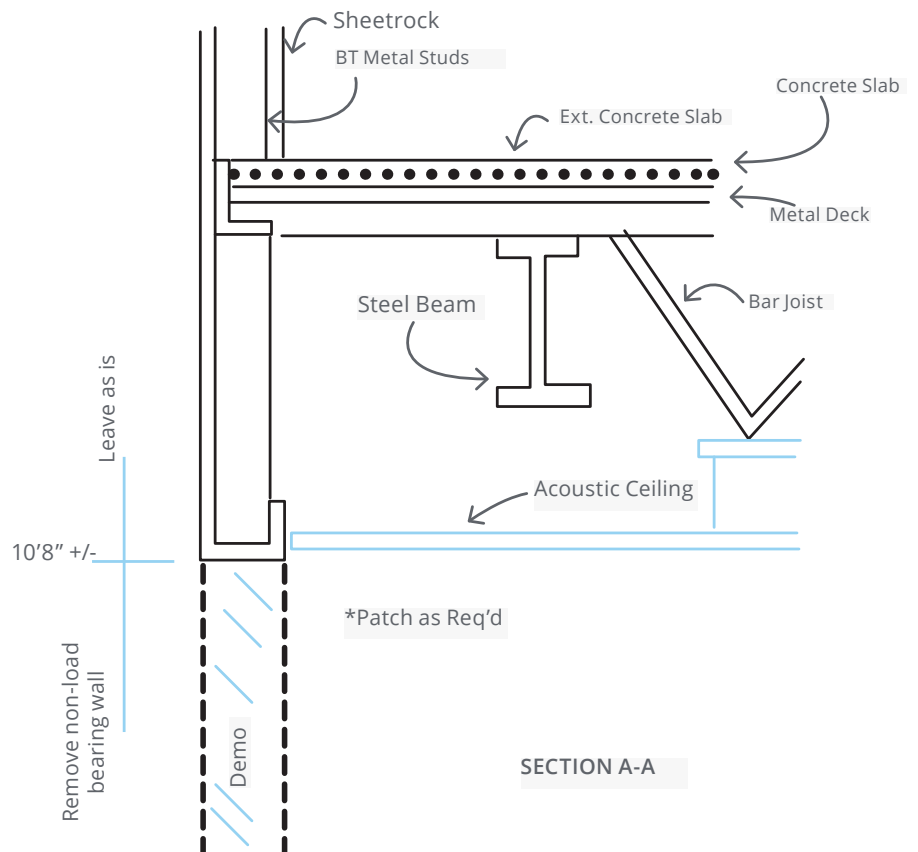
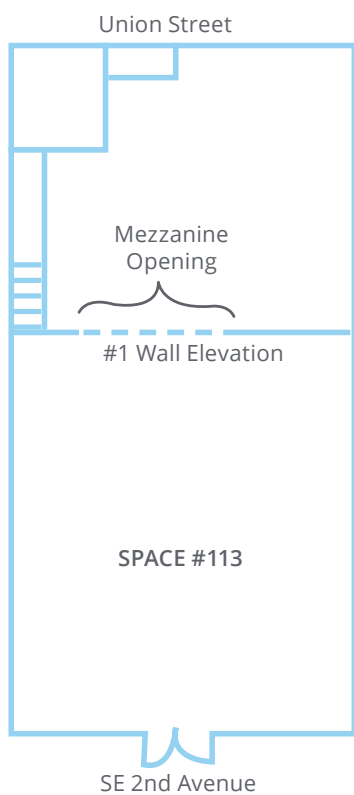


Floor Plan

Current Floor plan



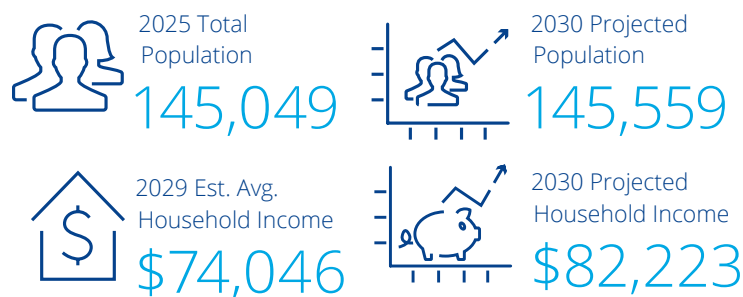
