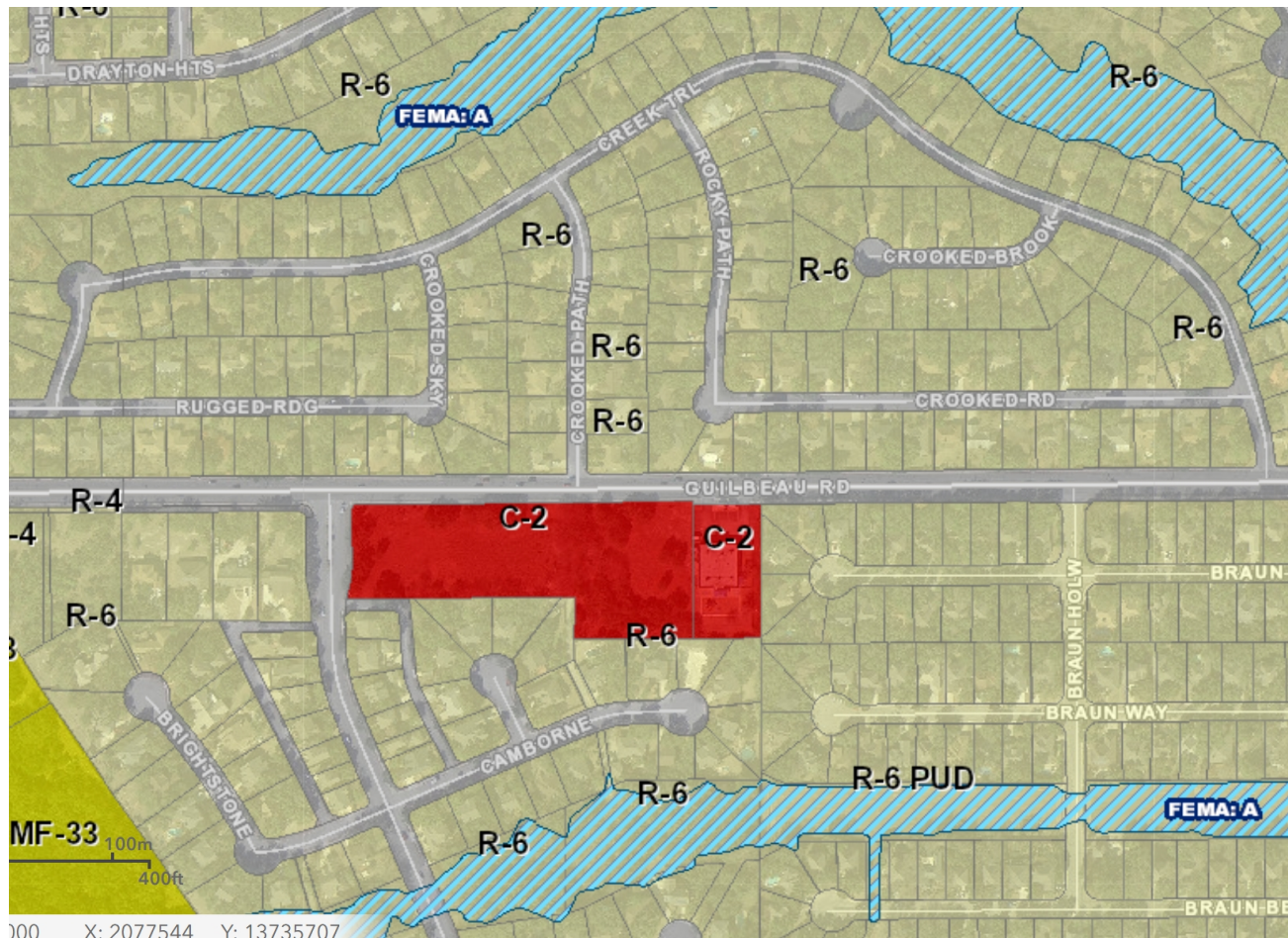

FLOOD & ZONING MAP

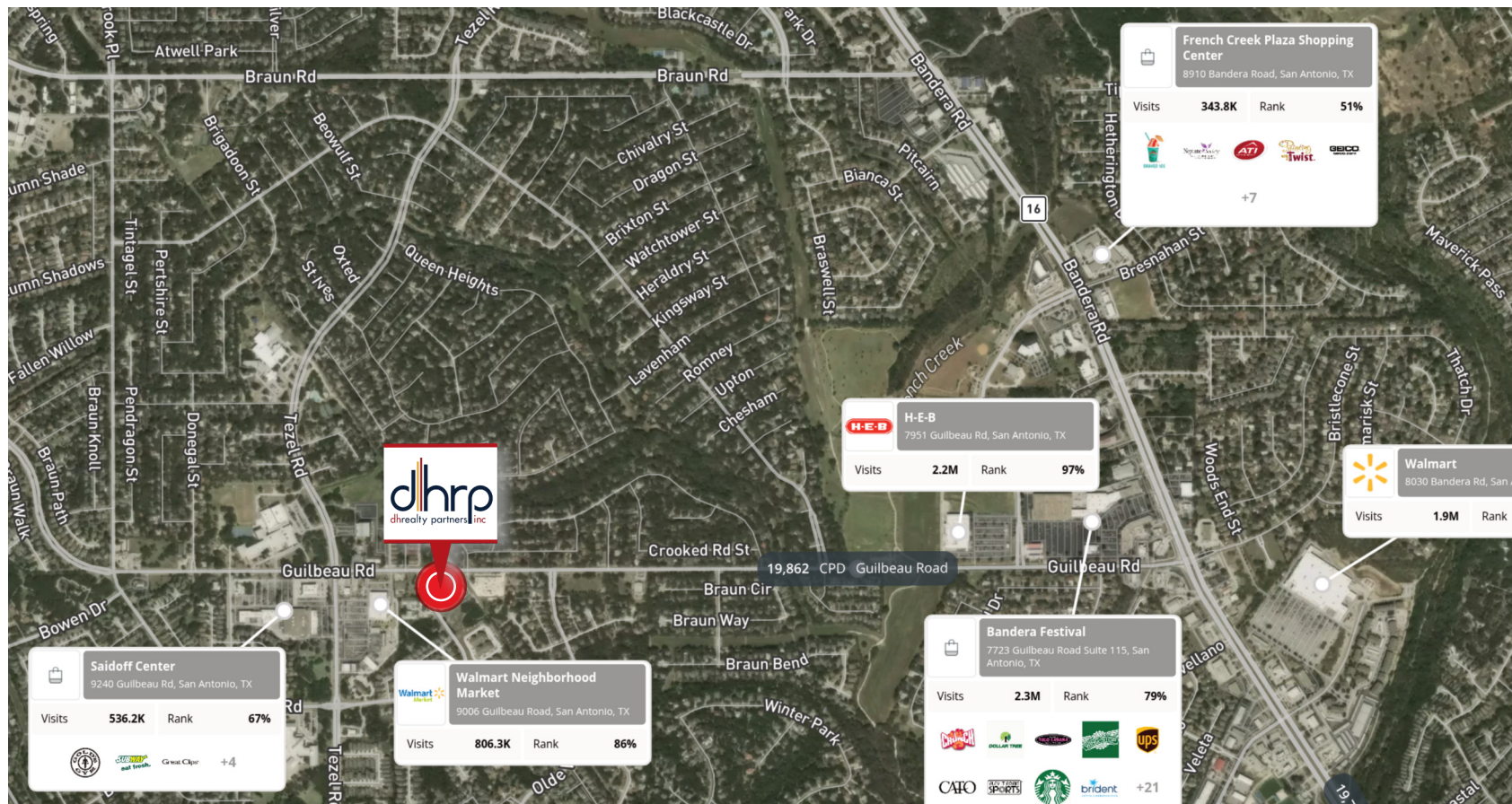

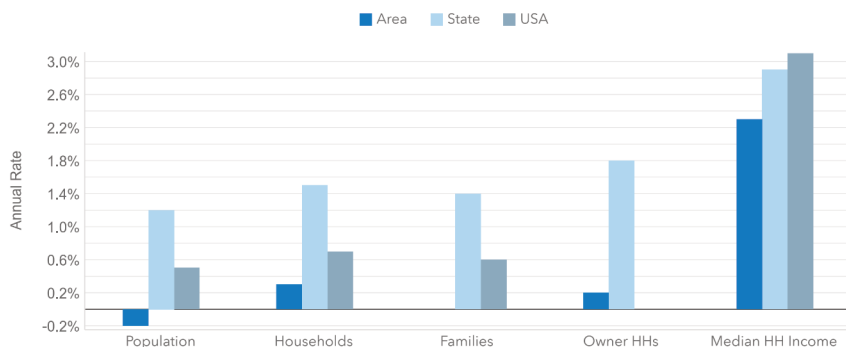

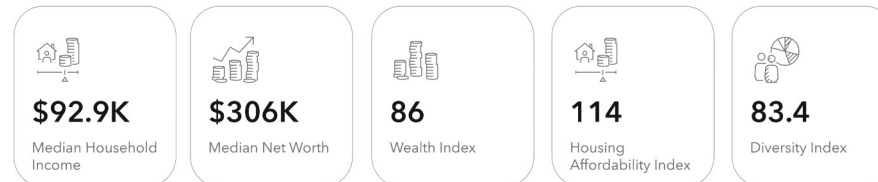

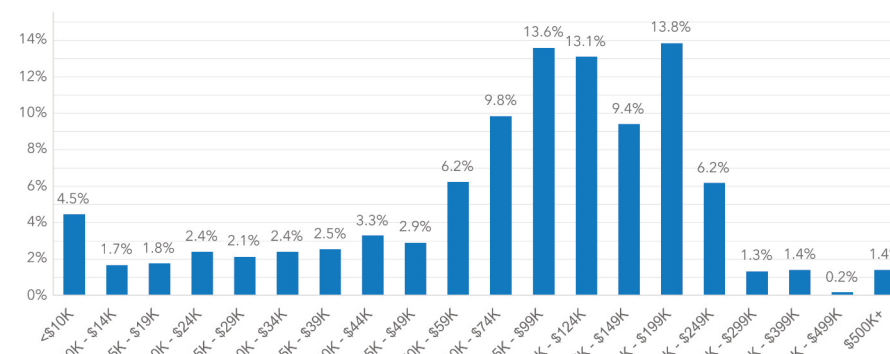

Households by Income for 2026



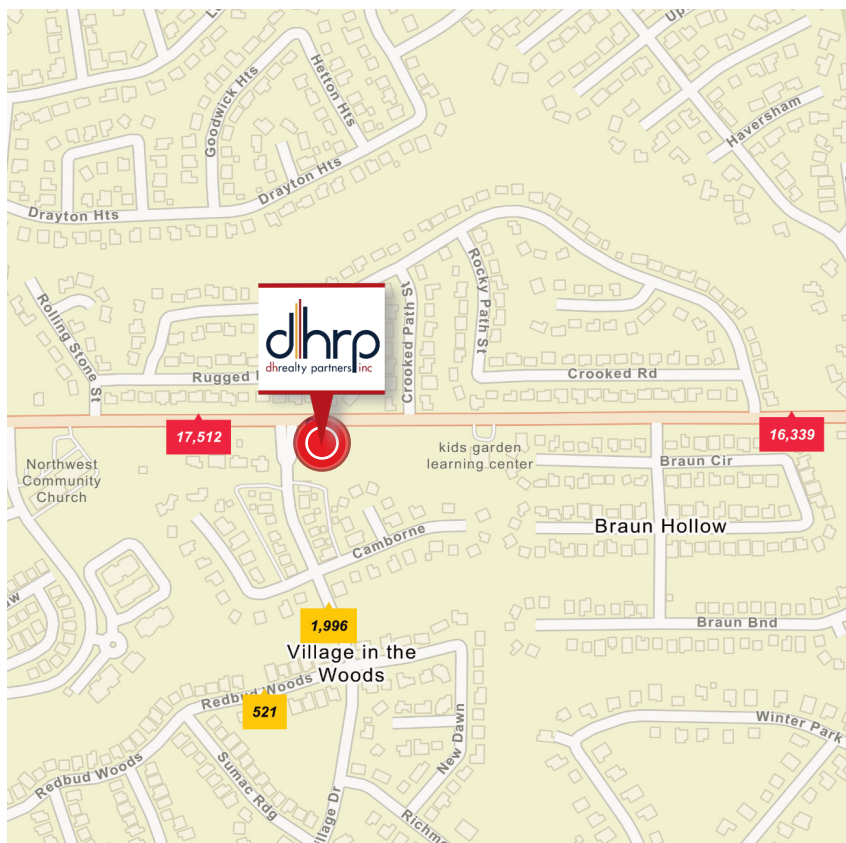
