Unit 8B Berrington Road comprises a semi-detached industrial/warehouse unit of steel portal frame construction with brick elevations under a pitched roof. The warehouse provides a minimum eaves height of 5.45 m, with a height to mezzanine of 3.16 m and is accessed via an electronically operated roller shutter door measuring 3.64 m wide by 4.29 m high.

The warehouse is lit with a mixture of fluorescent lighting and translucent roof panels, heated by hot air blowers with ladies and gents WCs.

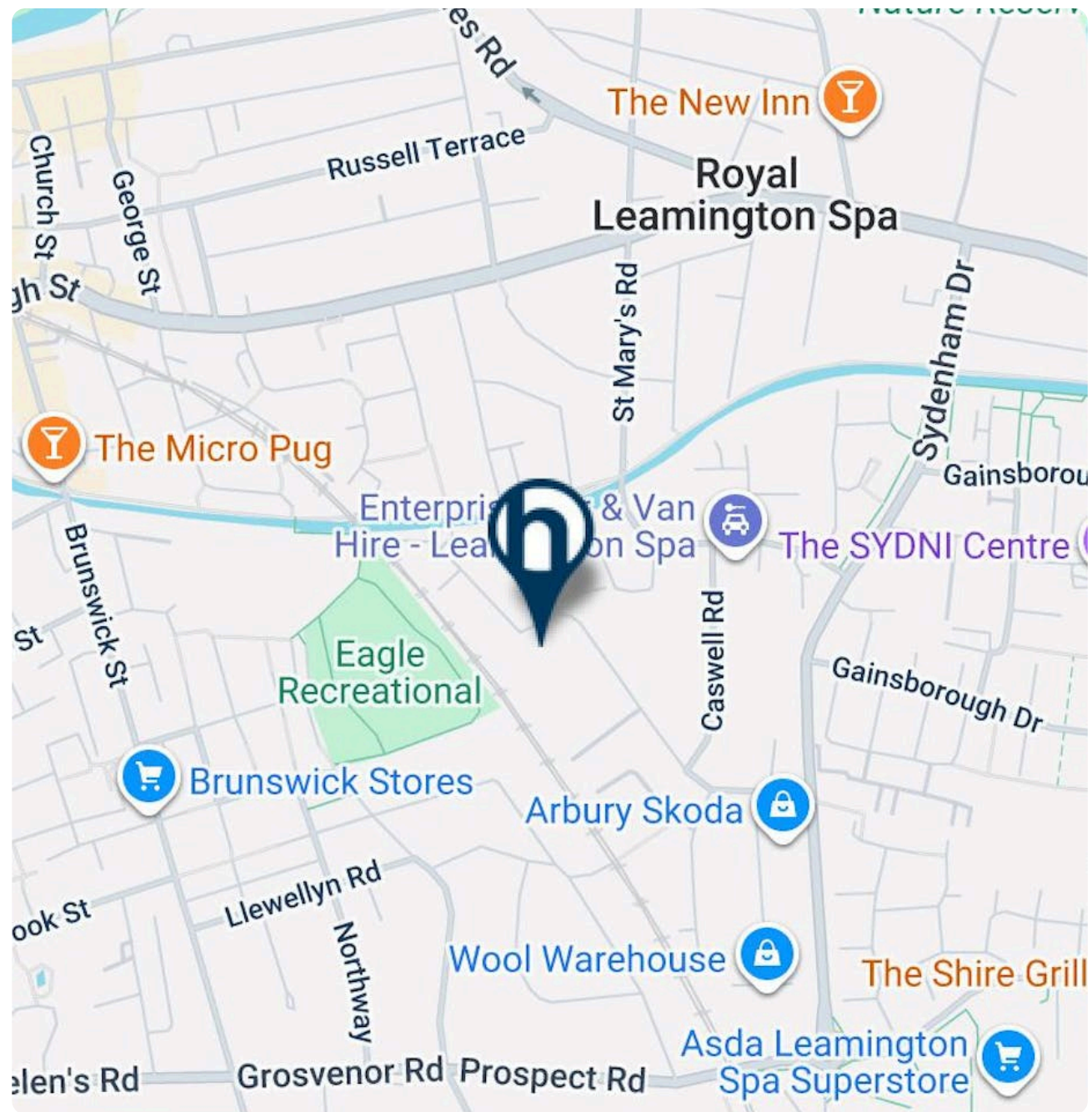
