Property Overview

An exceptional opportunity to develop housing on the last remaining vacant lot along Cambridge Road, directly backing up to Cameron Park Lake. This rare site offers the potential to create a residential community where occupants can enjoy serene lake views and peaceful surroundings right from their homes.

The property is zoned Multifamily Residential (RM), allowing for 5 to 24 dwelling units per acre—equating to approximately 3 to 12 residential units on this parcel. The zoning ordinance provides flexibility to pursue a parcel map or subdivision map to construct townhomes, condominiums, or detached homes. Other permitted uses include apartments, senior housing, and various rental housing developments.

Residents will enjoy direct gated access to Cameron Park Lake (with a pass from the Cameron Park Community Services District), offering a variety of recreational amenities including:

- Walking path surrounding the lake
- Tennis and pickleball courts
- Volleyball area and swimming lagoon with sandy beach
- Gazebo available for private events
- Restrooms, playground on the island, paddle boats, and more

WHAT *CAMERON* *PARK* HAS TO OFFER

Cameron Park is a vibrant community offering a well-rounded lifestyle. Local amenities include a public library, community center with gymnasium, swimming pool, meeting rooms, and programs for all ages. Families will appreciate access to area schools, including elementary, middle, and high school options all within approximately 3.9 miles of the property.

Recreation enthusiasts can join the Cameron Park Country Club, featuring an 18-hole golf course and private memberships, or utilize the local airport that serves small aircraft.

The Cameron Park Community Services District and Fire Department host the annual Summer Spectacular, a popular Fourth of July celebration featuring fireworks over the lake—visible right from homes on the property. Residents can also enjoy other community traditions, including the annual Easter Egg Hunt, adding to the neighborhood's appeal year-round.

Cameron Park was originally founded in the 1960s by Larry Cameron. In its early years, subdivisions of vacant lots were created and sold to individual buyers. Over the past six decades, homes have been built on these lots, resulting in a charming mix of new and older residences that gives Cameron Park its distinct character and enduring appeal.

As the community grew, tract home developments were later introduced by builders to meet the increasing demand for housing in the area. Today, Cameron Park features a diverse blend of residential neighborhoods, along with commercial shopping centers, medical facilities, offices, and laboratories, making it a well-balanced and thriving community.

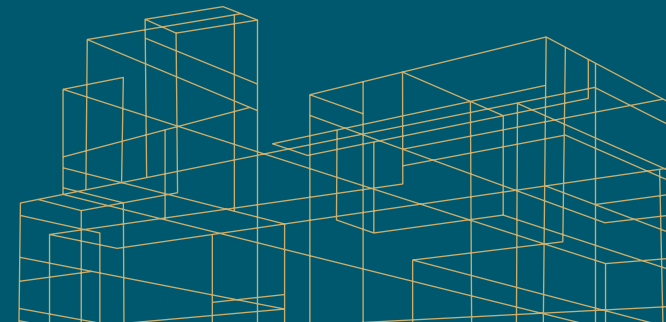
