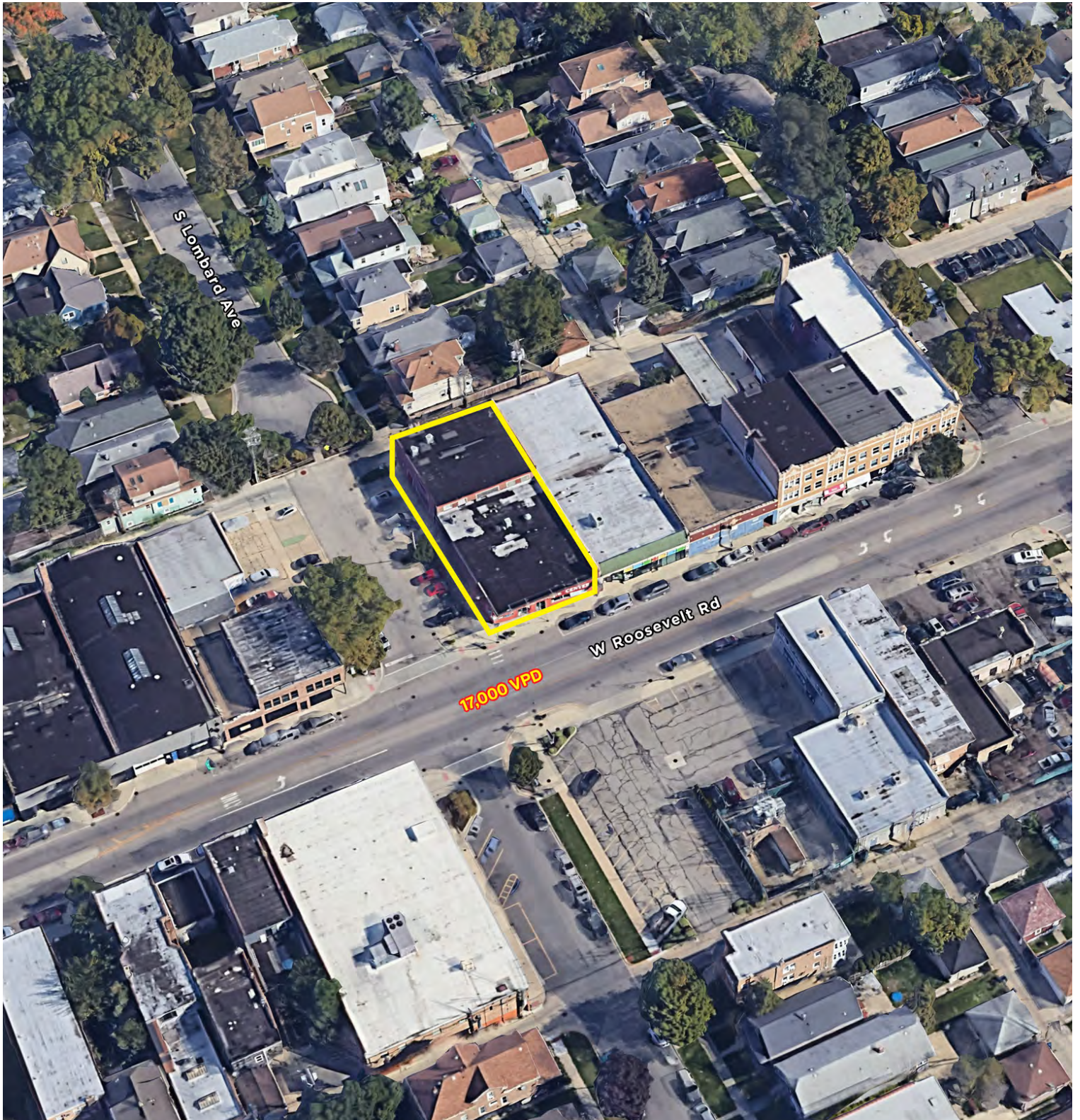

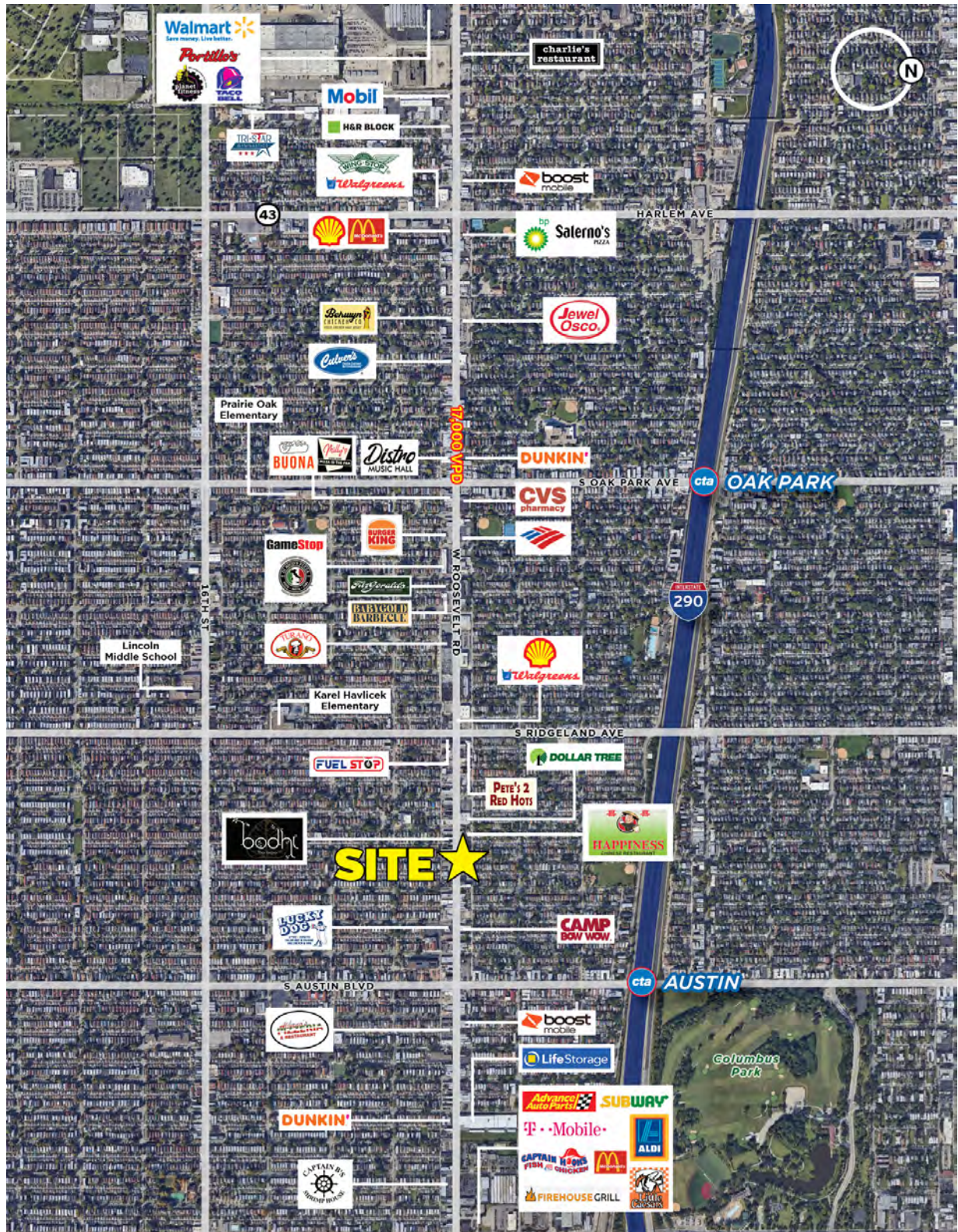

AREA RETAIL



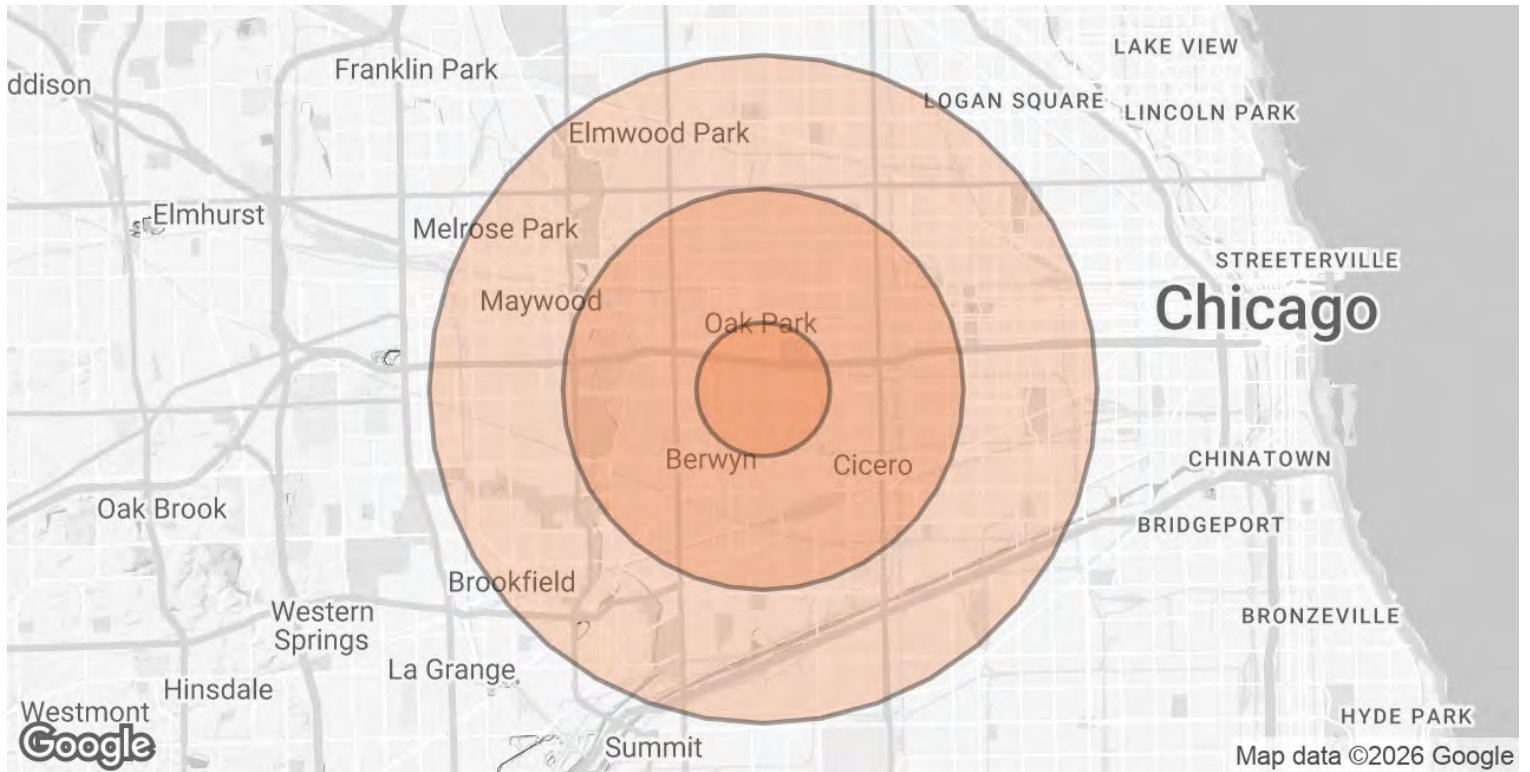
