

SHELL BUILDING

- ▶ Single-level Concrete Tilt Building
- ▶ Use: Office/Storage/Manufacturing
- ▶ Occupancy: B/ S-1/ F-1/ F-2
- ▶ Construction Type: IIB
- ▶ 4000 PSF slab on grade
- ▶ 100% HVAC
- ▶ Skylights & Clerestory
- ▶ ±1.66 AC Yard Area

SF & DIMENSIONS

- ▶ ±151,563 SF, including ±3,335 SF Office
- ▶ ±32' Clear height
- ▶ 7" concrete on 4" ABC unreinforced, vapor barrier at front 25%
- ▶ Roof: Class A TPO on panelized wood roof deck (steel joists/girders)
- ▶ R-30 batt insulation with white scrim sheet below deck
- ▶ Tilt wall construction 9" thick
- ▶ Interior column spacing 56' x 60'
- ▶ (6) 12' w X 14' h overhead doors at grade (expandable to 14' x 16')
- ▶ (31) 9' w X 10' h overhead doors at dock height (6 w/levelers)
- ▶ Storefront entry glazing and clerestory windows at sides/rear
- ▶ 1" Insulated PPG Solarcool Pacifica, clear anodized aluminum frame
- ▶ (8) 3' x 8' storefront entry doors
- ▶ (2) Outdoor Amenity Areas

- ▶ SES 3000A 277/480 3 Phs Nema 3R rated
- ▶ Meter section w/2 ea: 800A and 3 ea future 400A
- ▶ Electrical service is expandable up to 3000A 277/480 additional
- ▶ (4) Level 2 ChargePoint 2-port EV charging stations
- ▶ Telco (2 ea) 4" conduits to building adjacent to SES

PARKING

- ▶ ±326 vehicle parking spaces

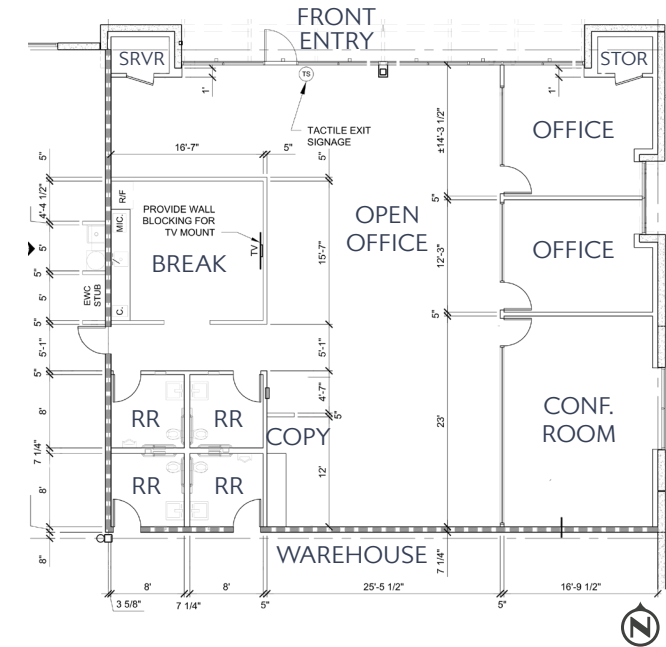
- ▶ ±3,335 SF spec suite with premium finishes
- ▶ (2) private offices
- ▶ (1) conference room
- ▶ Open office seating area
- ▶ Breakroom
- ▶ Multiple restrooms to serve office | separate restrooms for warehouse

FIRE SPRINKLERS

- ▶ Fire Protection: ESFR for high pile storage of Class IV non-encapsulated commodities
- ▶ Per NFPA 13/City of Phoenix Amended

- ▶ 2" domestic water meter with 4" line to building
- ▶ 6" sewer main to building
- ▶ Gas: none
