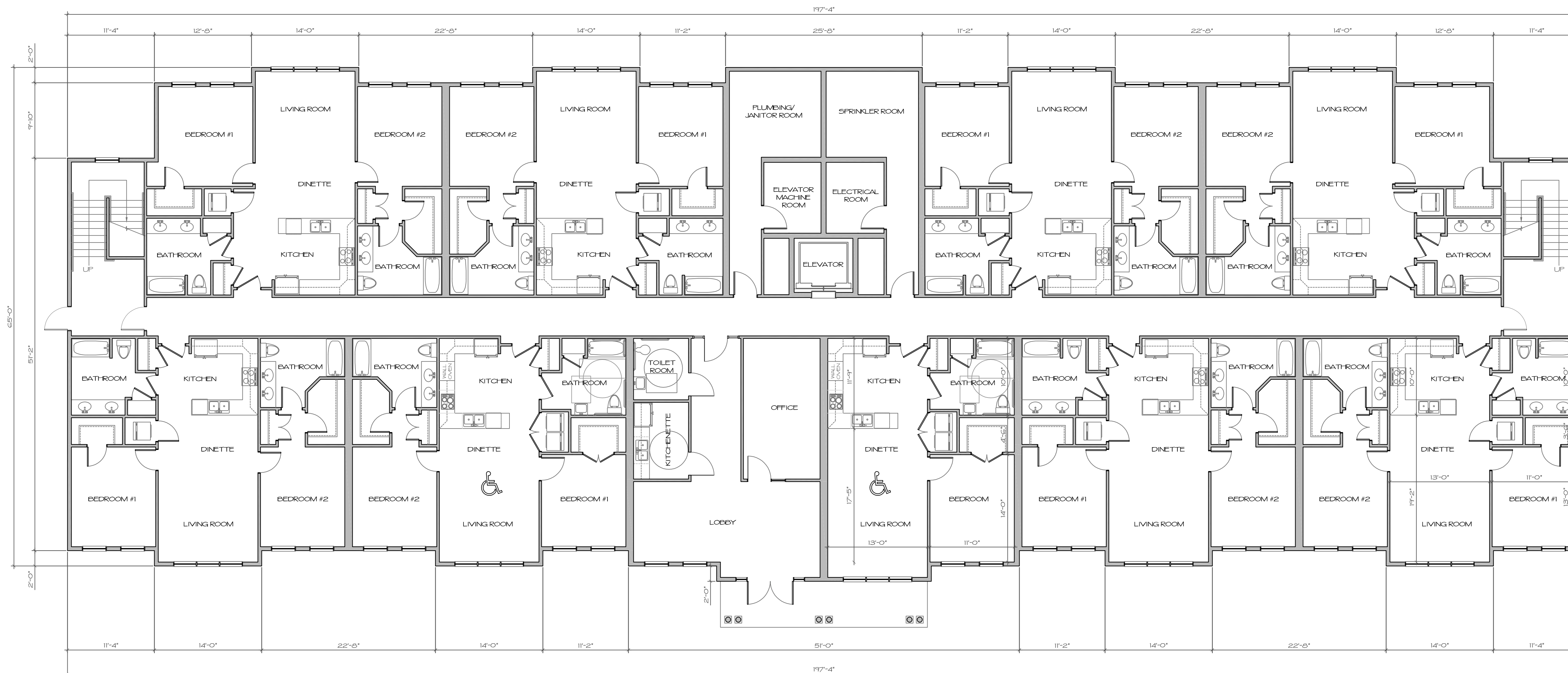

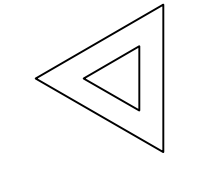


FIRST FLOOR PLAN - BUILDING No. 2

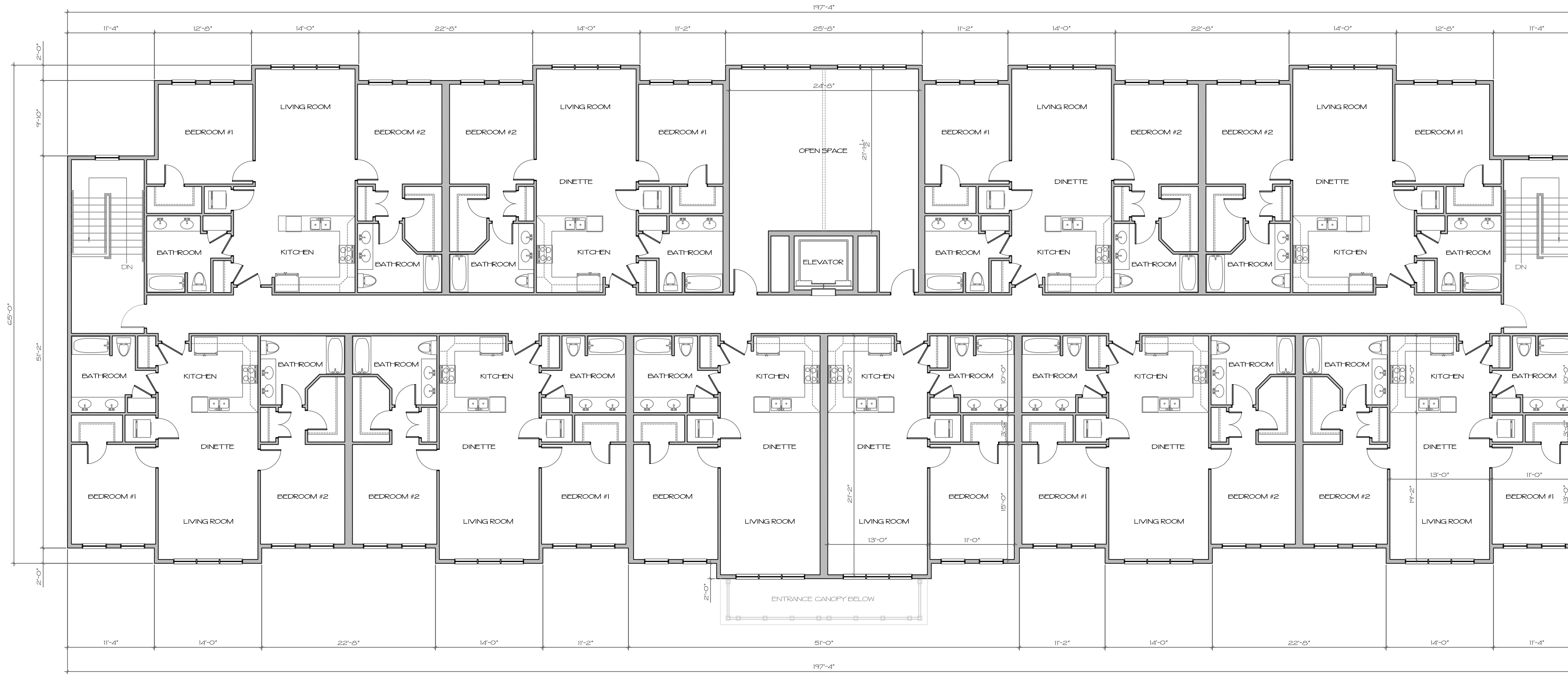

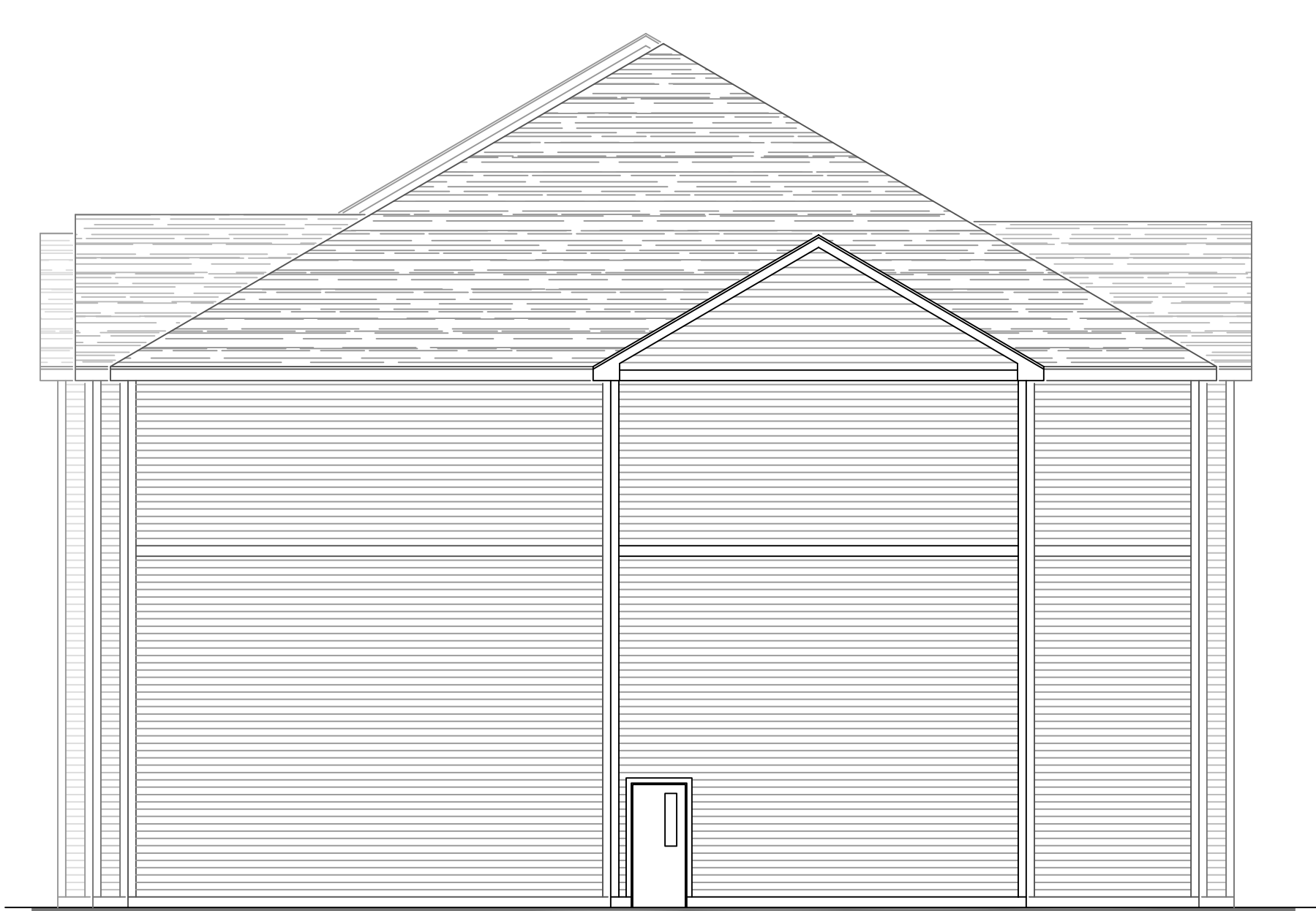
FRONT ELEVATION - BUILDING No. 1 # 3

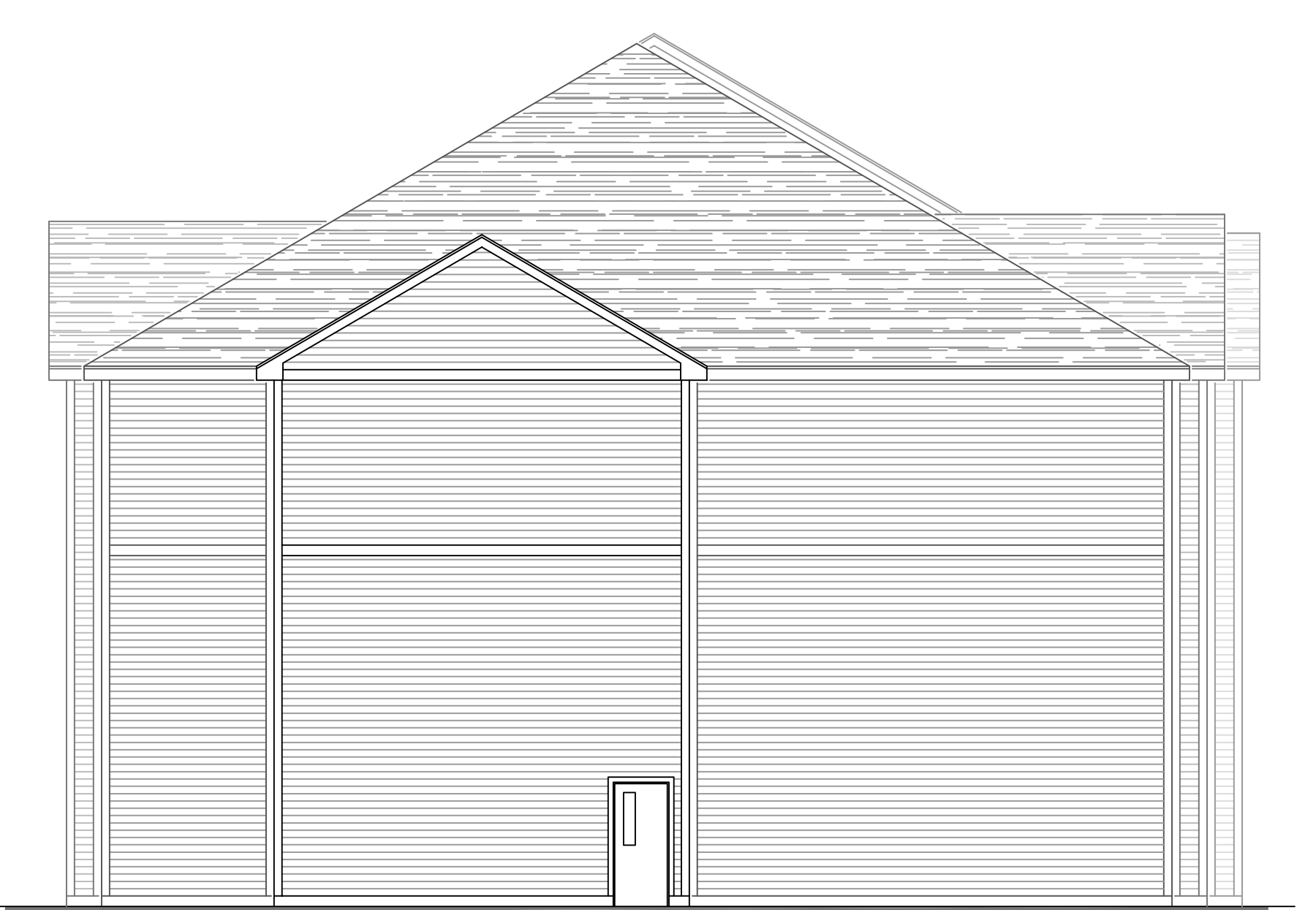
REAR ELEVATION - BUILDING No. 1 # 3

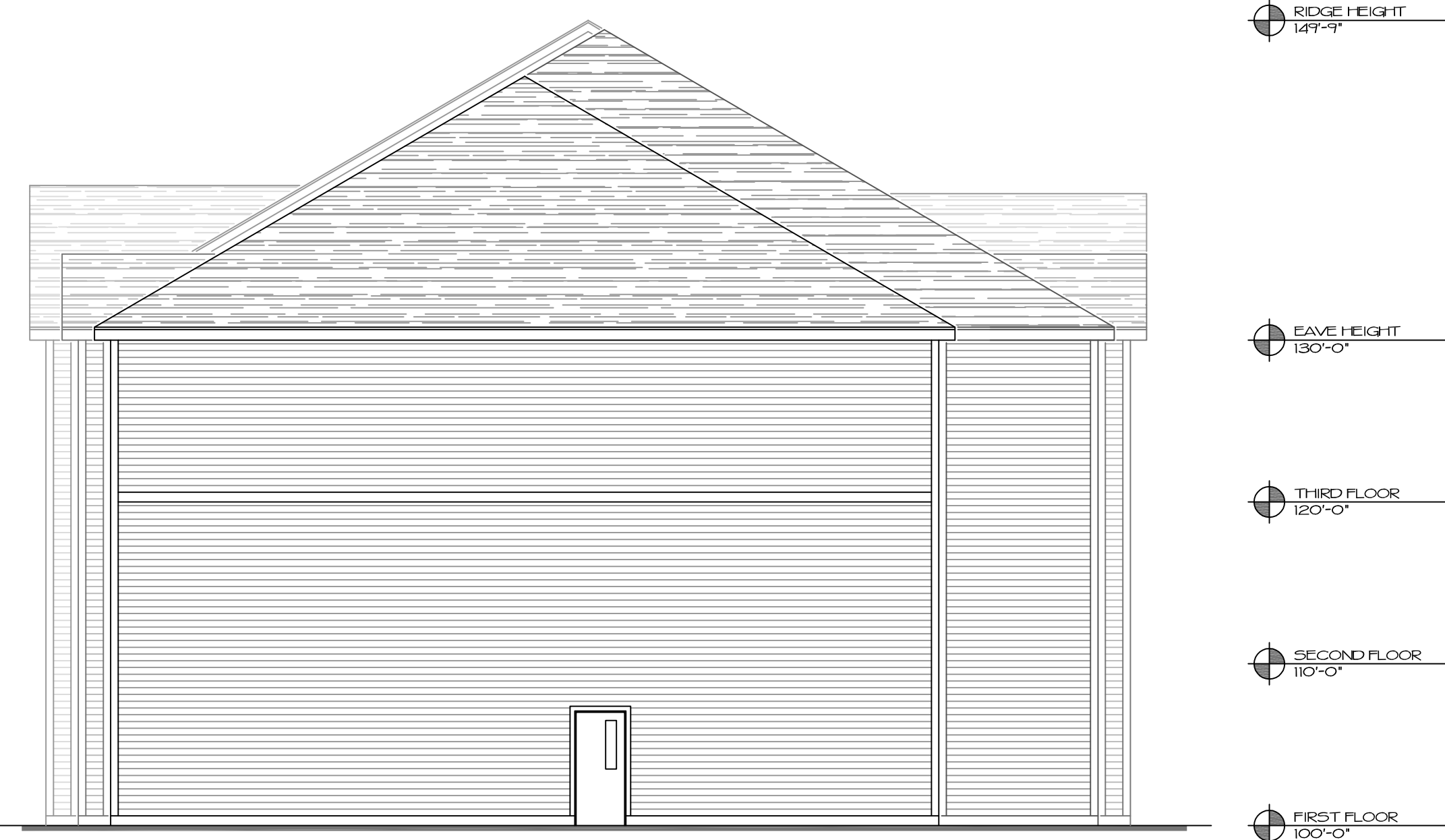

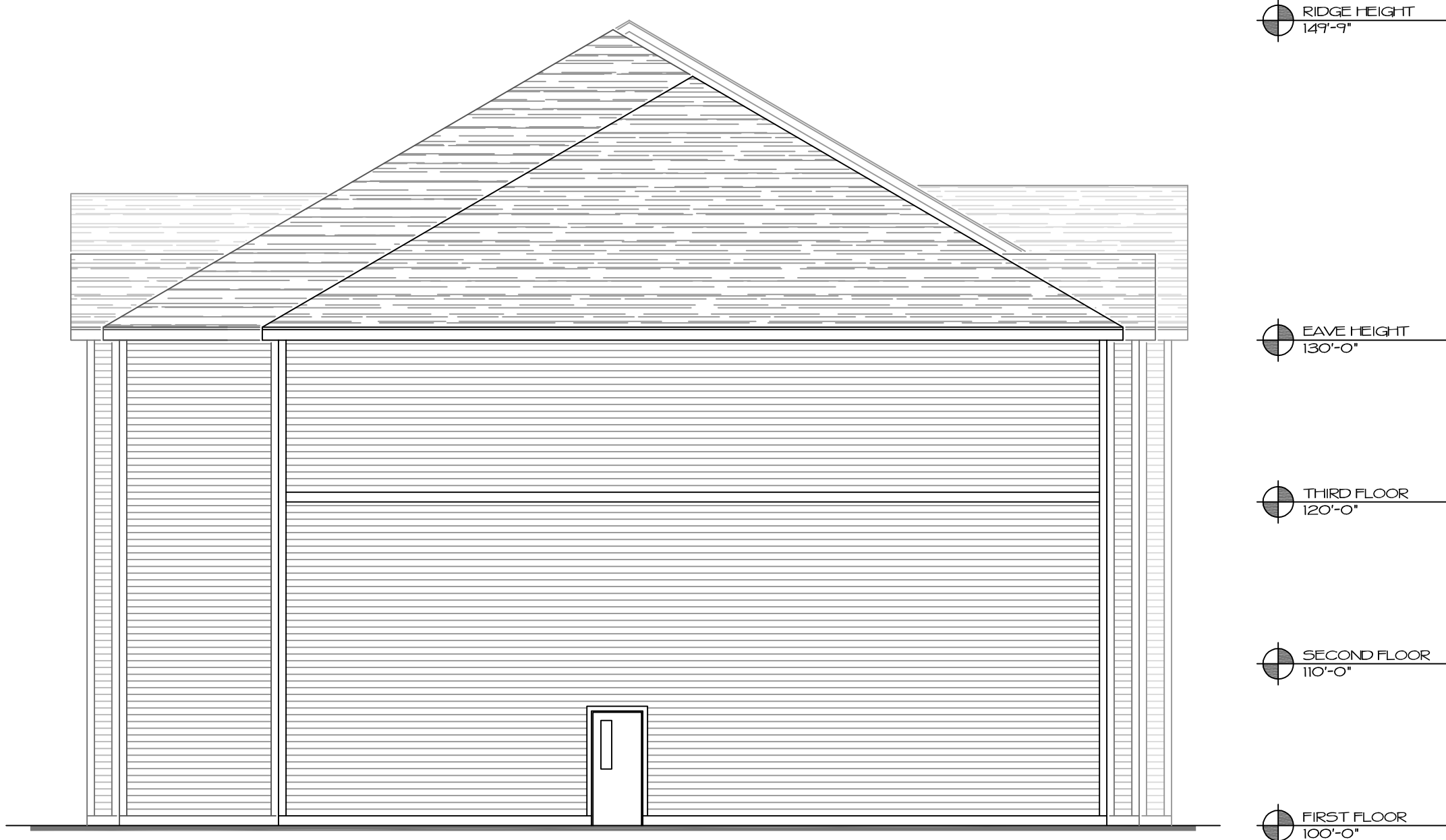
FRONT ELEVATION - BUILDING No. 2
