## LOCATION

Kelso is located in the Scottish Borders approximately 44 miles south of Edinburgh and 23 miles south west of Berwick Upon Tweed. The town has a resident population of around 7,000 people and draws on a wider catchment of around 80,000 people in the Scottish Borders area.

The subjects occupy a highly prominent position on Station Road which is one of the main arterial routes connecting the town centre and the southern bypass.
