This Revocable Permit hereby issued on this day of **October 17, 2012**

ISSUED TO: Alan and Janet Block Family Limited Partnership
ADDRESS: P.O. Box 691542, Los Angeles, CA 90069-1542
FOR THE PURPOSE OF: Full Service Restaurant: Placing 6 tables, 20 chairs, 6 umbrellas, and a 42-in high non-fixed railings within the public right-of-way of Beverly Boulevard. (See Attached sketch).

PERMIT CONDITIONS:

1. The tables, chairs, railings, and umbrellas shall be placed at a maximum of 6-ft from the face of the building, such that there is a minimum of 7 feet of clear space from the encroachments to any obstructions, such as street tree grates, parking meters, news racks, street lights or traffic signals for pedestrian traffic.
2. The tables, chairs, railings, and umbrellas shall be placed on the sidewalk during business hours only and shall be removed and stored inside the property at all other times.
3. Umbrellas approved by the Bureau of Engineering personnel shall be mounted in a stable base to prevent accidental or wind-blown tipping over. Umbrella spokes shall have a minimum height of 7-ft.
4. The applicant shall clean and maintain the sidewalk areas where the tables and chairs are placed at all times.
5. Evidence of the required insurance for \$1,000,000 must be presented annually to the Board of Public Works.

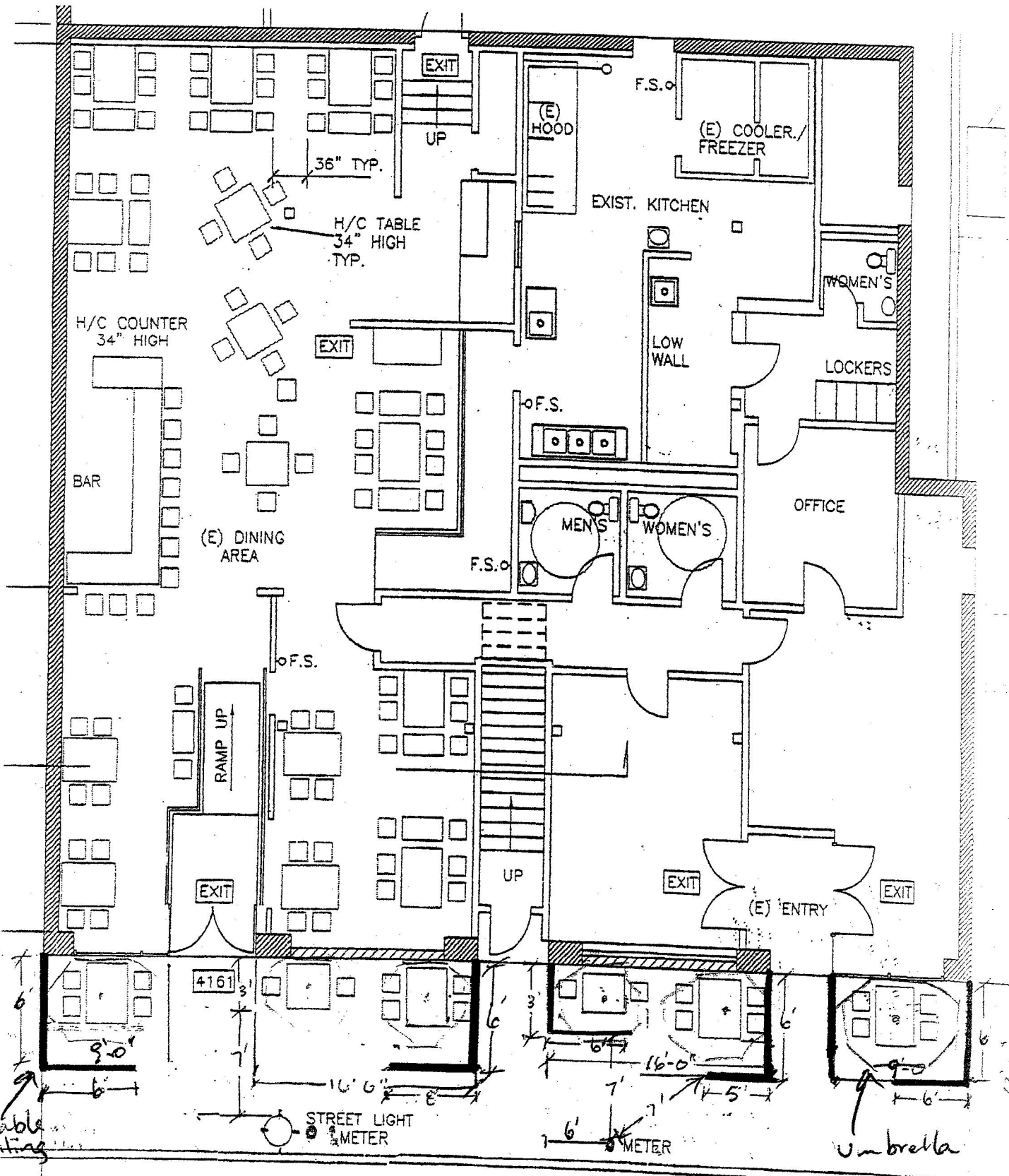
