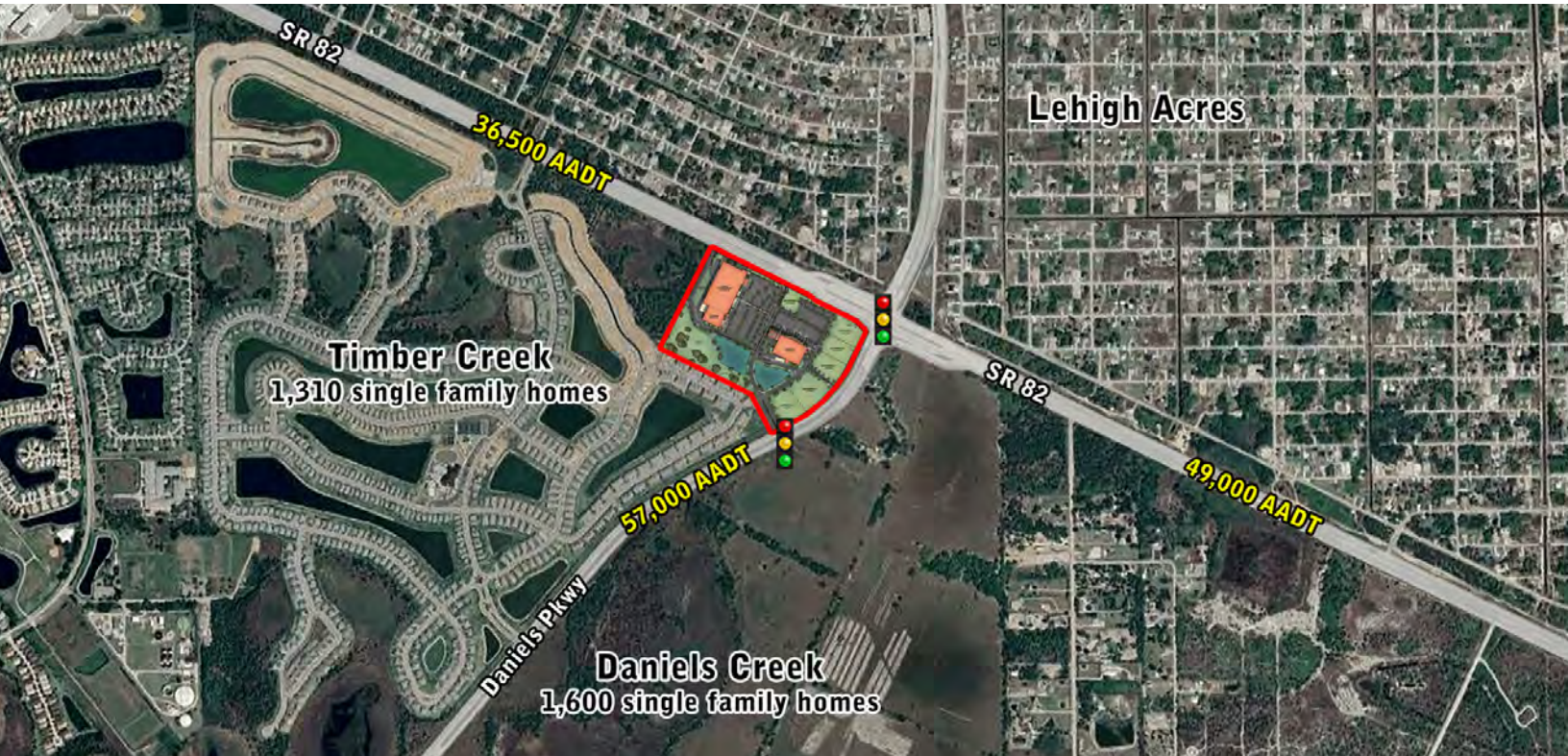

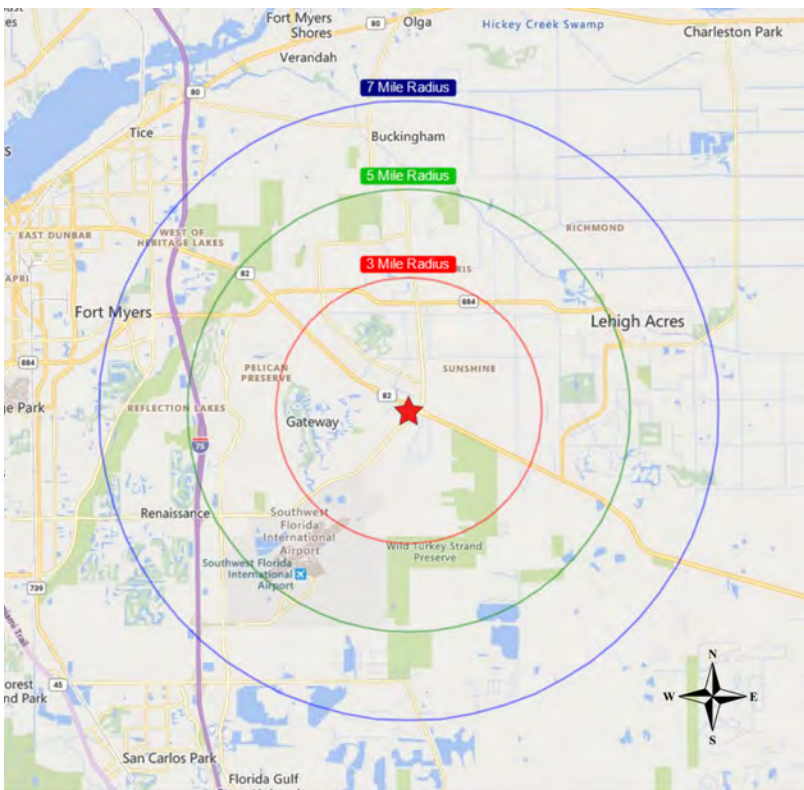


PROPERTY HIGHLIGHTS

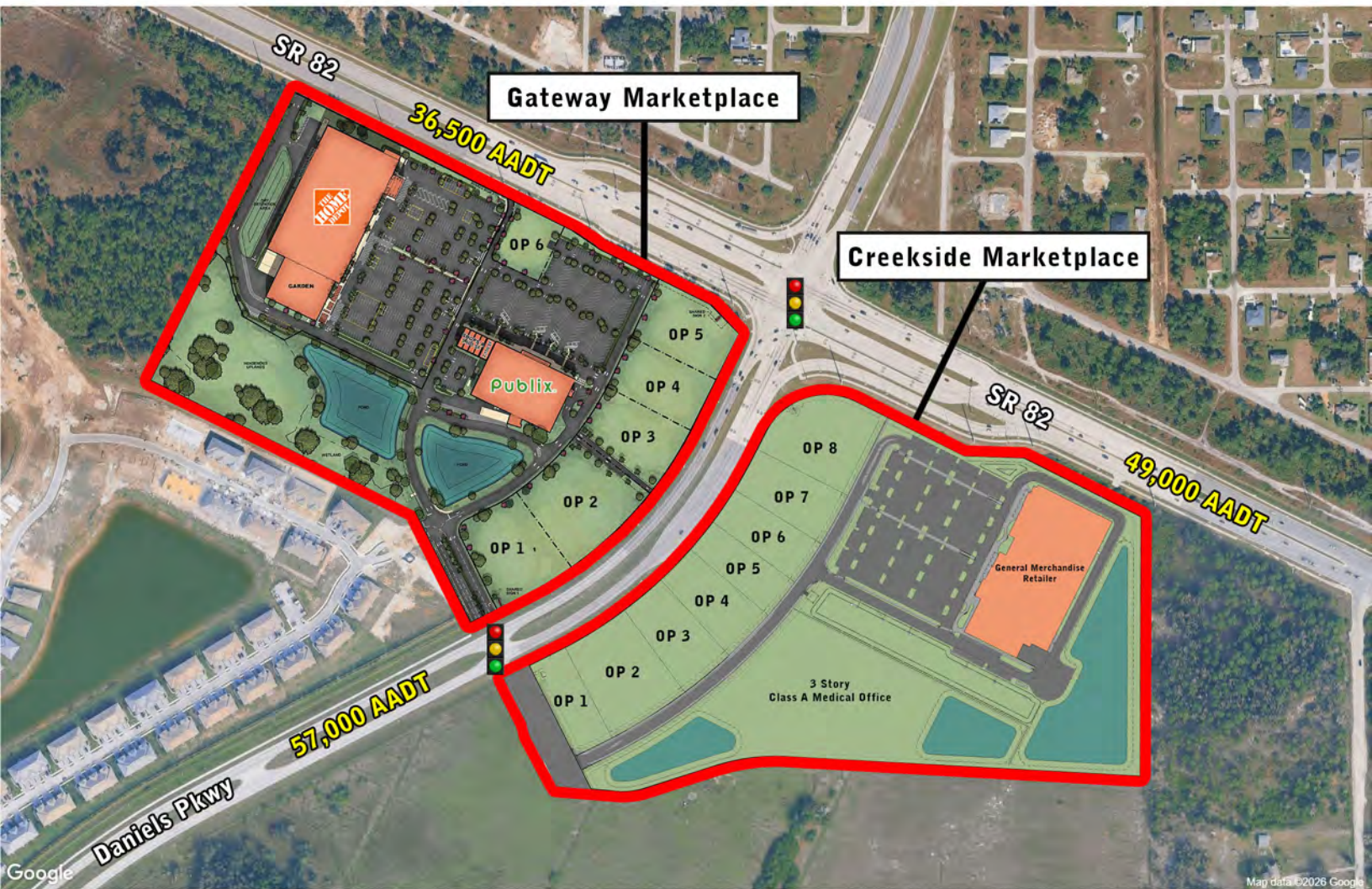
