There is some air conditioning and some LED lighting.

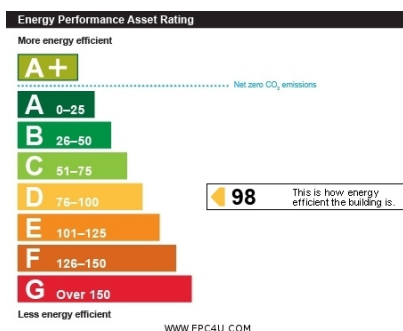
The property is located opposite Lidl at the start of Shirley High Street. It would be suitable for various uses.

## Location

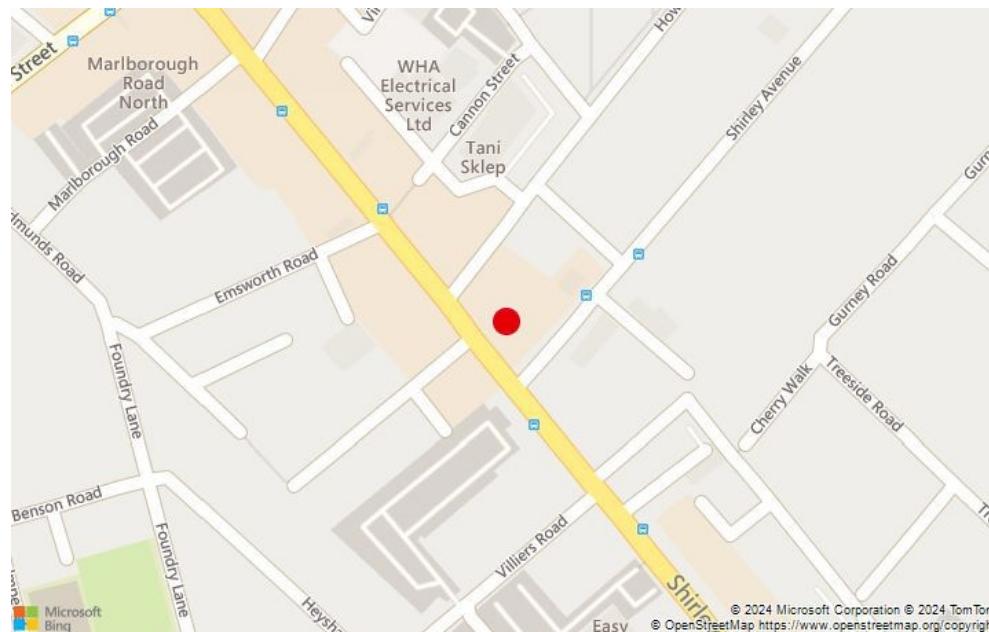
