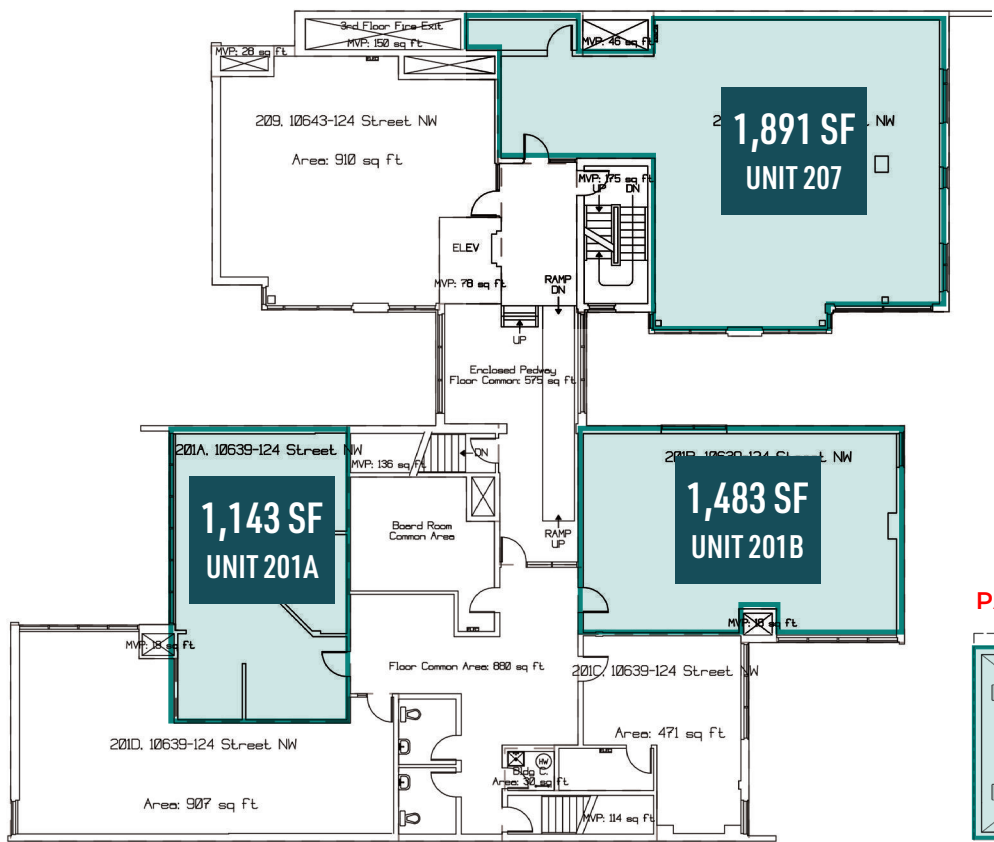

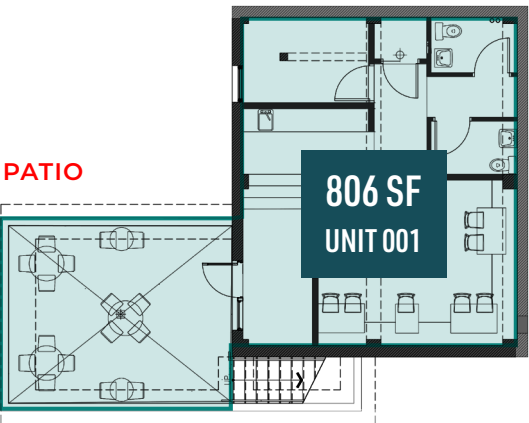


SPACE PLAN

LOWER LEVEL

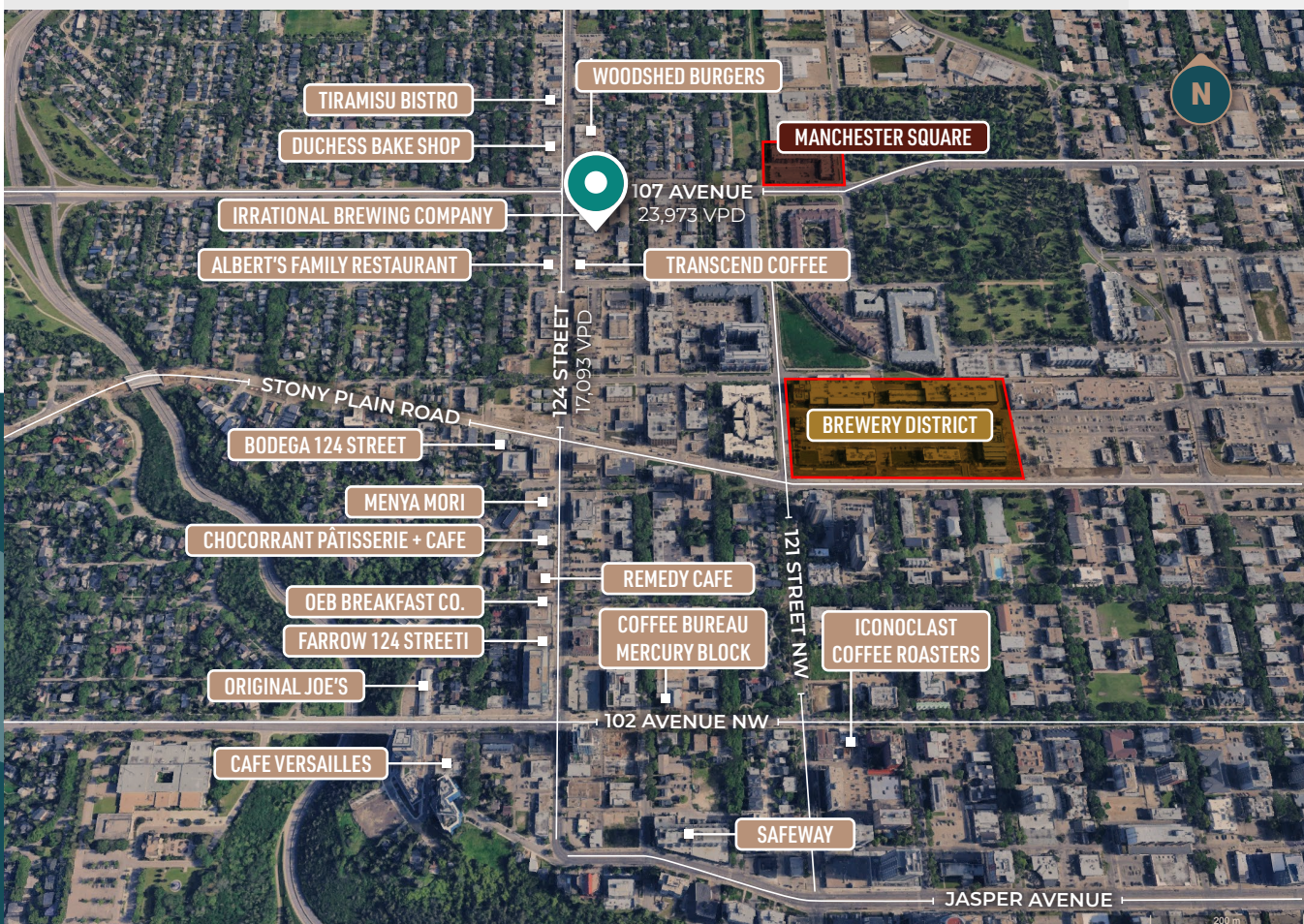

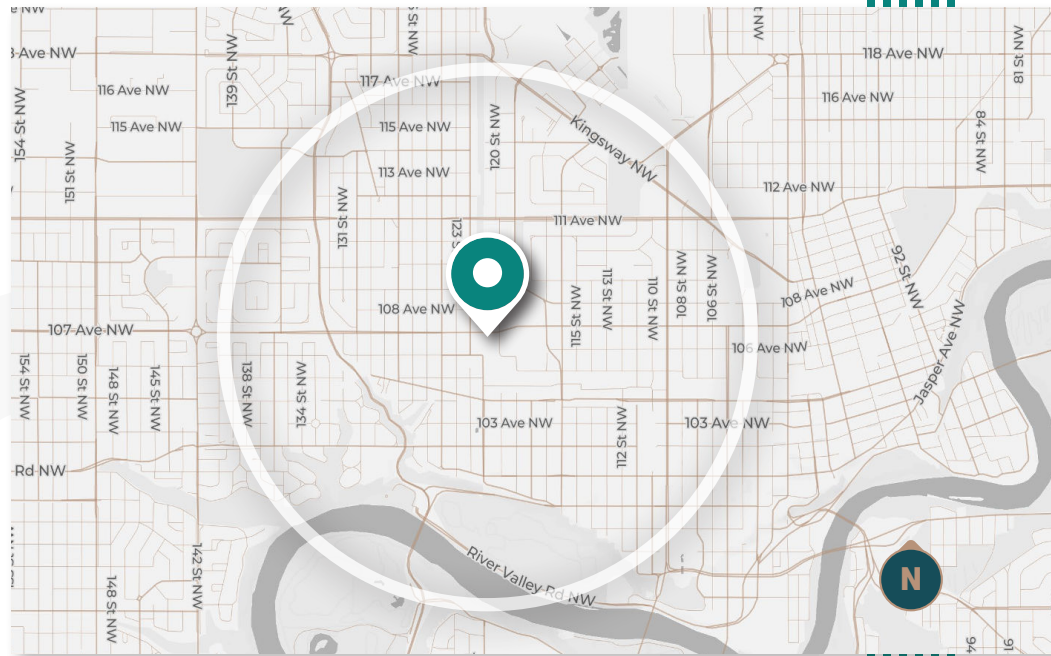
