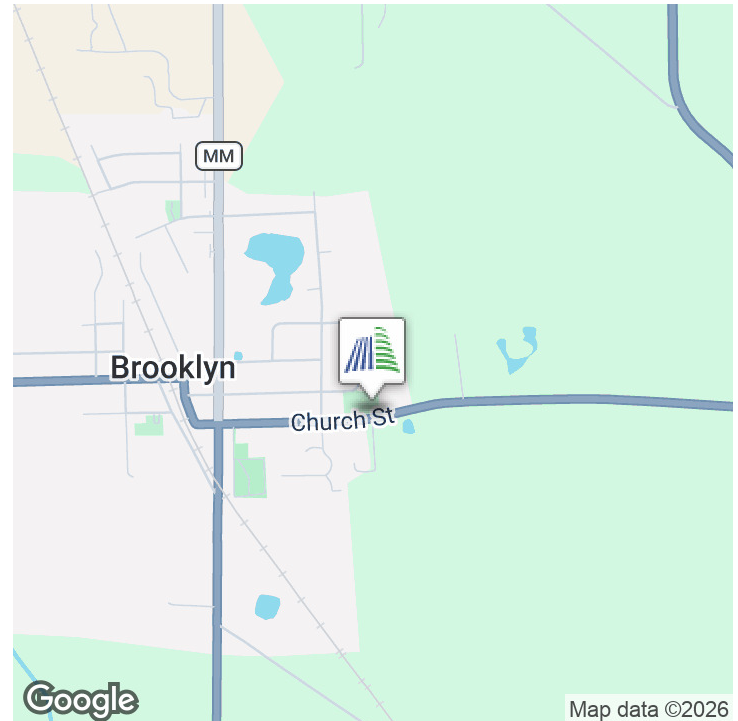

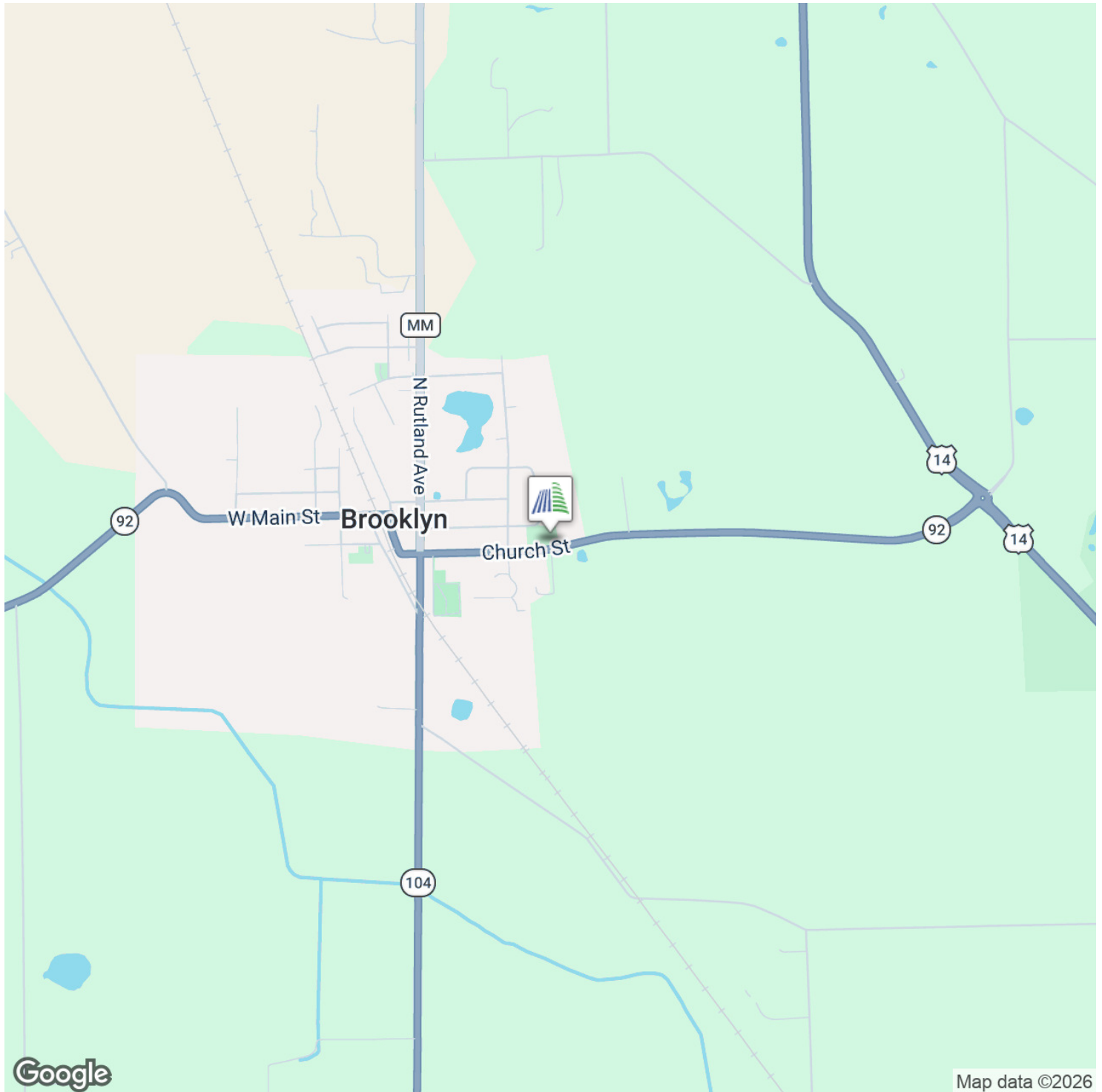

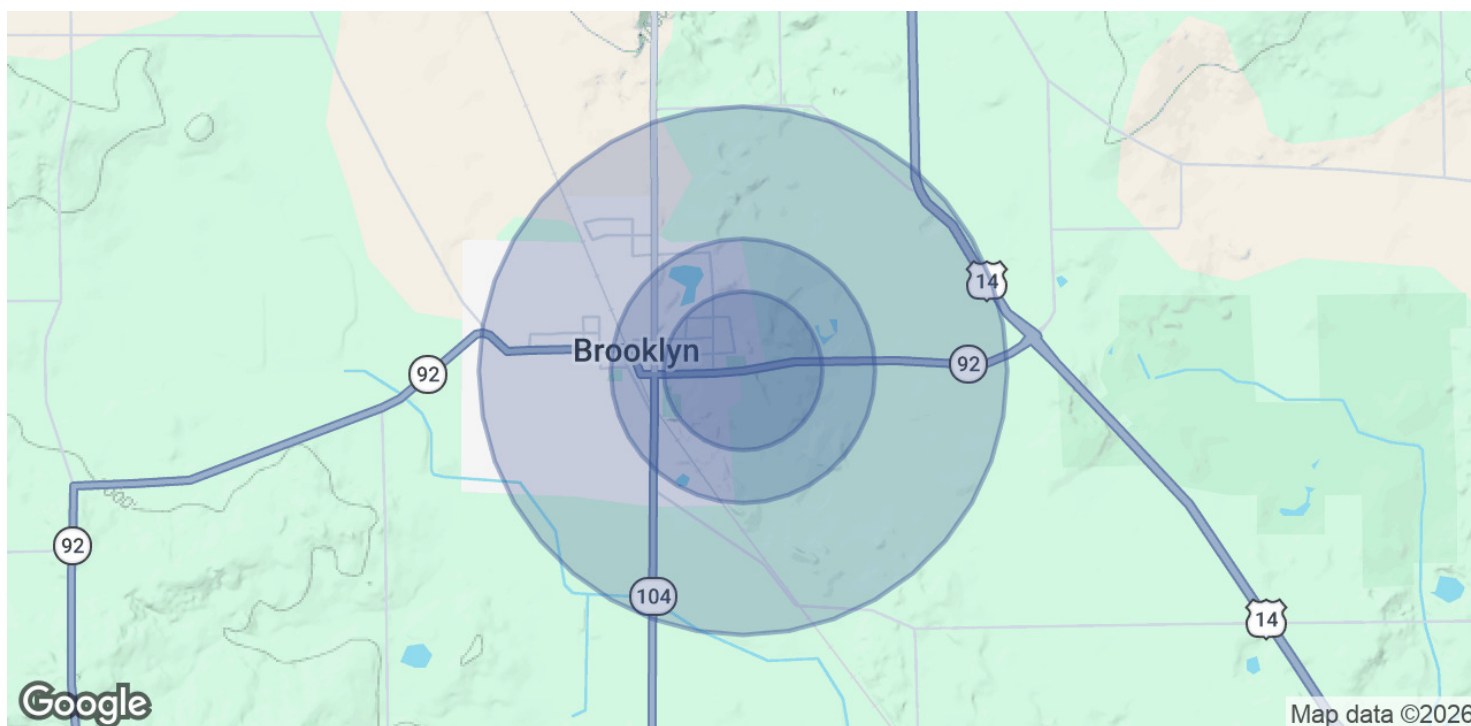
// LOCATION MAP
