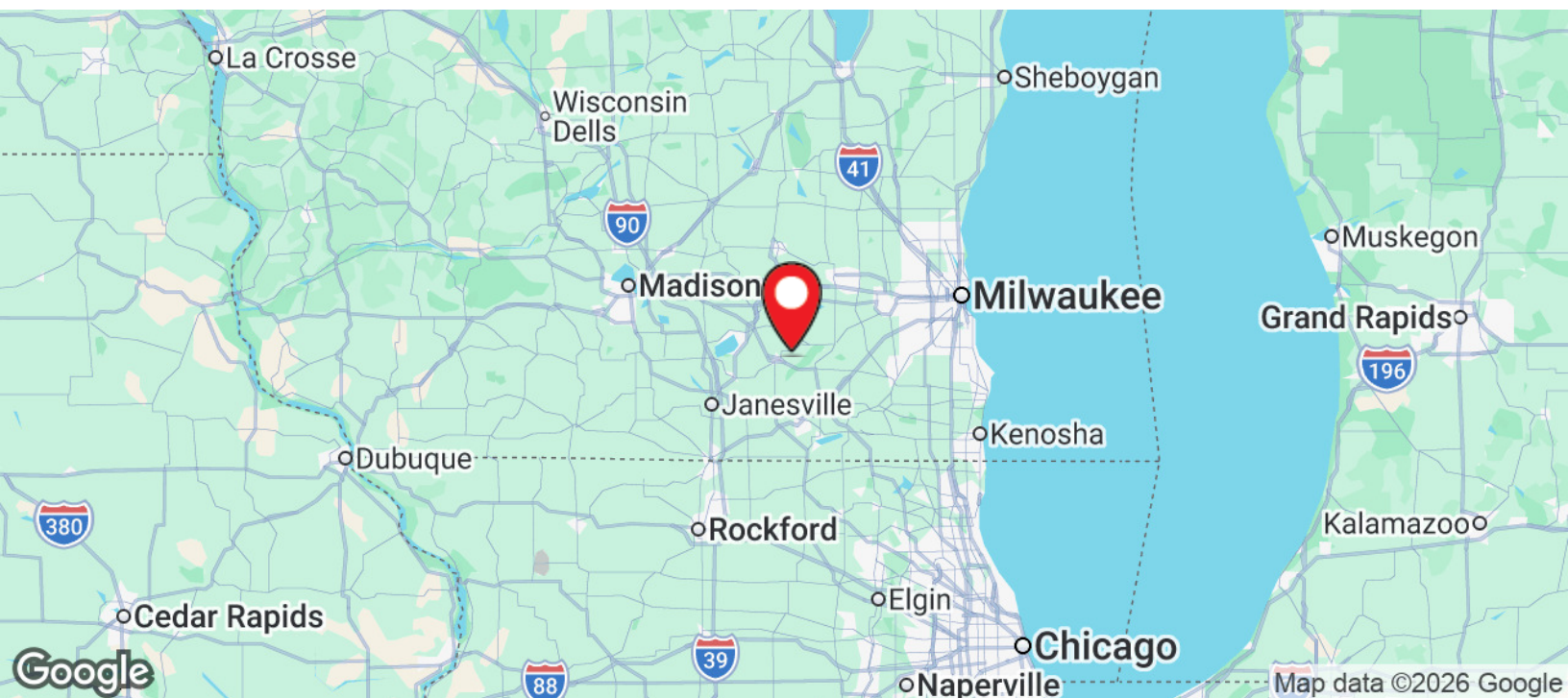

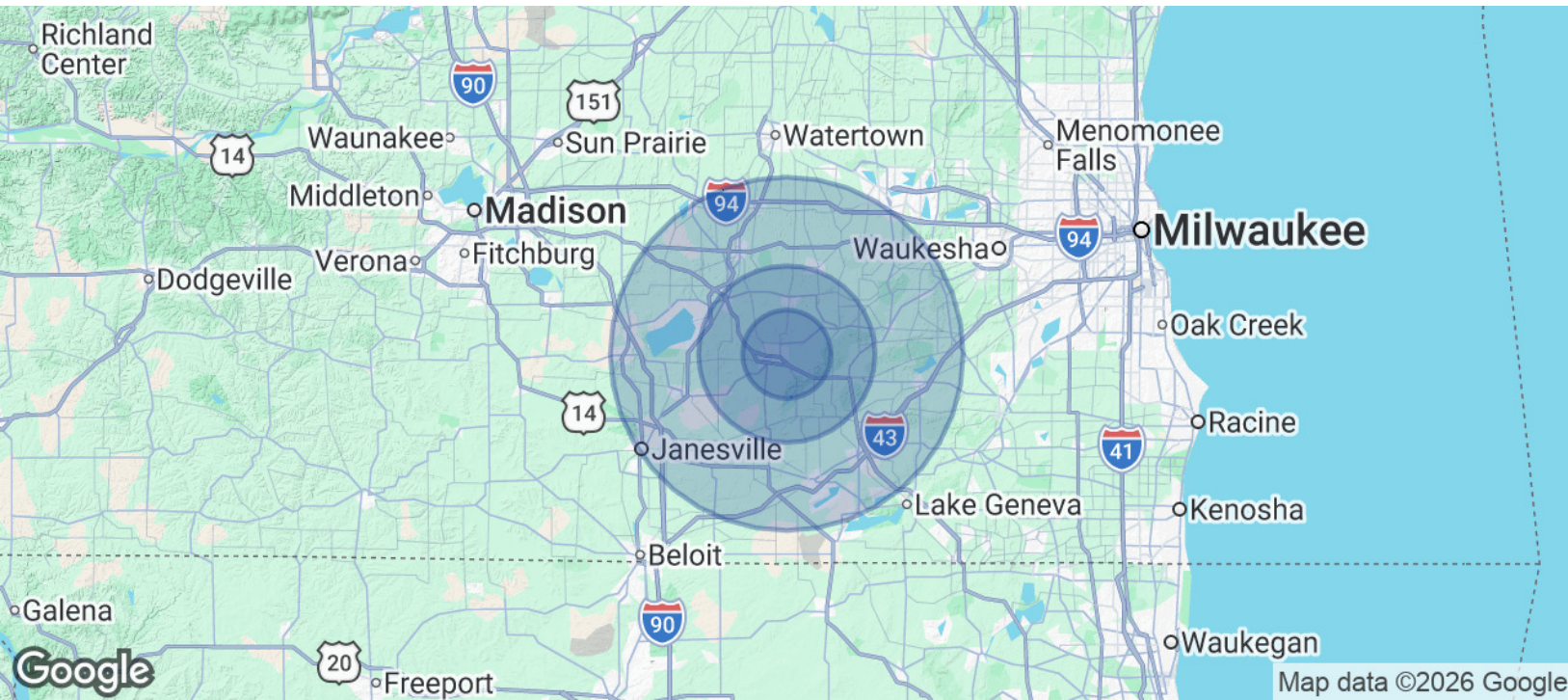

18 advantages and disadvantages of the proposals.
