This is a detached two storey brick-built property in the picturesque village of Hook Norton, Banbury Oxfordshire.

In its history the property was a former car garage that has been converted into offices. The cellular layout provides a series of office rooms both individual and

more open plan. All are carpeted with suspended ceilings in part. The property has air conditioning fitted and installed. There are WCs on the ground floor with a staff kitchen on the first floor.

The layout favours office use but could be used for a variety of users subject to planning.

The property is in good order and benefits from parking at the front and rear.

Hook Norton is a popular north Oxfordshire village, positioned between Banbury and Chipping Norton on the edge of the Cotswolds. The village provides a range of day-to-day amenities and is well known for the historic Hook Norton Brewery. Road communications are good, with access to the A44 and the M40, while Banbury offers mainline rail services.

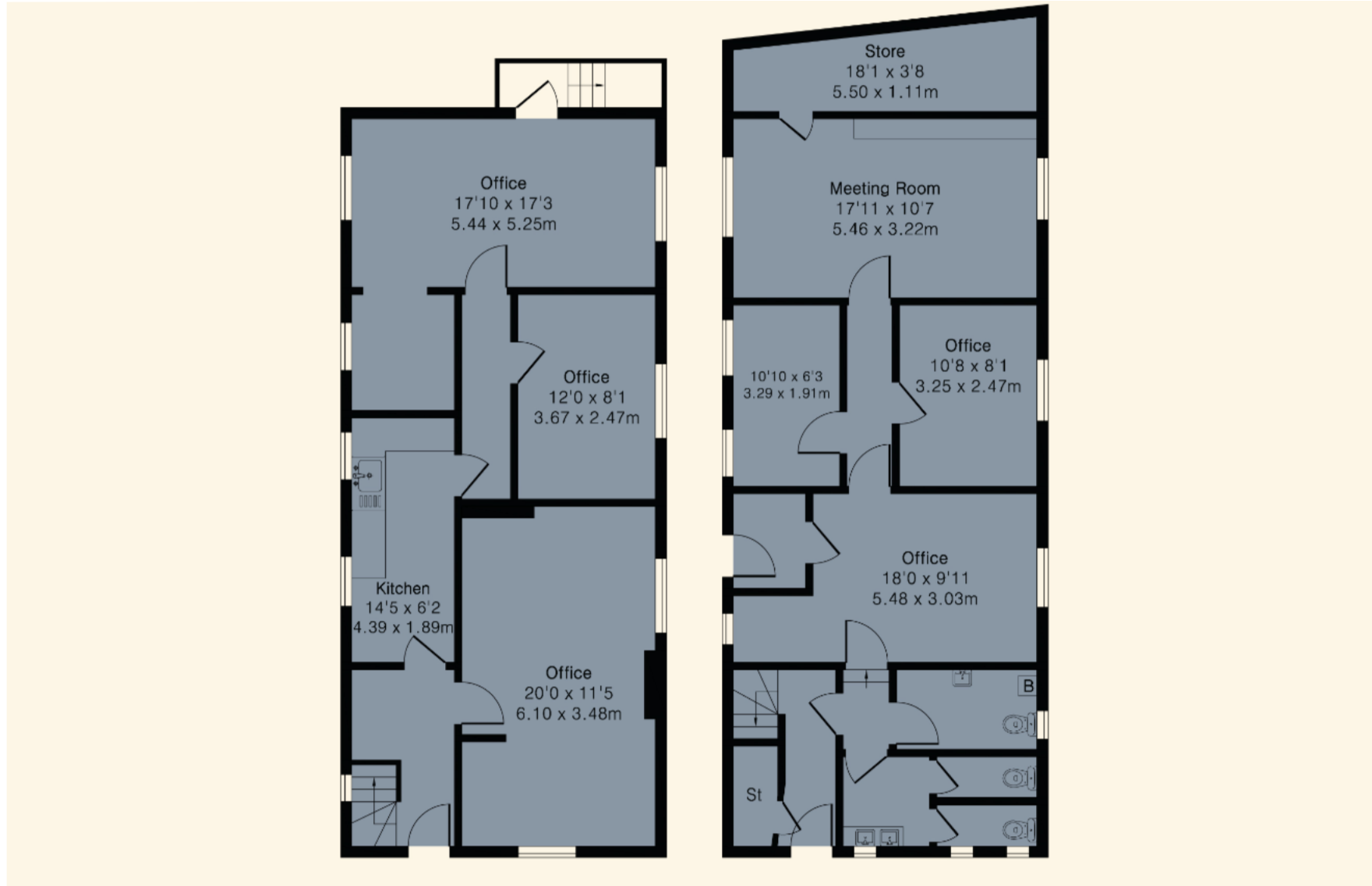
