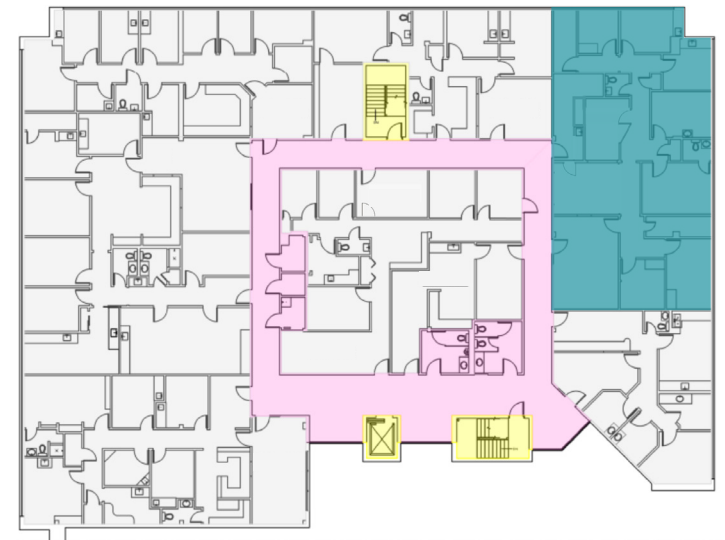

FLOOR PLAN

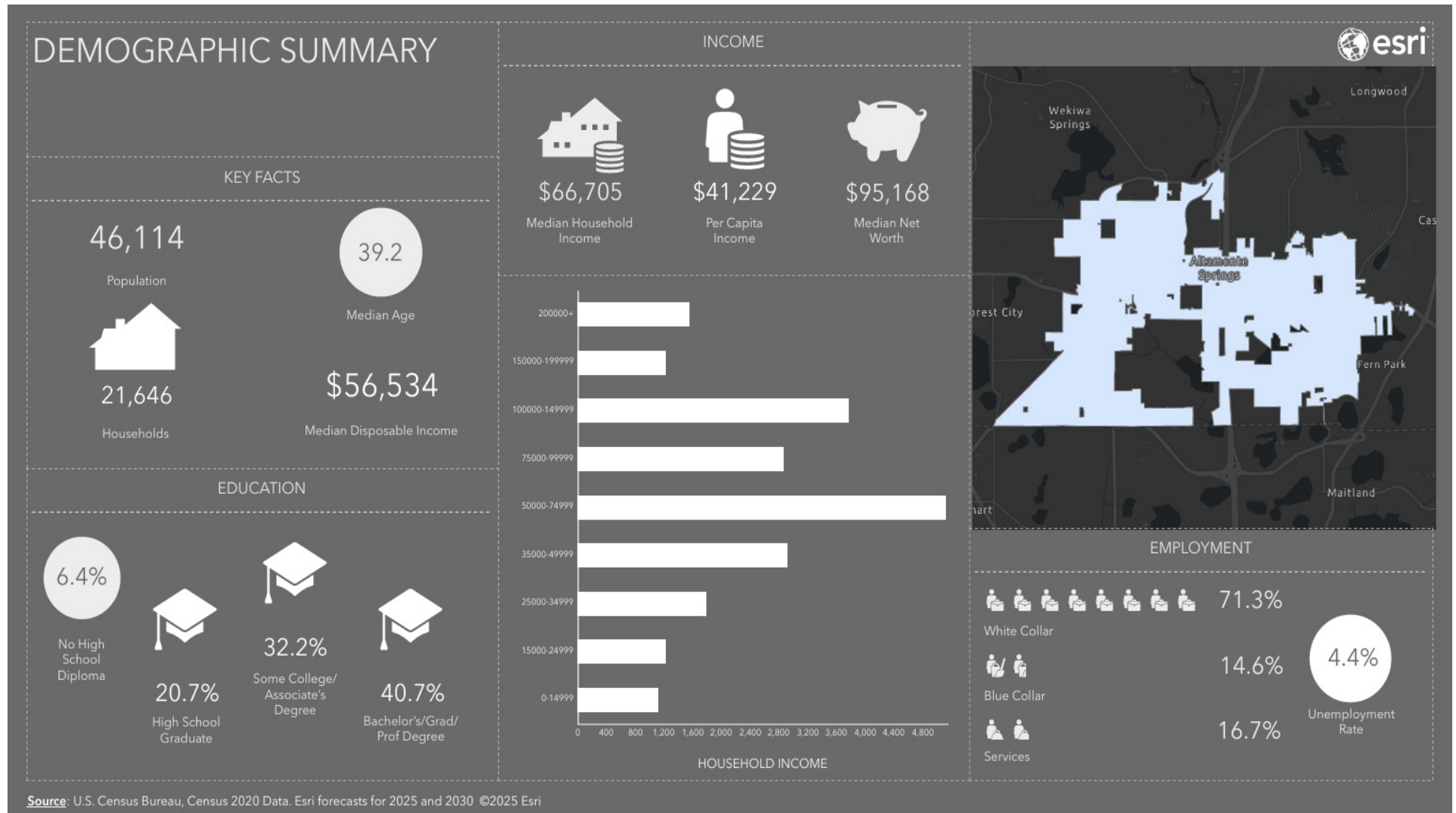

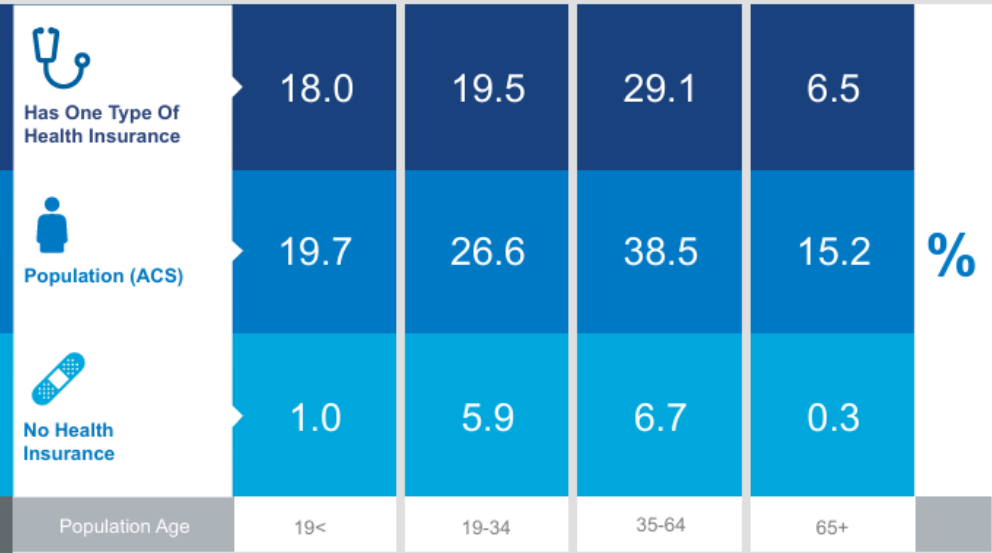

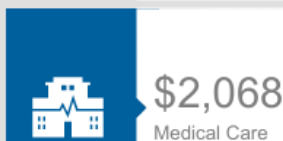
Civilian Noninstitutionalized Population (ACS)

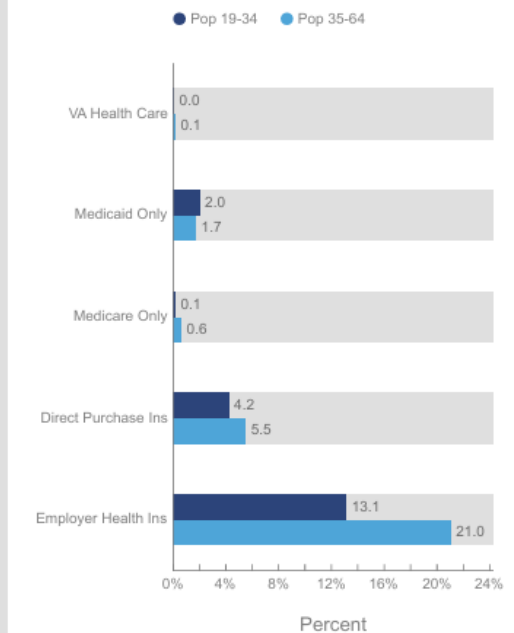

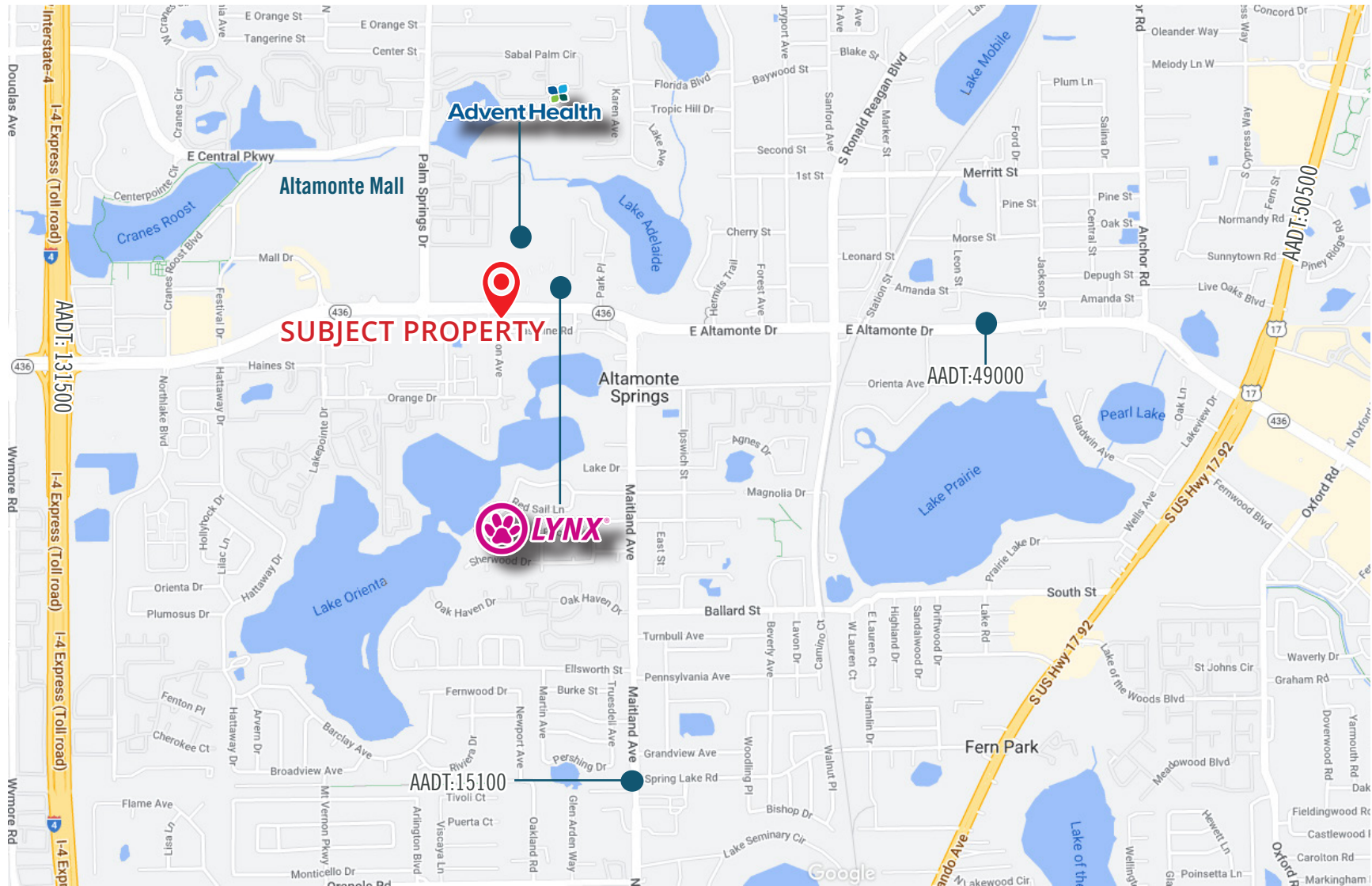
