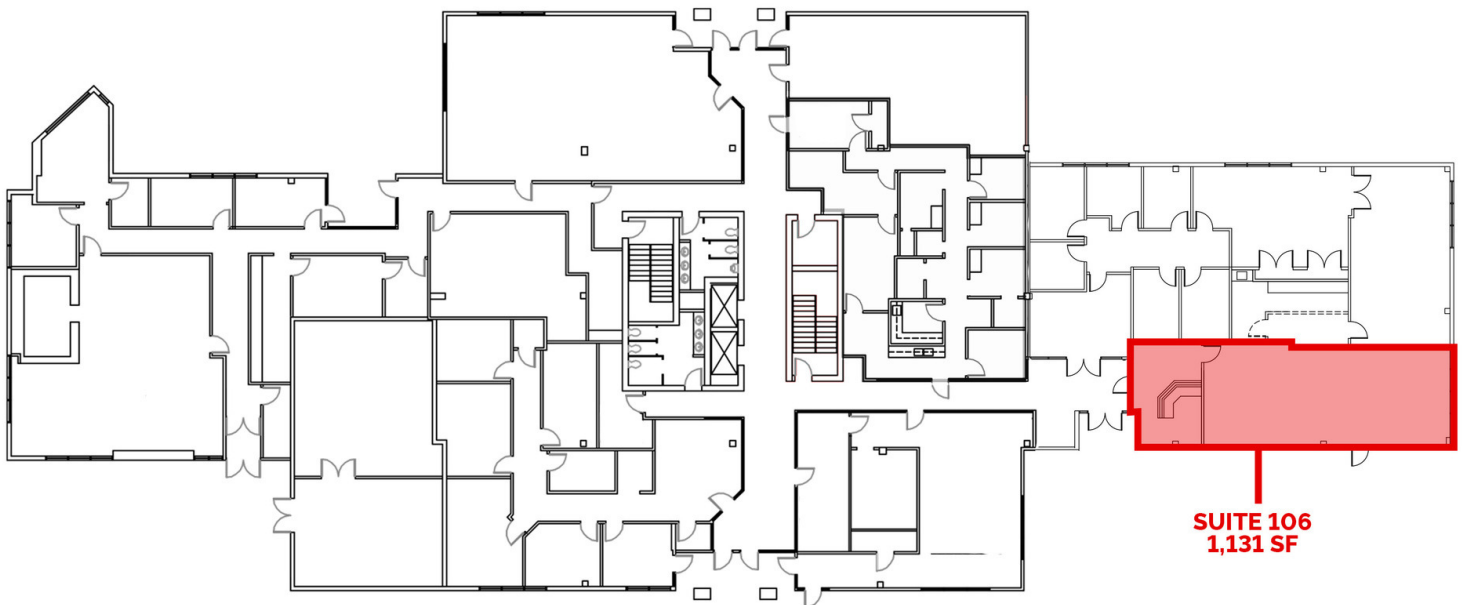

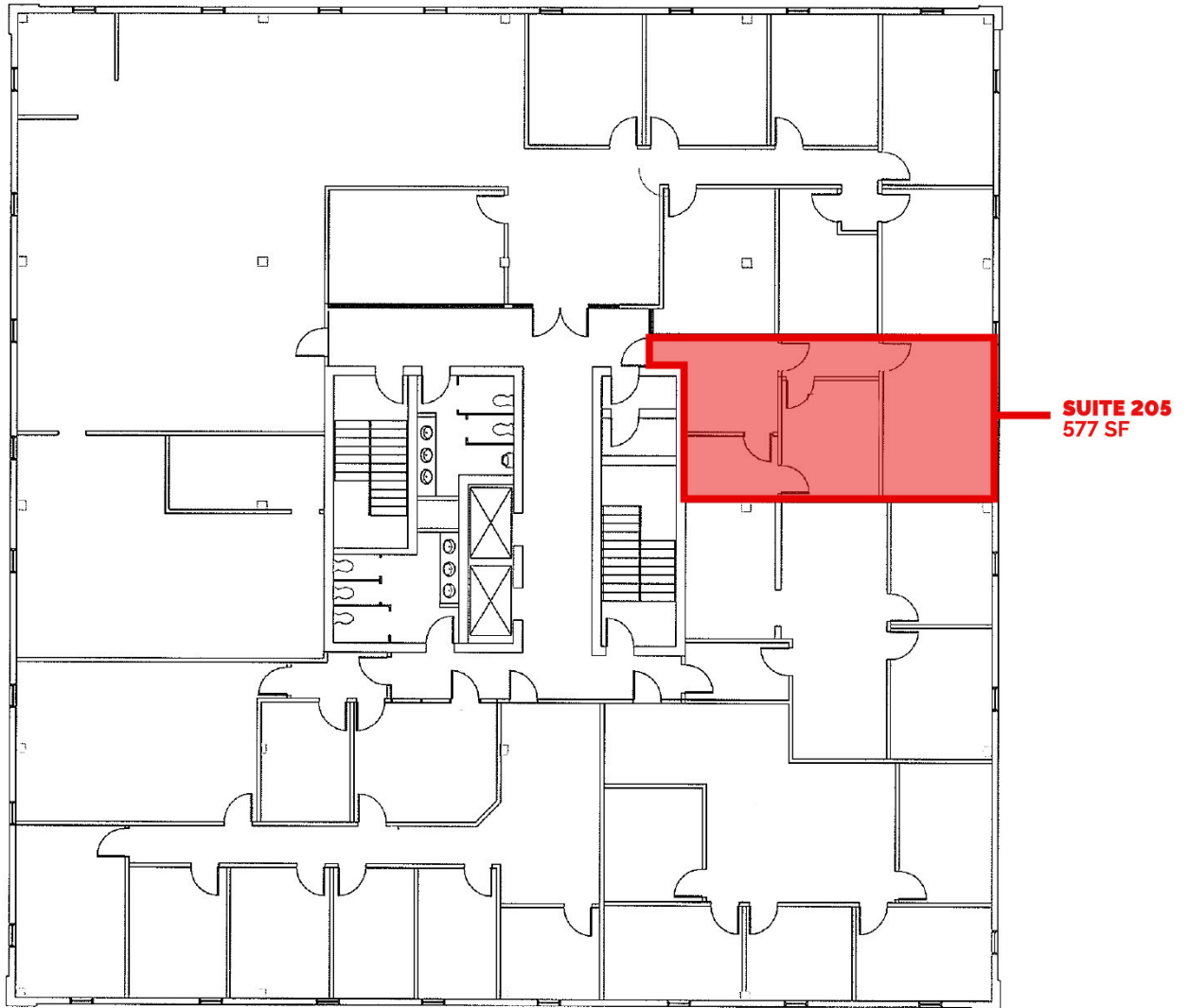

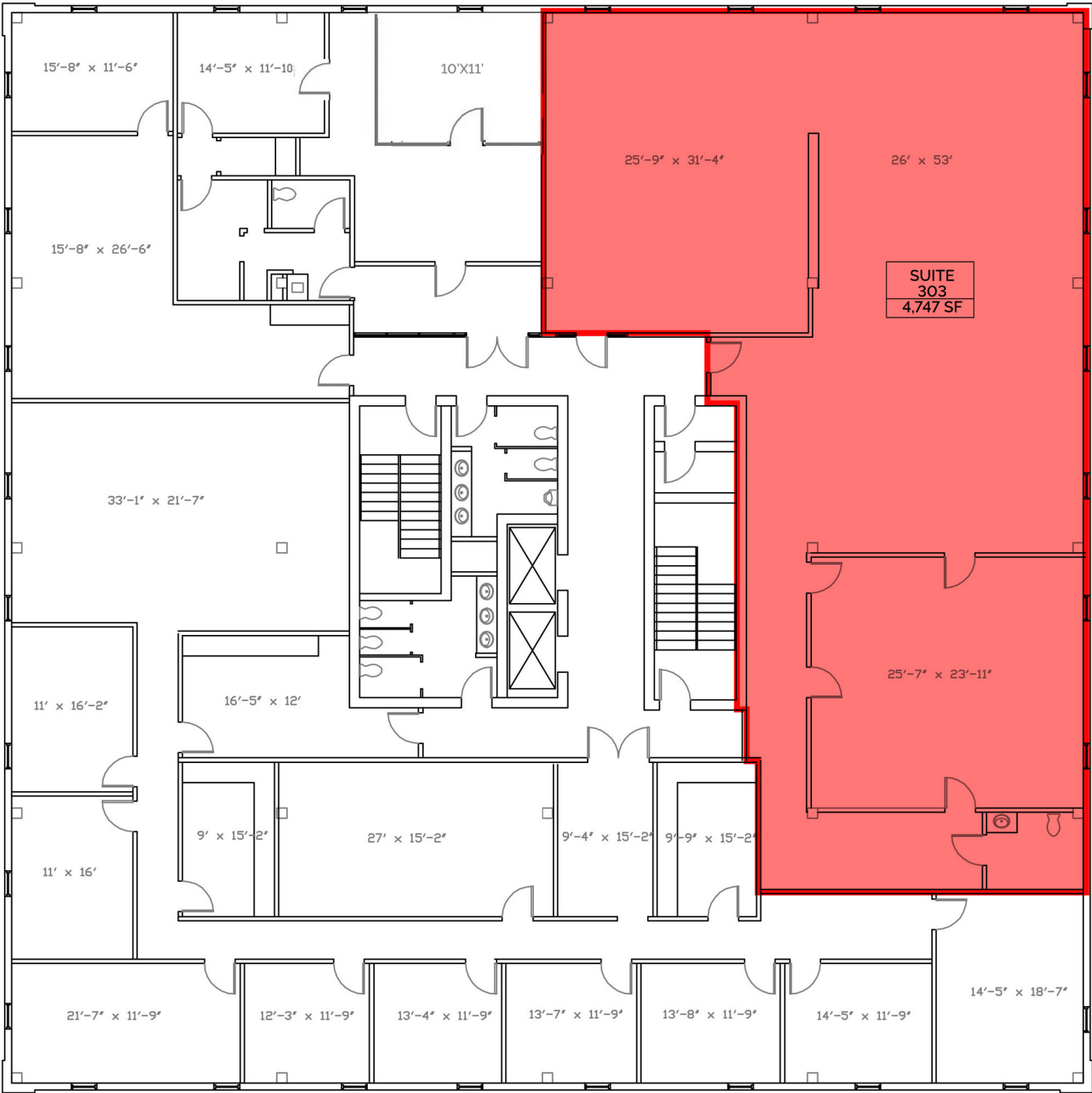

SECOND FLOOR



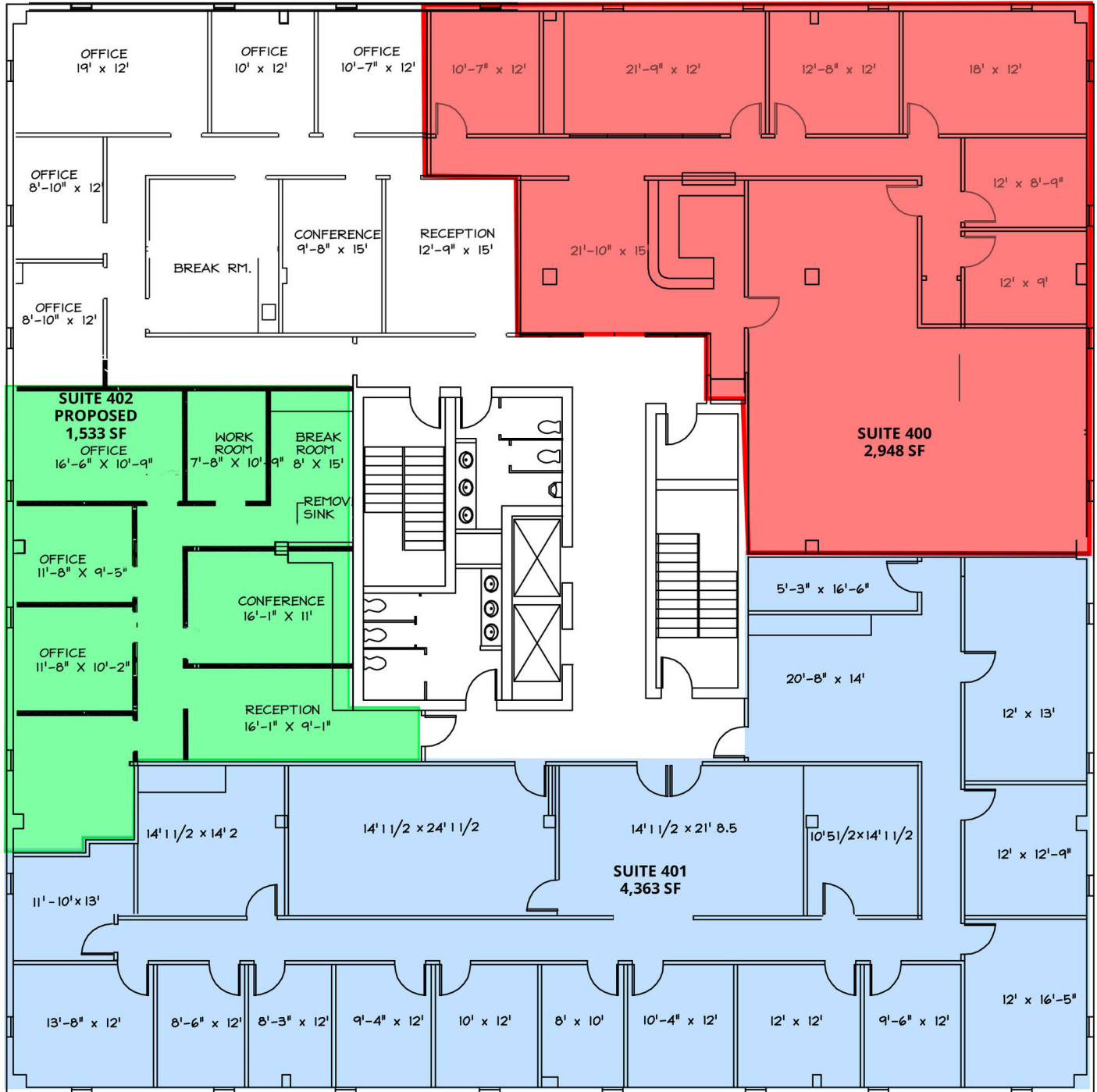

THIRD FLOOR



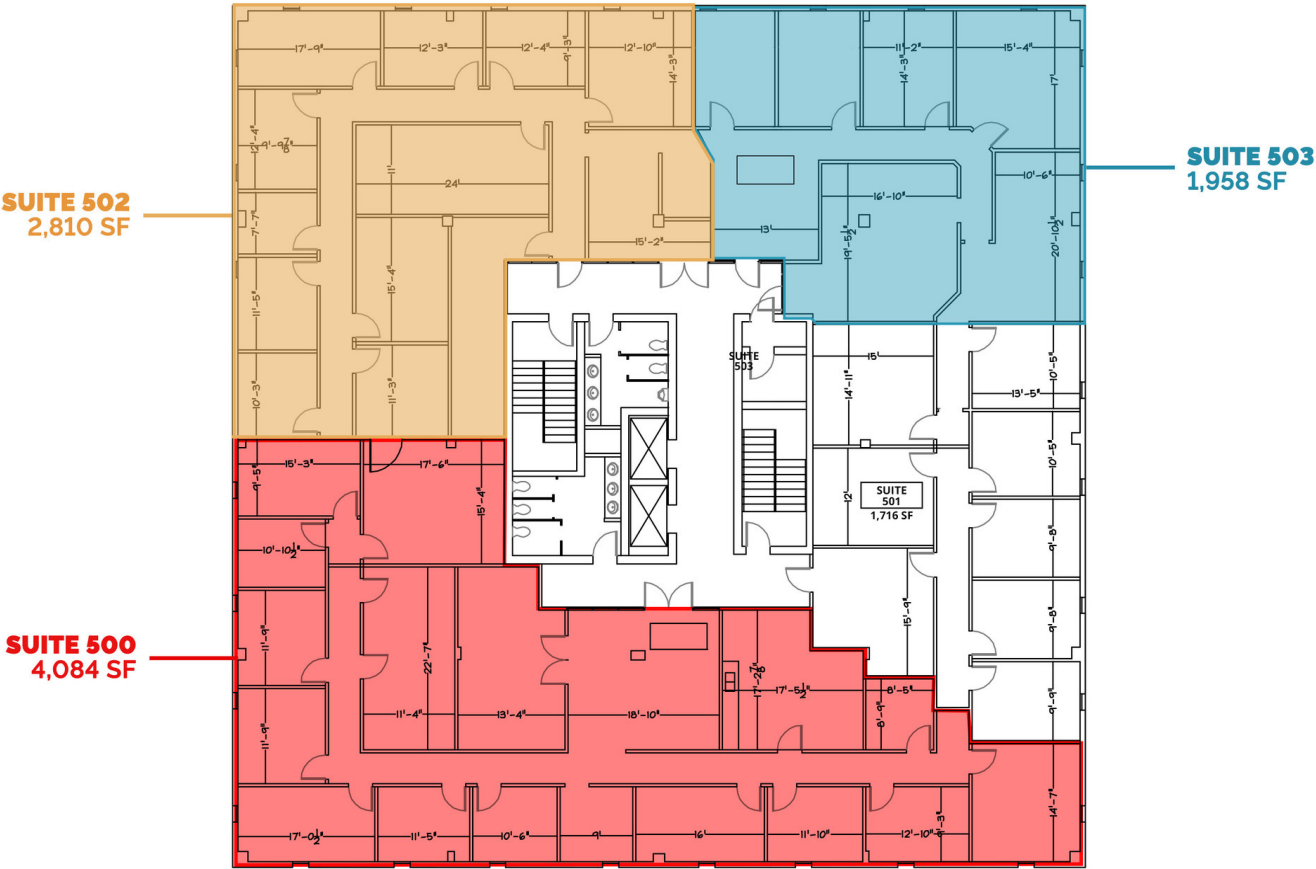
