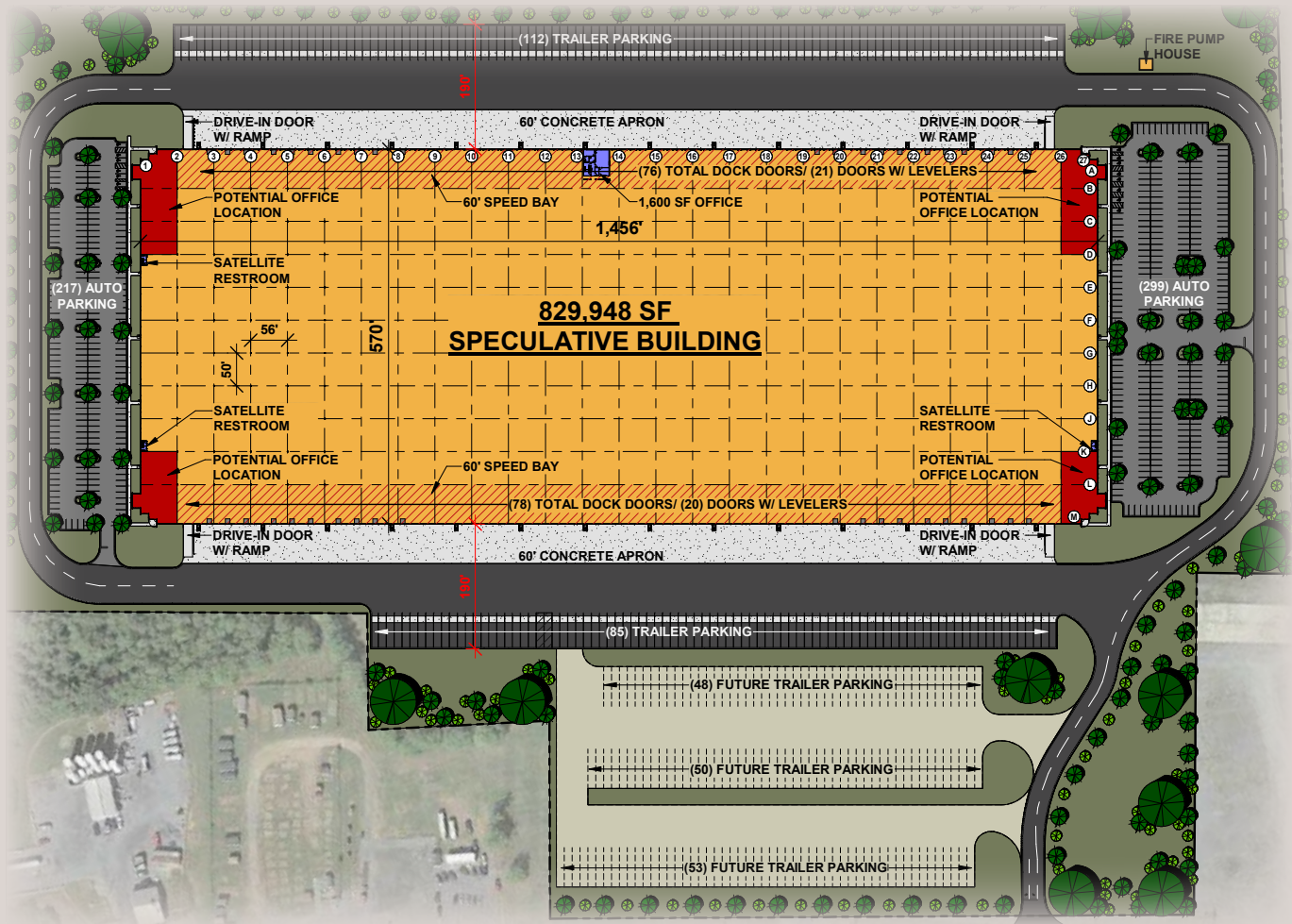

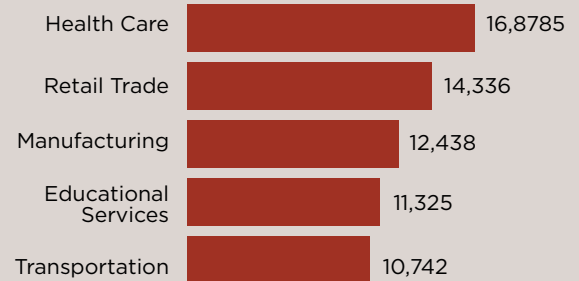

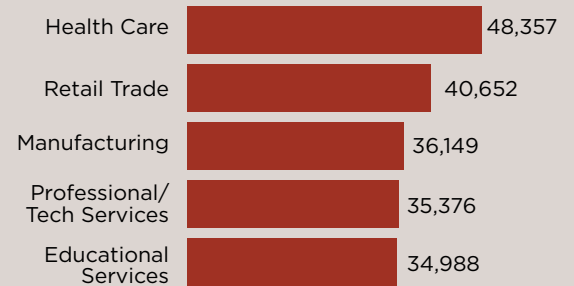
## EMPLOYMENT BY INDUSTRY

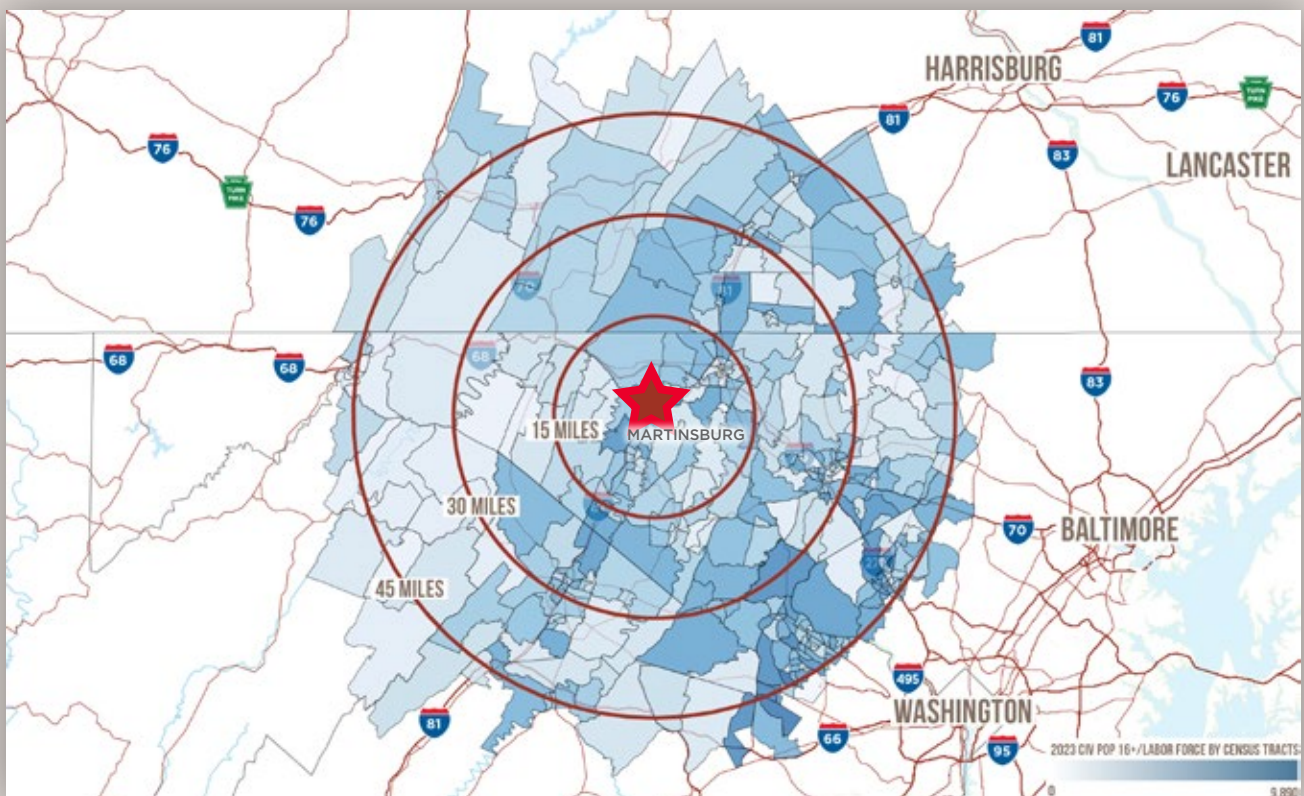

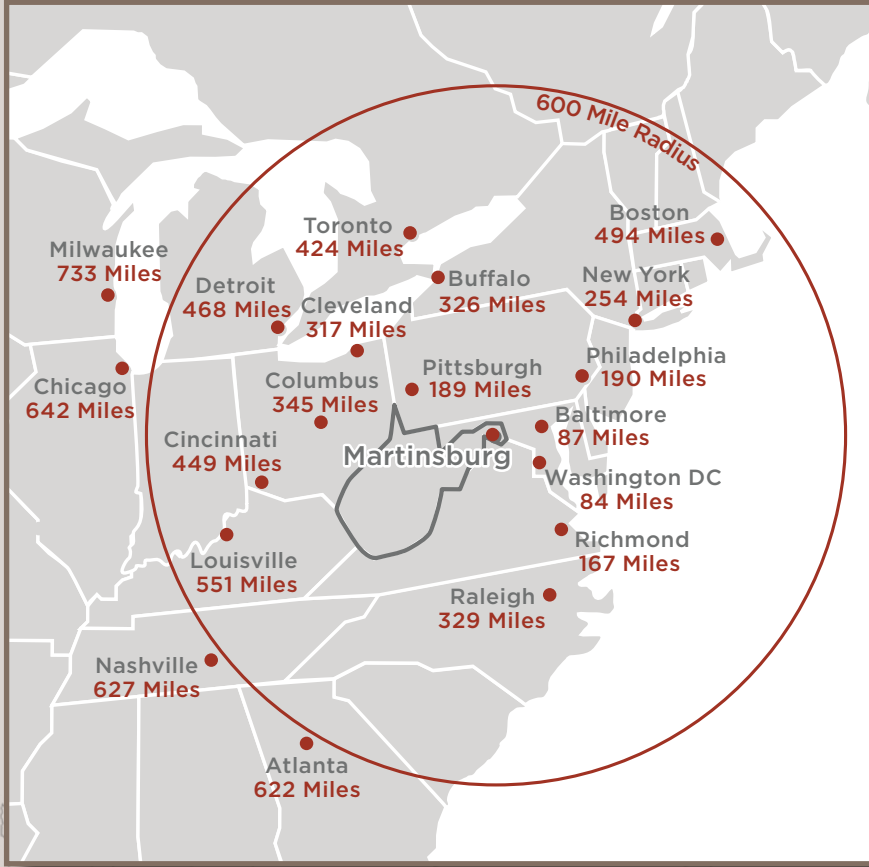
