Old Street 0.2 Miles



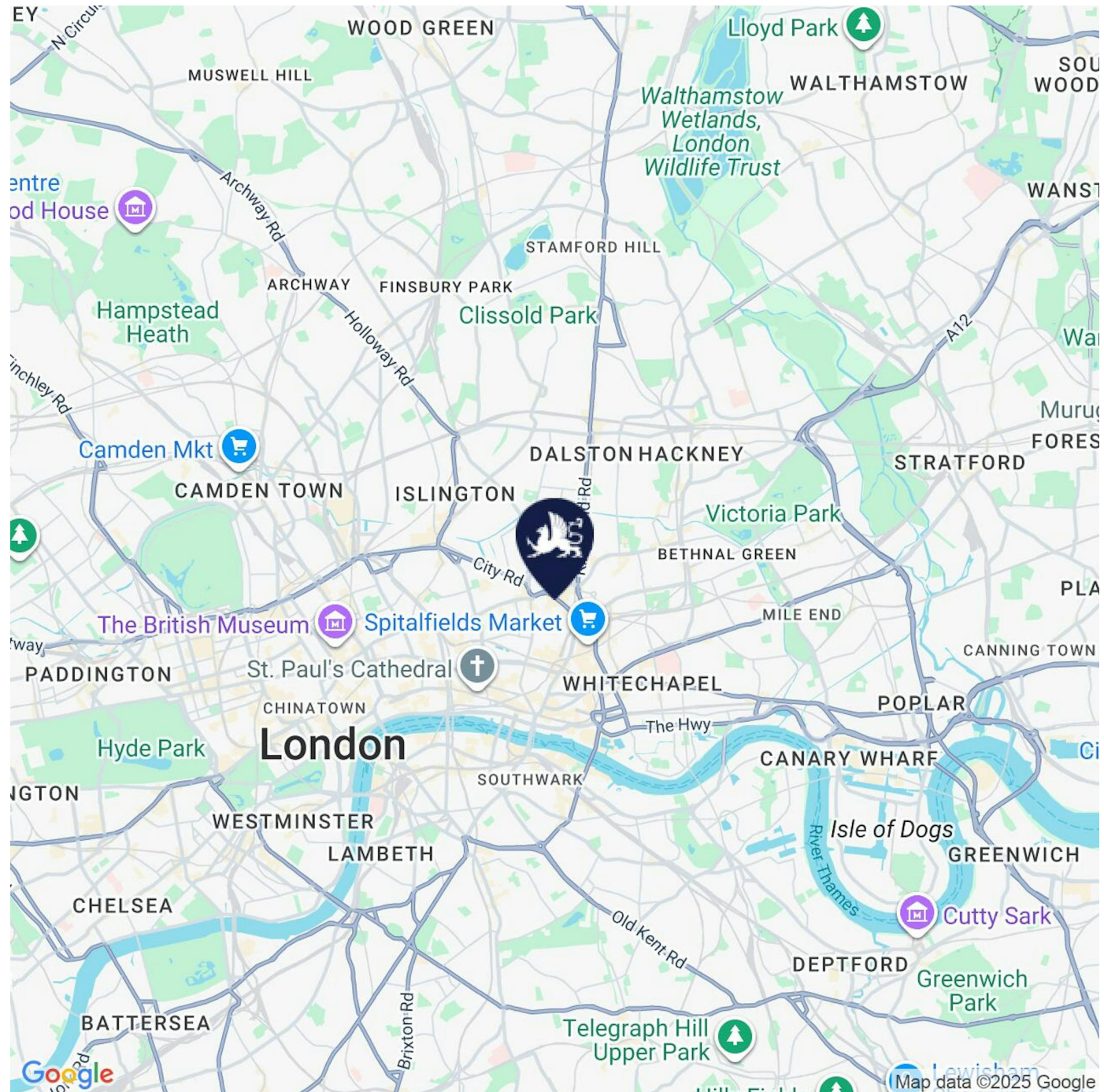
Shoreditch High Street 0.3 Miles
