LOCATION

The shop is in Derby City Centre's Cathedral Quarter on Curzon Street. Curzon Street is linked to the Wardwick and Friar Gate, which are generally regarded as Derby's prime business and professional district.

The opportunity is just 0.1 miles north of the Becketwell regeneration area; home to Derby's first purpose built PRS scheme "The Condor" a 269 unit development & the new Becketwell Performance Venue; a 3,500 seat arena.

The property has good links to public transport and parking. Derby bus station is 0.5 miles to the east, with a mainline bus stop directly outside the unit, and ParkSafe Car Park is 0.1 miles to the north.

DESCRIPTION

Retail unit. With off-street parking. To undergo light refurbishment ready for occupier fit out. Front sales area with rear store & WC. Display window with shutter door. There is staff parking in a shared yard to the rear of the property.

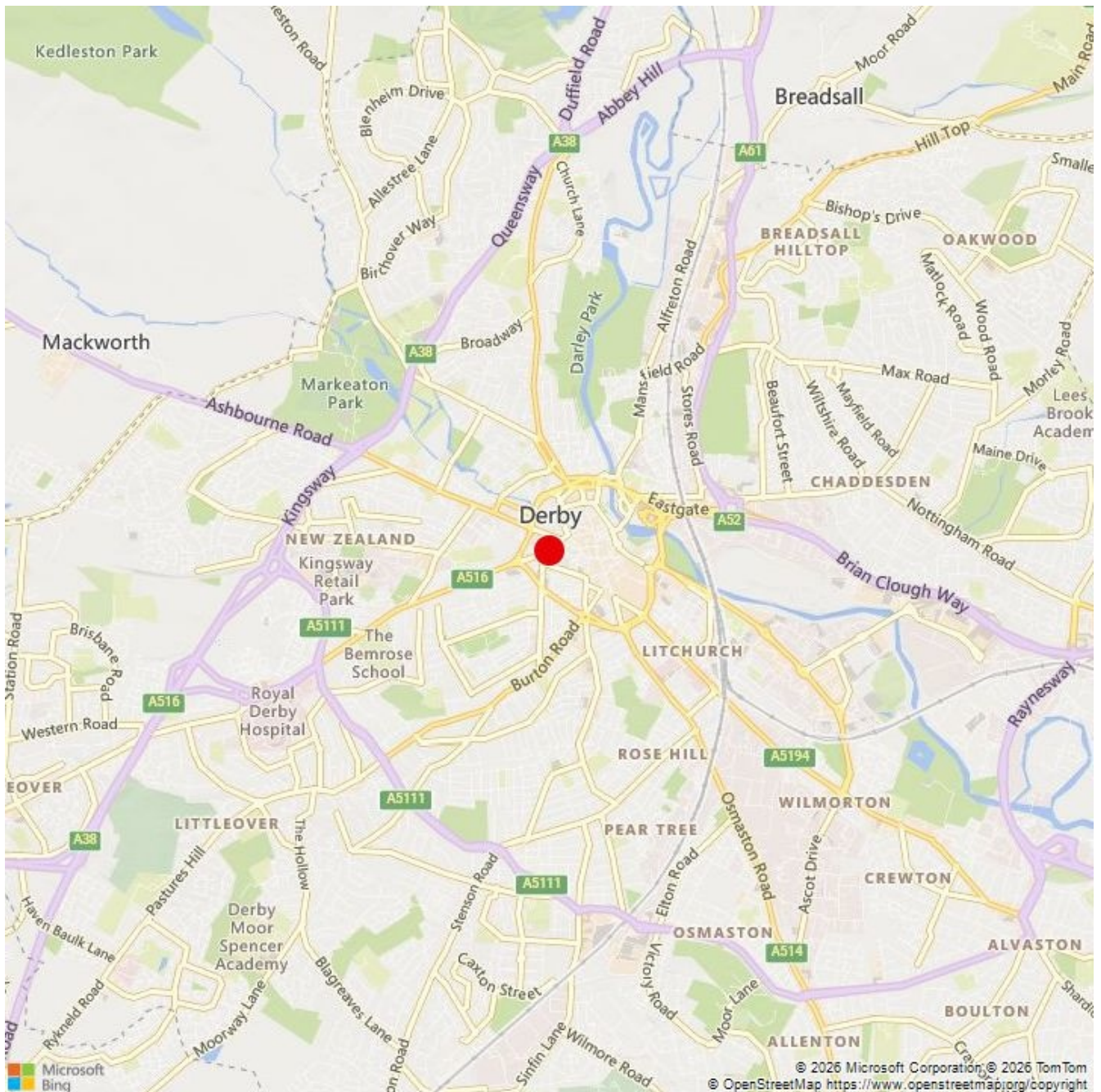
