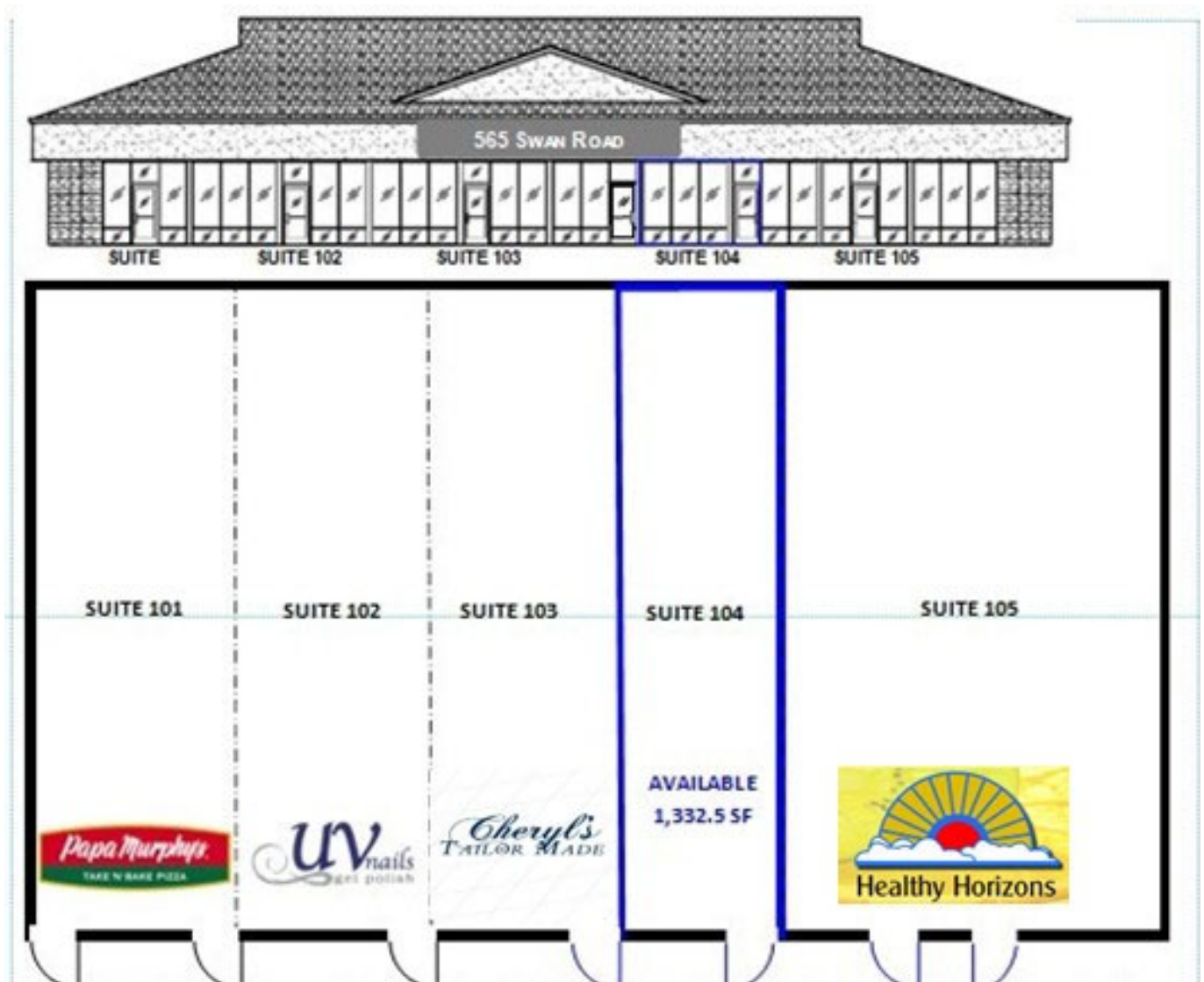

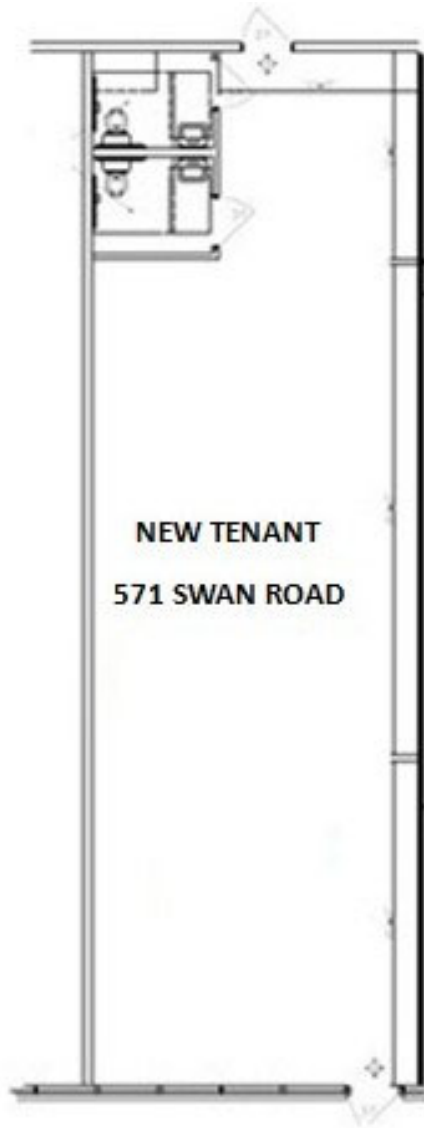
### FLOOR PLAN

### Non-Residential Customers

#### STATE OF WISCONSIN BROKER DISCLOSURE
