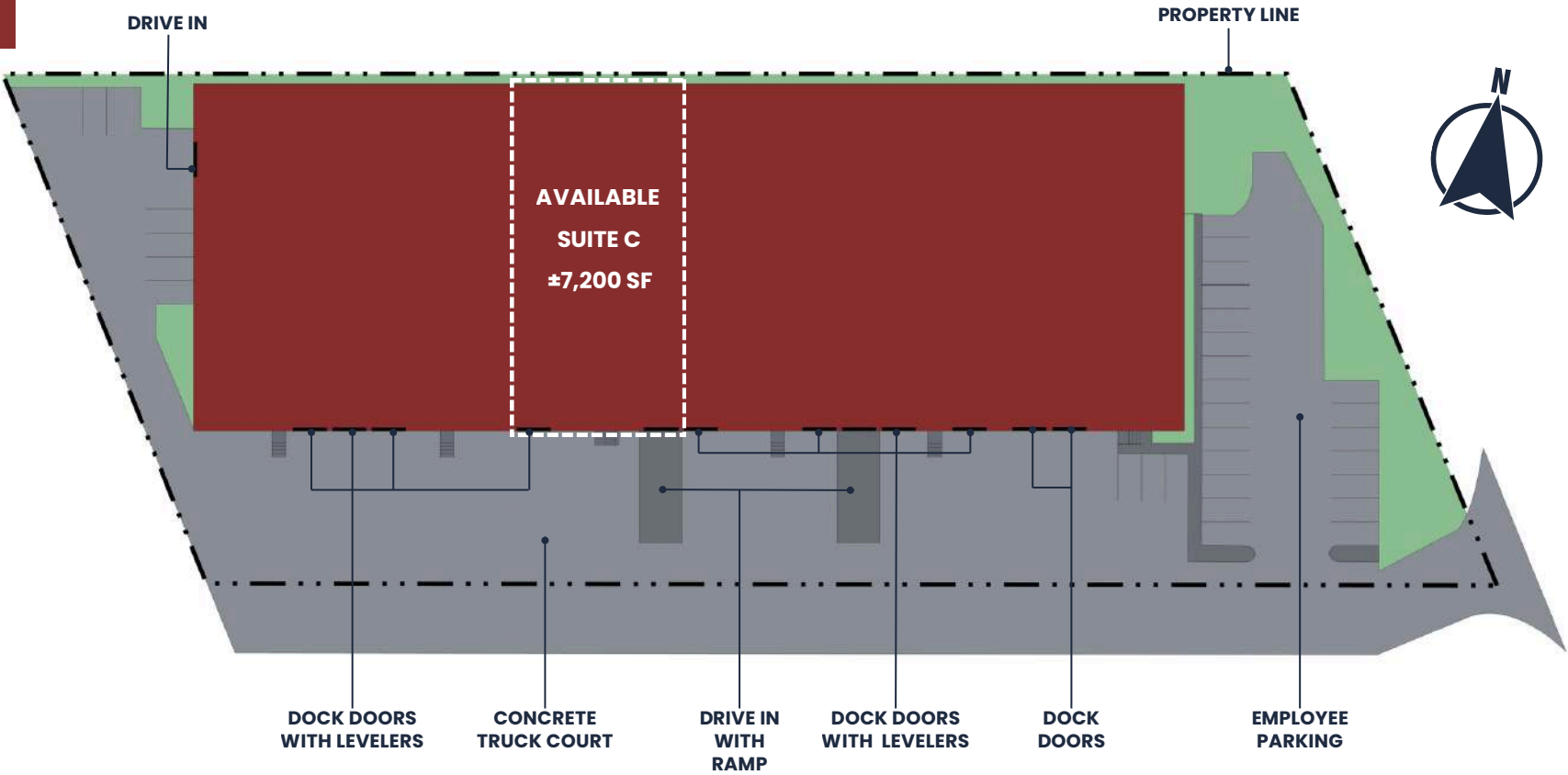

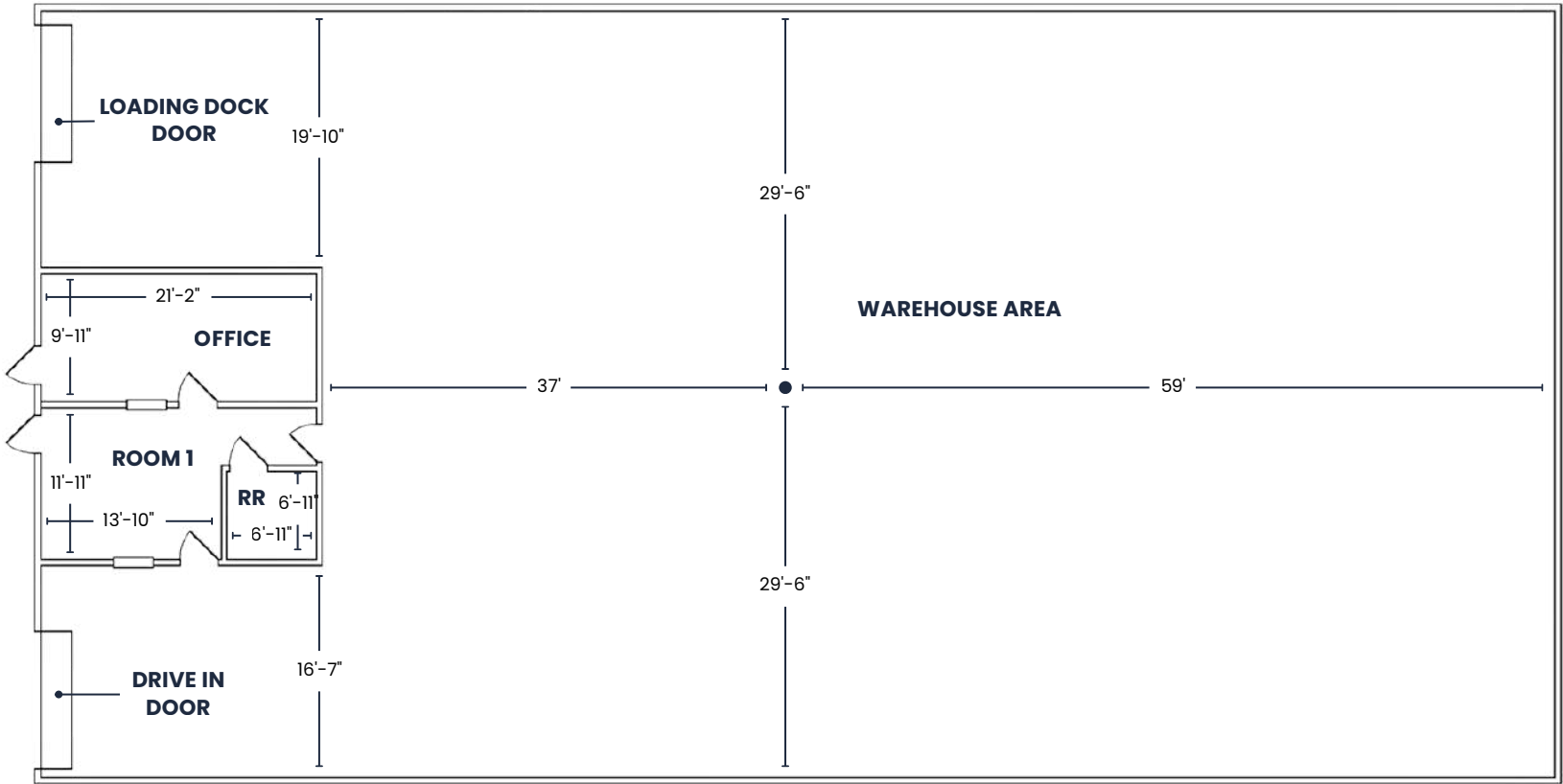

SITE PLAN



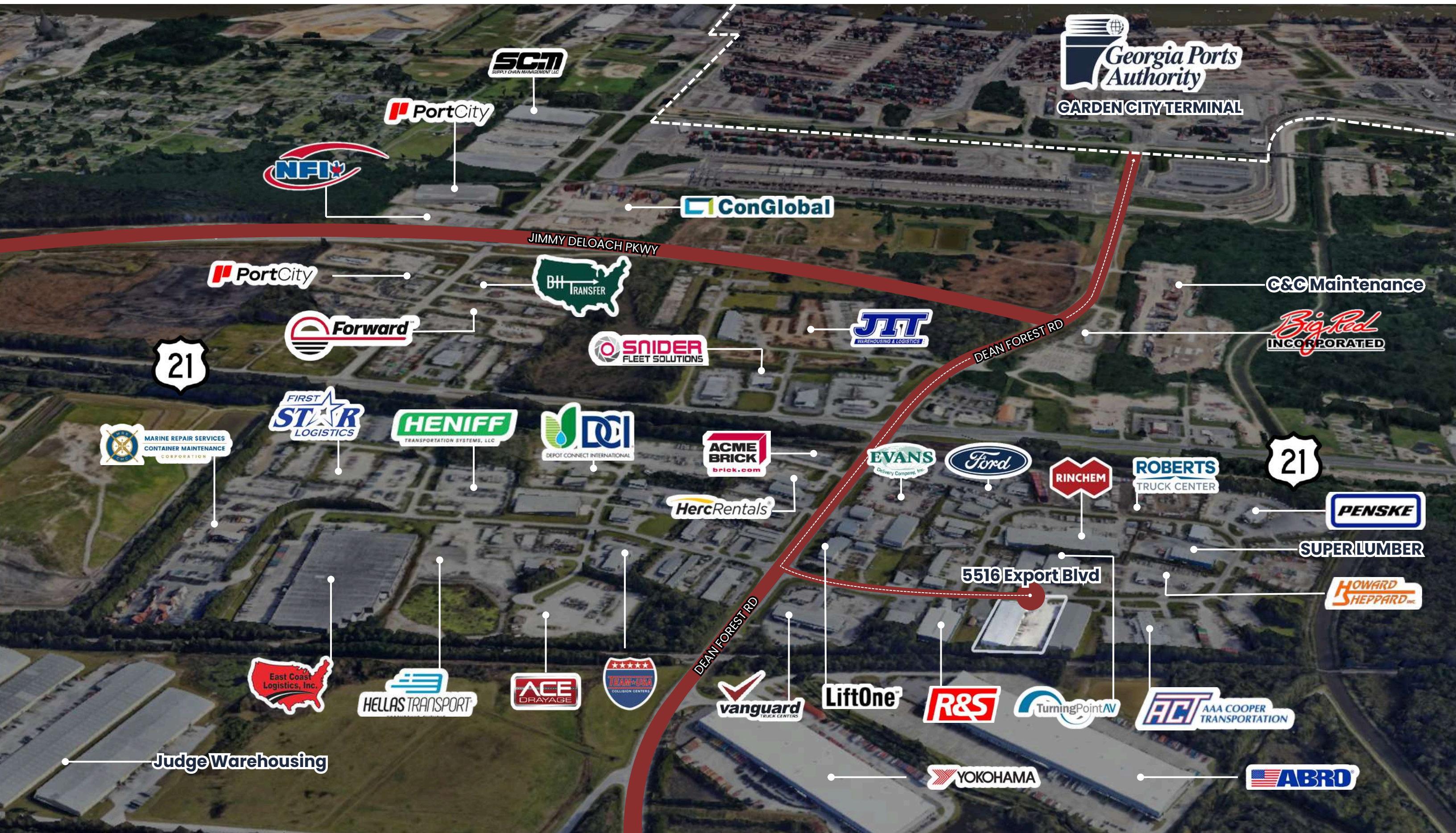
FLOOR PLAN

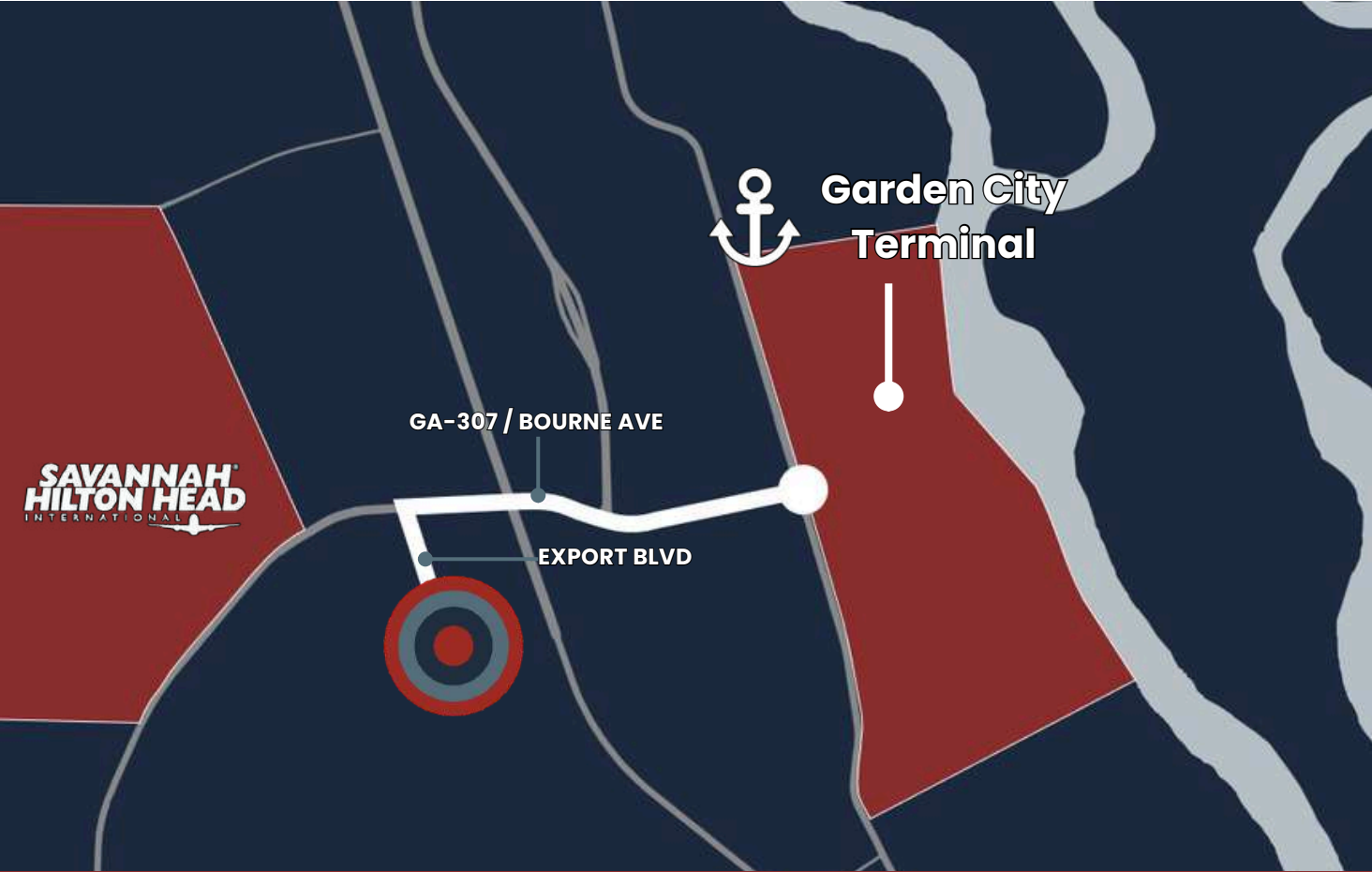






LOCATION OVERVIEW

via **GA-307 / Bourne Ave**

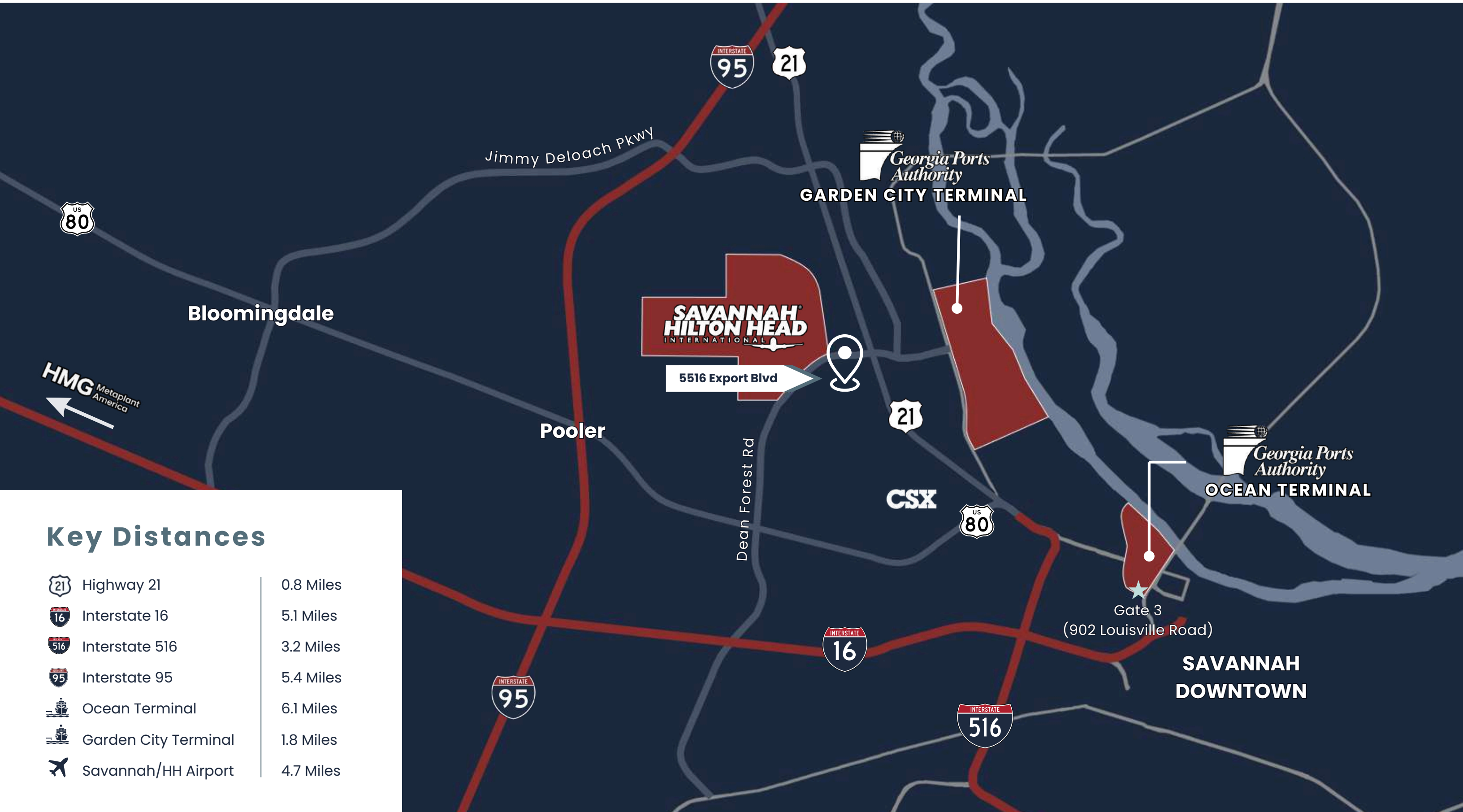
- ↑ **Head** toward **GA-307 / Bourne Ave**

via **GA-21 and I-516**

- ↑ **Head** toward **GA-307 / Bourne Ave**
- ↱ **Turn right** onto **GA-307 / Bourne Ave**
- ↱ **Turn right** onto **GA-21 / Augusta Rd**
- ↑ **Continue** onto **I-516**
- ↱ Take exit 5 to **merge** onto **I-16** toward Savannah
- ↱ **Turn slightly right** onto **US-17**
- ✓ **Take** the Louisville Rd exit and enter **Ocean Terminal**
